ORDER

1. Heard Shri A.V Bandiwadekar, learned advocate for the Applicant and Ms. Neelima Gohad, learned Presenting Officer for the Respondents.

2. On 14.8.2019 heard the learned advocate for the applicant for more than 2 hours for his prayer regarding interim relief.

Brief facts:-

- 3. The applicant was working as Assistant Police Inspector at Ganeshpuri Police Station, Thane. His grievance is that punishment of reversion has been imposed on him for a period of 2 years for the offence allegedly committed by him and found to be proved in the D.E concluded against him.
- 4. The punishment was imposed against the applicant for the following charges:-
 - (i) While working at Nalasopara Police Station on 23.4.2015, one lady complainant and her daughter approached the Police Station. After knowing the mobile number of the daughter, the applicant sent her objectionable messages.
 - (ii) Separately, on 1.4.2015 while working at Nalasopara Police Station, one lady complainant filed FIR under Sec 376 etc of IPC and applicant celebrated her birthday in the Police Station and filled cake in her mouth.
- 5. As the above misbehavior was proved in the D.E, Respondent no. 1, Special I.G.P, Konkan Range, imposed a punishment of reversion to the rank of Sub-Inspector for a period of 2 years and the applicant was allowed to appeal against the same if desired to the Respondent no. 3, Director General of Police. (Exh. 'A', pages 38 to 40).

- 6. Earlier, for the charge no. 1, S.P, Thane (Rural) in a summary trial on 8.10.2015 imposed a punishment of stopping increment for a period of 3 years. In Appeal against the same, Spl. I.G.P (Res.no. 1) had modified the punishment and imposed a fine of Rs. 500/- against the applicant.
- 7. Meanwhile, Respondent no. 2, (Home Department in State Government) on 3.12.2016, asked Respondents no 1 & 3 that the charges against the applicant and the punishment imposed of fine of Rs. 500/- is negligible and therefore the matter may be reexamined (Exh. 'B', page 41).
- 8. In pursuance thereof, on 12.7.2017, Respondent no. 3 directed Respondent no. 1 to hold D.E against the applicant and cancelled the earlier punishment of fine of Rs. 500/-. (Exh. 'C', page 42 & 43).
- 9. Earlier on 22.6.2015, the applicant was temporarily promoted to the rank of A.P.I by the Special I.G.P (Establishment), (Exh. 'D', page 47).

Prayer by the applicant.

10. Applicant has made following prayers:-

"9(a) By a suitable order/direction, this Hon'ble Tribunal may be pleased to set aside the impugned order dated 20.5.2019 passed by the Respondent no. 1 (Exhibit-A) under which he has imposed upon the Petitioner the punishment of reversion from the post of Assistant Police Inspector to that of Police Sub Inspector for a period of 2 years, so also the orders dated 3.12.2016 (Exhibit-B) and 12.7.2017 (Exhibit-C) issued by the Respondents no 2 and 3, thereby ordering the suo-motu reversion of the order dated 18.10.2016 about minor penalty of imposition of fine of Rs. 500/passed by the Respondent no. 1 and accordingly the Petitioner be granted all the consequential service benefits, as if the impugned orders had not been passed.



- 10. Interim relief:-
- (a) Pending the hearing and final disposal of this O.A, this Hon'ble Tribunal may be pleased to stay the implementation of the impugned order dated 20.5.2019 passed by the Respondent no. 1, Exhibit-A and accordingly the petitioner be allowed to continue to work as Incahrge, Ganeshpuri Police Station as was before the impugned order of reversion was passed by the Respondent no. 1."
