  - (a) The Original Applications are partly allowed.
  - (b) All the Applicants who are District Technical Service Medical Officers, placed in Group-B by virtue of GR dated 17.10.2014 with retrospective effect from 28.5.2001 are eligible and entitled to recruitment to Group-A from the date of the GR dated 18.7.2013 when the Rules were amended. Thus, they are recruited in Group-A from 18.7.2013 with all consequential benefits.
  - (c) The applicants are entitled to pay scale in the pay band of Rs. 15600-39100 with Grade pay of Rs. 5400, with effect from 18.7.2013.

#### Tribunal's orders

- 3. Ld. PO informs that a positive proposal on 2.8.2023 was submitted by the Public Health Department to the Chief Secretary pursuant to our order of this Tribunal. However, the Chief Secretary submitted a negative proposal to the Hon'ble Chief Minister and forwarded it to the Hon'ble Chief Minister on 9.11.2023 and the same was approved by the Hon'ble Chief Minister.
- 4. This is unprecedented and prima facie contemptuous! If judicial order is not acceptable to the Government then the Government can approach higher authority i.e. the Hon'ble High Court in case of this Tribunal. The order passed by this Tribunal cannot be set aside by rejecting the implementation of the same by the Executive or the Government. Thus, the option open for the Government is either to implement the order or to challenge it before the Hon'ble High Court. We are of the view that Chief Secretary has no power in law in his Executive capacity to submit the proposal of not implementing the judicial order of the Tribunal. It is as good as sitting in appeal over the orders of the Tribunal by usurping the judicial power.
- 5. We call upon the Chief Secretary to show the relevant provisions otherwise we will be constrained to issue notice under Contempt of Courts Act in this matter.
- 6. We direct Shri N.Y. Chavan, Ld. Advocate for the applicant to remain present.
- 7. S.O. to 29.11.2023. Hamdast allowed.
