2. A detailed order was passed by this Tribunal on 7.8.2018 making following observations: -

“3. In the order dtd. 20.6.2018 vide para 3 this Tribunal has observed as follows :-

“3. Considering the fact that the issue is pending before the concerned respondents since long, despite persuasion by this Tribunal, it is hoped that upon receipt of the copies of the ACRs, the concerned respondents would take prompt steps.”

4. The case is pending from quite some time and earlier submissions of the respondents were that the A.C.Rs. were not available. However, learned Advocate for the applicant during the last hearing had made available the ACRs. It is not understood as to why the matter has been now referred to the G.A.D. when the practice is that in case

some ACRs are not available, then ACRs of previous years are concerned. It is a quite strange case and learned P.O. seeks time to apprise this Tribunal as to why the matter is referred to G.A.D.”

3. Today, learned Presenting Officer has filed a copy of communication dated 18.8.2018 addressed to Divisional Commissioner, Aurangabad Division, Aurangabad by Under Secretary, State of Maharashtra. The copy of the said communication is taken on record and marked as document 'X' for the purpose of identification.

4. From the aforesaid communication, it is clear that the respondent authorities are unnecessarily prolonging the matter even though they can take decision in this matter. We, therefore, direct the respondent No. 1 to take appropriate decision as regards promotion of the applicant as per Rules on merit within a period of two weeks from the date of this order, failing which heavy costs will be saddled on the respondent No. 1.
