2. The present applicant is aspiring for admission to P.G. course as a in-service candidate. In NEET PG examination the applicant has scored 244 marks. As has been claimed by the applicant since she had rendered services as Medical Officer in rural areas she has been given weightage of 58.56 marks and as such her total score reaches to 302.56 marks. It is the further contention of the applicant that the list, which has been published by the Director of Health Services, Mumbai and which was forwarded to the Commissioner of State CET Cell, Mumbai, her name was included at Sr. No. 87 and in the remark column it has been clearly stated that 'eligible for in-service quota'. It is the further contention of the applicant that in spite of the fact as aforesaid that the Director of Health Services has communicated her name to the State CET Cell with remark that 'she is eligible for getting admission from in-service quota' the State CET Cell has not allowed her to register her name for participating in the further process.

3. The learned counsel has invited my attention to the communication received from the State CET Cell through email requiring the applicant to explain 'are you eligible in NEET PG without additional weightage? if not then your name will be included only after being eligible'. The learned counsel submits that there is no such provision or there is no such restriction for giving weightage to the candidates, who had served in the rural / remote or difficult areas and their total marks are to be considered by including the said weightage marks received by the concerned candidate in the marks earned in NEET PG examination. The learned counsel further submits that, that was the reason that the Director of Health Services recommended the name of the applicant as eligible for in-service quota. The learned counsel submitted that the first round has already been completed and since the applicant was not allowed to register her name, she could not participate in the said round. It is the further contention of the applicant that the respondent authorities may be directed to allow the applicant to get register the name of the applicant so that she can participate at least in the second round of admission. The learned counsel relied on the judgment of the Hon'ble Bombay High court in the case of **Dr. Mangesh Babasaheb Sanap & Another Vs. the State of Maharashtra & Ors. (Writ Petition No. 13949/2019)** wherein the issue of weightage marks was involved.

4. The learned Chief Presenting Officer has invited my attention to clause 8.16 in the brochure of NEET-PG 2022 examination and more particularly clause 8.16.3, which reads thus :-

“(8) Eligibility Criteria for NEET-PG 2022 Medical Postgraduate Courses :

(8.16) *Eligibility for In-service Candidates:*

(8.16.3) *In service quota candidate must have appeared for NEET-PG 2022, and declared eligible by Competent Authority, Government of India, New Delhi.”*

5. The learned C.P.O. thereafter invited my attention to the regulations framed by the Medical Council of India titled as ‘Postgraduate Medical Education Regulations, 2000’ and referred to clause 9.3 thereof, which reads thus :-

“9. Procedure for selection of candidate for Postgraduate courses shall be as follows: -

(3) In order to be eligible for admission to Postgraduate Course for an academic year, if shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the ‘National Eligibility-Cum-Entrance Test for Postgraduate courses’ held for the said academic year. However, in respect of candidates belonging to Scheduled Castes, Scheduled Tribes, and Other Backward Classes, the minimum marks shall be at 40th percentile. In respect of candidates with benchmark disabilities specified under the rights of Persons with Disabilities Act, 2016, the minimum marks shall be at 45th percentile for General Category and 40th percentile for SC/ST/OBC. The percentile shall be determined on the basis of highest marks secured in the All India Common merit list in National Eligibility-cum-Entrance Test for Postgraduate courses.”

6. Referring to the aforesaid 2 provisions the learned CPO submitted that since the applicant did not receive the minimum marks in the NEET-PG examination, she was not entitled for claiming any weightage for her service rendered in the Rural area. The learned CPO brought to my notice the communication dated 1.6.2022 in the form of notice issued by the National Board of Examinations in Medical Sciences, New Delhi wherein minimum qualifying /

eligibility criteria is prescribed. For SC/ST and OBC candidates 40th percentile is prescribed which comes to 245 marks out of 800 for NEET-PG 2022 examination. The learned CPO submitted that the applicant has received 244 marks i.e. less than minimum qualifying marks and as such she was not entitled to claim any weightage on the basis of G.R. dated 19.3.2019. The learned CPO in the circumstances opposed for granting any interim relief as has been prayed by the applicant.

7. I have carefully considered the submissions advanced by the learned counsel appearing for the applicant and the learned CPO appearing for the State authorities. As has been prescribed in clause 9.3 of 'Postgraduate Medical Education Regulations, 2000', in order to be eligible for admission to PG Course it shall be necessary for the candidates to obtain minimum marks of 50th percentile in the NEET PG examination held for the said year. In respect of the candidates SC/ST or OBC the minimum marks are at 40th percentile. Similar provision is there in clause 8.6 in the broacher of NEET-PG examination. It also provides that to be eligible for selection for Medical PG course the candidate belonging to constitutional reservation category must secure minimum of 40th percentile in NEET PG-2022 examination. Clause 8.2.6 further provides that, the candidate who fails to obtain the minimum percentile marks as prescribed in Regulation shall not be admitted for the PG course in the academic year 2022-23.

8. According to the learned counsel the NEET-PG marks are to be considered along with weightage and not exclusively the marks secured in the NEET-PG examination, and there is no such provision at least he has

not come across any such provision showing that the weightage will not be given if the candidate has not secured the minimum percentile of marks. It was therefore, his contention that the applicant is otherwise also short of only one mark than the cut-off marks and as such, the respondents be directed to consider his case provisionally.

9. I am however, not convinced with the submissions so advanced by the learned counsel for the applicant. There is no ambiguity in the clauses referred above. In the NEET PG Examination the candidates must secure minimum number of marks. Admittedly, the applicant has not secured minimum percentile of marks and hence, prima face it does not appear to me that the applicant is entitled for any interim relief. However, the issue raised by the applicant needs adjudication. Hence, I issue notices to the respondents requiring them to file affidavit in reply to the O.A. Hence, the following order: -

ORDER

1. Issue notice to respondents, returnable on 2.12.2022.
2. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
3. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
4. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
5. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and

produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

2. Both these applicants are seeking intervention in O.A. No. 826/2022 and the prayer also has been made for vacation of the interim order passed by the Tribunal on 7.9.2022.

3. Shri Deshmukh, learned counsel appearing for the applicants in both these MAs submitted that insofar as the applicant in M.A. No. 456/2022 is concerned, the applicants in O.A. may not dispute that he is senior to them and is no way concerned with the controversy raised by the applicant as about inter-se seniority of the candidates appointed from Earthquake Affected Persons' category. He submitted that since this Tribunal has passed

order thereby restraining the respondents from effecting orders of promotions, though the applicant is due for promotion and is in all respect entitled for the said promotion, has been deprived from the said promotion. Insofar as the applicant in M.A. No. 455/2022 is concerned, the learned counsel submitted that this applicant belongs to the category of Persons With Disability (PWD). The learned counsel submitted that in the O.A. there is no concrete objection insofar as the said applicant is concerned for promotion from the said category. The learned counsel, in the circumstances, has prayed for allowing both the intervention applications and to vacate the interim order insofar as these 2 applicants are concerned.

4. Ms. Pradnya Talekar, learned counsel appearing for the applicants in O.A. fairly submitted that insofar as the applicant in M.A. No. 456/2022 is concerned, the applicants don't dispute the contentions raised in the said M.A. and concede that the said candidate is senior to the applicants in O.A. and he is the appointee from the Selection Board. Insofar as the applicant in M.A. No. 455/2022 is concerned, the learned counsel pointed out that the claim of the said applicant that he is the senior most person in the PWD category does not appear to be correct in view of the seniority list. However, she further submitted that even the promotion to the said candidate will not have adverse effect on the case of the applicants in O.A.

5. The learned CPO has submitted for passing appropriate orders in both the matters. It was however his general submission that the interim order passed in the

present O.A. deserves to be modified thereby restricting it to the interest of the applicants in the said O.A. so that the way can be paved for the promotion for the remaining posts.

6. After having considered the submissions advanced by the learned counsel appearing for the intervenors, learned counsel for the applicants in O.A. and learned C.P.O. appearing for the respondent authorities, there appears a prima-facie case in favour of both the applicants. Insofar as the applicant in M.A. No. 456/2022 is concerned in view of the submissions made, there may not be any impediment for vacating the interim order insofar as the promotion of the said applicant is concerned, if he is otherwise entitled for the said promotion.

7. Insofar as the applicant in M.A. No. 455/2022 is concerned, the objection has been raised by the learned counsel for the applicants in O.A. that there may be more senior candidates in the category of PWD and as such unless their seniority is verified it may not be proper to accept the request of the said candidate as has been made in the M.A. The list of the candidates, who are proposed to be promoted is there on record at page 529 of paper book. This list has been published on 29.8.2022. The name of the applicant in M.A. is there in the said list at Sr. No. 20. In view of the fact that no one from the said category has raised any objection for inclusion of the name of the said candidate in the list of promotees. The candidates who are stated to be senior than the applicant by Ms. Pradnya Talekar, learned counsel also have not objected for inclusion of name of this candidate in the list of promotions. At least there is nothing on record in that

record. In the circumstances, at this stage it has to be assumed that the applicant is entitled and eligible to be promoted from the category of PWD's. For the reasons stated above following order is passed : -

ORDER

- (i) Both the MAs are allowed, however without any order as to cots..
- (ii) The interim order dated 7.9.2022 shall not be an impediment for promoting the applicants in both these MAs, if otherwise they are found eligible for the said promotion.

2. Respondent Nos. 5 & 6 in the present O.A. have come out with the prayer for vacating interim relief or modifying it suitably so that the persons who are in all respect entitled for promotion may get the timely promotion.

3. Shri Ajay Deshpande, learned counsel for respondent No. 5 submitted that in the seniority list published in the year 2006 and in the provisional seniority list published on 13.4.2022 the present respondent has been shown senior to the applicants in O.A. Learned counsel further submitted that present applicants did never object to the final seniority list published in the year 2006. He further submitted that though the applicants have raised objection as about the provisional seniority list published on 13.7.2022 in the present application, have not raised any objection to the said seniority list to the concerned

authority till date. The learned counsel submitted that having regard to the fact as aforesaid the applicants do not have any right or equity in their favour to say that the provisional seniority list published on 13.7.2022 is faulty and that the applicants are illegally and incorrectly shown junior to the respondent Nos. 5 & 6. The learned counsel in the circumstances prayed for vacating the interim relief. The learned counsel alternatively submitted that it will be fair to modify the interim relief thereby restricting it only to the interest of the applicants in the OA.

4. Shri D.R. Shelke, learned counsel appearing for respondent No. 6, adopting the arguments advanced by Shri Ajay Deshpande, learned counsel for respondent No. 5, further submitted that the applicants have not placed on record any *prima facie* material so as to convince this Tribunal as about the seniority of the applicants vis-à-vis respondent Nos. 5 & 6. He further submitted that on the contrary there is strong evidence in favour of these respondents in the form of final seniority list of the year 2006, wherein they are shown senior to the applicants. He further submitted that moreover promotions are not only based on the seniority list but several other aspects are required to be considered while granting promotion. The learned counsel submitted that entire process of promotion cannot be stalled and he also prayed for vacating the interim relief or modifying it suitably.

5. While replying the objections as are raised on behalf of the respondents the learned counsel for the

applicants pointed out that the respondents have not determined the inter se seniority of the candidates appointed from the category of Earthquake Affected Persons in accordance with the G.R. dated 14.7.2018 and the objections in that regard are already raised. The learned counsel submitted that according to G.R. issued by GAD the promotions cannot be effected unless the seniority list of the feeder cadre of the immediate preceding year is finalized. Learned counsel in the circumstances, opposed for grant of request so made by respondent Nos. 5 & 6.

6. I have considered the submissions advance by learned counsel appearing on behalf of respondent Nos. 5 & 6, learned C.P.O. appearing for respondent authorities and learned counsel for applicants. After having considered the submissions advanced on behalf of respective parties and after having gone through the documents filed on record it appears to me that the dispute raised in the present OA cannot be finally resolved unless the provisional seniority list published on 13.7.2022 is made final. As has come on record and as has been contended in the affidavit in reply filed on behalf of respondents the objections and representations are already received in relation to the provisional seniority list so published. Learned C.P.O. was asked to state how much time would be required for deciding the objections and thereafter in finalizing the provisional seniority list published on 13.7.2022. The learned C.P.O. on instructions, made a statement

that period of about 2 months will be required for finalizing the said seniority list. It appears to me that when the provisional seniority list published on 13.7.2022 is going to be finalized within the period of 2 months which may resolve the controversy raised in the O.A. finally, it would be in the fitness of the things to wait till the said period. If the promotions are delayed for 2 months that may not cause any serious prejudice. In the circumstances, I direct respondent No. 1 to decide the objections already received and finalize the provisional seniority list published on 13.7.2022 within 2 months from the date of this order.

2. The applicant has claimed the following reliefs: -

(A) This Miscellaneous Application may kindly be allowed.

(B) The delay, if construed to have occurred in filing the Original Application, of about four years, may kindly be graciously be condoned, having regard to the nature of grievance sought to be agitated, to subserve the ends of justice.

(C) Any other suitable and equitable relief to which the applicant is entitled to, may kindly be granted in her favour.

3. Since some delay has occasioned in preferring the Original Application the applicant has preferred the present M.A. seeking condonation of delay. Learned counsel submits that the cause of action for filing O.A. had arisen in the year 2016. Up to till 2017

the applicant was making representation ventilating her grievance with the departmental authorities, however, she did not get any favourable response. Learned counsel submitted that thereafter in fact the applicant was supposed to prefer the O.A. before this Tribunal within the limitation as provided under the provisions of the Administrative Tribunals Act. Learned counsel submitted that the applicant was bona-fide believing that when the other similarly situated persons have been granted the relief she will also be granted the same. Learned counsel submitted that in fact there is continuous cause of action for ventilating grievance of the applicant. Learned counsel in the circumstances prayed for condoning the delay so that the grievance raised by the applicant in the O.A. can be prosecuted on merits.

4. Learned Chief Presenting Officer has submitted for passing appropriate orders.

5. On perusal of the application for delay condonation, in fact, the applicant has not provided any specific reason for not approaching this Tribunal within stipulated time. However, the contention as has been raised by the learned counsel that the applicant was bona-fide believing that when the other similarly situated persons have been granted the relief she will also be granted the same relief cannot be outrightly rejected. As such, it appears to me that the applicant needs to be given opportunity to prosecute her

grievance on merits. I am therefore, inclined to allow the present application.

6. Accordingly, the present application is allowed and disposed of with no order as to costs. The delay occurred in filing accompanying O.A. is condoned. The Original Application be registered in accordance with law.

7. The respondents are already served with the notice of the O.A. The O.A. be therefore, listed for filing their affidavit in reply on 17.11.2022.
