2. Learned Advocate for the applicant has submitted that the applicants have challenged the amendment made in the Maharashtra State Municipal Chief Officers Service (Recruitment and Conditions of Service) Rules, 1983 by which Rule 4 has been substituted. He has submitted that by substituting Rule 4(2)(b) the eligibility of promotion on the post of Municipal Chief Officer has been made and it has been provided that the promotion be made from the suitable person, who has completed regular service of not less than 5 years in the cadre and his age is not more than 53 years on the basis of the selection list prepared as per the merit determined by the Limited Departmental

Competitive Examination. He has submitted that the applicants have not given exemption in passing the departmental competitive examination in view of G.R. dated 01-03-2018. Therefore, they are not eligible for the promotion in the cadre of Municipal Chief Officer. He has submitted that the respondents have started the process of promotion. If the process is continued, valuable rights of the applicants will be affected, and therefore, he has prayed to stay the process of promotion till decision of the O.A. by allowing the present M.A.

3. Learned P.O. has submitted that in view of the amended Rule 4(2)(b), the promotion be made from the suitable person, who has completed regular service of not less than 5 years in the cadre and his age is not more than 53 years on the basis of the selection list prepared as per the merit determined by the Limited Departmental Competitive Examination. She has submitted that the applicants are 51 years and 53 years of age, respectively. They have experience of more than 5 years and they are eligible for promotion on the post as per their seniority. The applicants have



not passed the limited departmental competitive examination and no examination for passing the limited departmental examination has been sought by them, therefore, they are not eligible for promotion. She has submitted that the process of promotion of eligible and suitable persons is initiated as per Rules and therefore, same cannot be stayed. Therefore, she has prayed to reject the M.A. for interim relief.

4. On perusal of the amended Rule 4(2)(b), it reveals that the following provisions are made:

*“(b) by promotion of a suitable person, who has completed regular service not less than 5 years in the cadre and his age is not more than 53 years, on the basis of the selection list prepared as per the merit determined by the Limited Departmental Competitive Examination;”*

5. For appointment on the post of Chief Officer by way of promotion, suitable person has to possess experience of not less than 5 years for the appointment on the cadre and his age should not be more than 53 years and his promotion shall be on the basis of limited departmental competitive examination. Applicants have not passed the limited departmental

competitive examination. They have neither sought exemption from passing the limited departmental examination as per the G.R. dated 01-03-2018 nor they got exemption in that regard in the absence of exemption in passing the limited departmental examination they cannot be considered for promotion. Therefore, they are not eligible for promotion on the post of Chief Officer.

6. Respondents have started process of promotion on the post of Chief Officer in view of the said amended provision in the Rules. Prima facie, there is no illegality or irregularity in the process started by the respondents. There is not just ground to stay the process of promotion. Therefore, in my view, the relief as claimed by the applicant cannot be granted during the pendency of the O.A. Therefore, interim relief as claimed by the applicant cannot be granted. Hence, the prayer for interim relief is rejected. M.A. stands disposed of accordingly with no order as to costs.
