The applicant claims to be belonging to NT-D category. In the written examination the applicant has received 146.660 marks and in the general merit list he is shown at sr. no. 57. Against NT-D (General) seats, 02 NT-D candidates who were also falling in the category of Specially Disabled

Persons were recommended for their selection. However, one of them is held not eligible after his documents were verified. His candidature has been rejected on the ground of not having requisite educational qualification.

3. It is the contention of the applicant that in the category of NT-D candidates, he has secured highest marks and, as such, he is having his valid and legitimate claim on the post, which may remain unfilled because of rejection of candidature of one Divyang candidate coming from NT-D category. Learned counsel for the applicant submitted that after the candidature of 2nd Divyang candidate was rejected, the applicant has immediately preferred an application on 6.10.2023 requesting the authorities to consider his candidature for the said post claiming that he is the candidate coming from NT-D category and has secured highest marks. Learned counsel further submitted that though the applicant belongs to NT-D category and also possesses the Tribe valid certificate, since he was not possessing at the relevant time non-creamy layer certificate of the particular year, against the said column he has recorded answer as 'NO'. Learned counsel submitted that now the applicant is possessing the noncreamy layer certificate of the

current year which, according to the corrigendum issued by the Government on 17.2.2023, may be a valid non-creamy layer certificate. Learned counsel submitted that the applicant apprehends that the authorities may call for the documents verification the other candidates from the NT-D category having less marks than the applicant. In the circumstances, the prayer has been made for directing the respondents to keep 01 post of Planning Assistant (Group-B) (Non-gazetted) vacant reserved for NT-D category candidate.

- 4. Learned Chief Presenting Officer has sought time to file affidavit in reply after taking instructions. Learned C.P.O., however, submitted that the present is not the case wherein interim relief as has been prayed for can be granted. Learned C.P.O. submitted that from the document, which has come on record, on the date of filling in the application the applicant was not holding the non-creamy layer certificate and, as such, apparently he is barred to claim the seat for NT-D category. Learned C.P.O. in the circumstances prayed for rejecting the request for interim relief.
- 5. We have considered the submissions made on behalf of the applicant, as well as, the respondents. As has come on record, the applicant claims to be having highest marks amongst the NT-D candidates. From

the selection list, it is quite evident that against 02 NT-D (General) seats, 02 Divyang candidates from the said category, were shown to have been selected. As has been argued and as the documents on record also demonstrate, candidature of 01 Divyang candidate is rejected on the ground of not holding the requisite educational qualification. Thus, 01 post reserved for NT-D category is vacant as has been claimed by the applicant. It is the apprehension of the applicant that on the ground of not holding the non-creamy layer certificate, the respondents may recommend any other candidate from NT-D category having less marks than the applicant and in the circumstances, interim relief has been sought.

6. After having gone through the documents filed on record, it appears to us that the prima-facie case is made out by the applicant for issuing directions against the respondents, at least till filing the affidavit in reply by them, to keep 01 post vacant reserved for NT-D (General) candidate. Hence, the following order:-

2. In is not in disputed that during pendency of the Original Application, Dr. Dilip Dnyanoba Gurme was sent on deputation for Post-Graduation Studies at Vilasrao Deshmukh Government Medical College, Latur. In view of the same, he may not have concern with this litigation.

3. M.A. St. No. 2223/2023 is allowed in terms of prayer clauses B and C. M.A. is accordingly disposed of without any order as to costs.

- 2 Leave to add the District Health Officer, Aurangabad as party respondent to the M.A. and O.A.
- 3. The applicant has filed Original Application No. 496/2023, thereby challenging the legality, validity and correctness of transfer order dated 10.06.2023 (Annexure A-8 in O.A.), whereby the services of the applicant were transferred from Panchayat Samiti, Vaijapur to District Hospital, Beed.
- 4. By the order dated 26.06.2023, this Tribunal was pleased to grant interim relief thereby directing the respondents not to relieve the applicant and to allow him to work at his existing post till the next date or till the date his representation is decided, whichever is earlier. There is no dispute that this

interim order was effectively communicated to the respondents.

- 5. Meantime, by order dated 26/27.06.2023 (Annexure A-2) respondent No. 5 i.e. Dr. Dilip Dnyanoba Gurme, was transferred on administrative ground at Vaijapur by respondent No. 1 as communicated by respondent No. 3. The said respondent No. 5 i.e. Dr. Dilip Dnyanoba Gurme had joined his transferred place on 27.06.2023.
- 6. It further appears that on 03.07.2023 (Annexure A-3), the applicant has submitted an application before the Dy. Director of Health Services, Aurangabad Circle requesting therein to retain him at Vaijapur in terms of interim relief granted by the Tribunal or that he may be accommodated as Taluka Health Officer at Soygaon. His request was duly forwarded by the District Health Officer and thereafter from Dy. Director of Health Services, Aurangabad to Director of Health Services, Mumbai.
- 7. Meantime, the applicant has issued legal notice to respondents for show cause as to why

contempt proceeding shall not be initiated against them.

- 8. In view of the said legal notice, by order dated 23.08.2023 (Annexure A-7) the applicant was given charge at Soygaon. In view of the said order, the applicant had taken charge of Taluka Health Officer, Soygaon on 23.08.2023.
- 9. It is, however, pertinent to note that by order dated 29.08.2023 (Annexure A-8) one Dr. Gitesh Dhiraj Chawda was transferred from Gangapur to Soygaon as Taluka Health Officer.
- 10. In terms of the earlier order, which is under challenged in the O.A., the applicant was transferred to District Hospital, Beed, however, by order dated 29.08.2023 (Annexure A-11) one Dr. Laxmikant Ramrao Tandale was appointed at District Hospital, Beed. Thereafter respondent No. 5 i.e. Dr. D.D. Gurme, who was posted as Taluka Health Officer at Vaijapur sent on deputation for Post-Graduate Studies at Vilasrao Deshmukh Government Medical College, Aurangabad. In consequence thereof, the applicant herein was given the independent charge

as Taluka Health Officer, Vaijapur. Learned counsel appearing for the applicant at this stage has rightly pointed out that this is in compliance of the interim order passed by this Tribunal on 26.06.2023, though belatedly.

- 11. It is not disputed that the applicant is presently holding the charge of Taluka Health Officer, Vaijapur. Learned Presenting Officer on instructions has also admitted the same.
- 12. Further by order dated 08.11.2023 (Annexure A-10), one Dr. Kishor Vilas Jadhav was transferred from Dapoli, Dist. Ratnagiri to Vaijapur as Taluka Health Officer, however, undisputedly he had not taken the charge of his transferred posting at Vaijapur. If cumulative effects of all these orders as referred above are considered, then if the applicant is not protected by interim order as prayed in the present M.A., he will be nowhere. All 03 places i.e. Beed, Soygaon and Vaijapur will not be available for him, if he is not protected (which he has already been protected by interim order).
- 13. In view of above, interim relief in terms of prayer clauses B and C in M.A. is granted till further orders, which read as follows:-

- "B) The operation, implementation and effect of transfer order dated 08.11.2023 issued by the respondent No. 2 in favour of Dr. Kishor Vilas Jadhav whereby his services are transferred from Taluka Health Officer, Dapoli, Dist. Ratnagiri to Taluka Health Officer, Vaijapur, Dist. Chatrapati Sambhaji Nagar, may kindly stayed.
- C) Pending hearing and final disposal of Original Application No. 496/2023, applicant may kindly be permitted to discharge his duties as Taluka Health Officer, Vaijapur in pursuant to interim order dated 26.06.2023 with further directions to the respondent authorities not to relieve him from the post of Taluka Health Officer, Vaijapur until final decision of Original Application."
- 14. Learned Presenting Officer is hereby requested to communicate this order forthwith to the respondents through E-mail, Fax or in person and submit report to that effect to this Tribunal.
- 15. Learned P.O. waives notice for respondent Nos. 1 to 3-A.
- 16. In the circumstances, issue notice to the respondent Nos. 4, 6 & 7, returnable on 04.01.2024.
- 17. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

- 18. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- 19. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- 20. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
