2. It is the grievance of the applicant that within three months of his posting at Latur vide the impugned order he has been transferred to Nanded allegedly on administrative grounds. The aforesaid order is challenged by the applicant in the present Original Application. The applicant is presently working on the post of Police Inspector. Vide order dated 3.2.2023 he was transferred from Police Station Udgir City to MIDC Police Station, Latur. The applicant accordingly resumed duties at transferred place. While he was discharging duties on the said post, he has been again transferred to Nanded vide the impugned order of transfer dated 27.06.2023.

3. Learned counsel for the applicant submitted that the applicant has been transferred contrary to the transfer guidelines and the rules in regard to the transfer of the Police Personnel as provided under Section 22N of

the Maharashtra Police Act. Learned counsel submitted that ordinarily the applicant was entitled to be at the transferred place for 2 years. Learned counsel further submitted that the applicant would be retiring in the month of March, 2024 on attaining the age of superannuation. Learned counsel submitted that on 06.03.2024, the applicant would attain the age of superannuation and thus, he will be retiring by the end of the said month i.e. on 31.03.2024. Learned counsel submitted that in such circumstances, his transfer made when the applicant is on the verge of retirement from one district to another district is caused prejudice and harassment to the applicant. The applicant in O.A. has therefore, prayed for quashment of the impugned order.

4. The respondents have filed their affidavit in reply, thereby opposing the contentions raised and the prayers made in the Original Application. The only ground which seems to have been pressed in the affidavit in reply by the respondents is that the maximum period for Police officer can be retained at one police station / post or one district and one region itself, no other reason is made out. Reference is given to Rule 6 (c)(1)(c) of the amended Rule, whereby the amendments were effected in Section 22N of the Maharashtra Police Act.

5. After having considered the facts involved in the present matter, it appears to me that the respondents have really failed in considering the request made by the applicant vide his representation dated 04.04.2023. When there was no such reason for shifting the applicant from Latur only on the ground that he has been completed 4 years tenure in the Latur district, transfer could not have been effected. There are certain provisions in the Maharashtra Civil Services Rules and wherever paramateria provisions are made in the Maharashtra Police Act, aid is taken of the provisions made under the Maharashtra Civil Services Rules. However, certain rules provided that when the employee is on the verge of retirement can ask for posting at his native place or nearby to his native place stating the reason therefor. The applicant in his representation dated 4.4.2023 has explained the reasons for his retention at Latur for the remaining period up to his retirement. It appears that the respondents did not consider any all those reason. There are no explanations for rejecting the said representation being there open. The reasons could have been tested on the ground of suspecting. However, there was no reason sated I reiterate. Therefore, the interim order was passed in this matter, thereby respondents were directed to allow the applicant to discharge duties on his existing post at Latur and, as such, the impugned
