4. Learned Chief Presenting Officer has tendered across the bar copy of order passed by the Principal Bench of this Tribunal at Mumbai in O.A. No. 233/2020 on 09.03.2021. It is taken on record. Referring to the observations made and findings recorded in the said order, the learned C.P.O. submits that having identical facts involved in the present matter, the contempt action would not lie.

5. We have gone through the order, which has been referred to and relied upon by the learned C.P.O. It appears to us that the facts in the said matter are quite distinguishable and may not be applicable in the instant matter.

6. After having perused the order the contempt of which is alleged in the present petition and after having heard the submissions made on behalf of the applicant, as well as, the respondents, we have *prima facie* reached to the conclusion that respondent No. 1 has failed to comply with the order
