### ORDER

- 1. Heard Shri M.D. Lonkar, learned Advocate for the Applicants and Shri A.J. Chougule, learned Presenting Officer for the Respondents.
- 2. All these three applicants are working as Associate Professor, Group-A in Grant Medical College, Mumbai. They are due for transfer. These applicants challenge their transfer order dated 13.7.2023 by which they are transferred to Nandurbar, Satara and Kolhapur respectively. All the applicants are relieved from their posts on 14.7.2023. However, nobody has joined on their respective posts.
- 3. Ld. Advocate for the applicants submits that it is a mid-term transfer. He submits that children of the applicants are studying. Son of

V/

applicant in OA No.884/2023 is studying in 10<sup>th</sup> standard and elder son is in last year of PG. Daughter of the applicant in OA No.885/2023 is in 12<sup>th</sup> standard and son of the applicant in OA No.888/2023 is in10th standard. He further submits that on account of this mid-term transfer children are going to suffer and they will not get correct admission. Ld. Advocate in support of his submissions rely on the judgment of the Hon'ble Supreme Court in <u>Director of Education, Madras & Ors. Vs. O. Karuppa Theven & Anr. 1994 Supp (2) SCC 666</u>. Ld. Advocate further submits that Section 4 of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter referred to as the 'Transfer Act') is not followed. Therefore, he prays for interim relief.

- 4. Ld. PO opposes these OAs and produces minutes of the meeting of Civil Services Board (CSB) dated 17.5.2023. Ld. PO submits that these transfers are general transfers and the applicants were aware that they were due for transfer. Ld. PO further submits that proper procedure is followed while transferring these applicants. These transfers are on administrative ground and as per requirement of the services of these applicants they are posted on the vacancies available.
- 5. Perused the minutes of CSB meeting dated 17.5.2023. After the minutes, the file was sent to the Hon'ble Minister for Medical Education & Drugs on 18.5.2023. It was pending before him till 28.6.2023. Then it was sent to the Hon'ble Chief Minister and the Hon'ble Chief Minister signed the same on 12.7.2023. Therefore the orders were issued on 13.7.2023.
- 6. The submission of Ld. PO is that delay is caused on account of administrative grounds. The submission is not acceptable, especially

when under Section 4 of the Transfer Act the procedure is mentioned in detail which is reproduced below:

- "4. (1) No Government servant shall ordinarily be transferred unless he has completed his tenure of posting as provided in section 3.
- (2) The competent authority <u>shall prepare every year in the month</u> of January, a list of Government servants due for transfer, in the month of April and May in the year.
- (3) Transfer list prepared by the respective competent authority under sub-section (2) for Group A Officers specified in the entries (a) and (b) of the table under section 6 shall be finalized by the Chief Minister or the concerned Minister, as the case may be, in consultation with the Chief Secretary or concerned Secretary of the Department, as the case may be:

Provided that, any dispute in the matter of such transfers shall be decided by the Chief Minister in consultation with the Chief Secretary.

(4) The transfers of Government servants shall ordinarily be made only once in a year in the month of April or May:

Provided that, transfer may be made any time in the year in the circumstances as specified below namely:-

(i) to the newly created post or to the posts which become vacant due to retirement, promotion, resignation, reversion, reinstatement, consequential vacancy on account of transfer or on return from leave;



- (ii) where the competent authority is satisfied that the transfer is essential due to exceptional circumstances or special reasons, after recording the same in writing and with the prior approval of the next higher authority."
- Section 4 specifically mentions that Government servants who are 7. for transfer, the authority is required to prepare list of the Government servants who are due for transfer much earlier i.e. in the month of January itself to enable to issue transfer orders in the month of April-May in the year. When the Act mentions the time and the period specifically then the Government is duty bound to follow the procedure as it is. There is always a though, lot of deliberation by the law makers, when such time frame is mentioned on the 'Act' itself. If at all Govt. wants to go beyond the period then it will amount of mid-term transfer. It is to be noted that last year on account of COVID-19 Pandemic being global calamity it was not possible to follow the schedule of the transfer contemplated under Section 4 of the Transfer Act. But it is not the case in this year and therefore it is expected that every department should do their paper work of the transfer in the month before April and so that the CSB can be conducted within time to enable to issue the order of transfers in the month of April-May in each year. It is made clear that mere conducting CSB is not fulfilling the procedure when further the approval of the Hon'ble Minsiter or Hon'ble Chief Minister is required. responsibility of the concerned department to complete the procedure within time frame and the department should place the file for orders well within time before the Hon'ble Minister for issuing orders in the month of April-May. If the files are placed in late May and the signatures are not obtained within time limit then orders issued after stipulated time frame are to be considered as mid-term transfers. Thus considering the legal position prima facie I am of the view that the ground that signature could



not be obtained on account of administrative ground and therefore the transfer orders could not be issued within time, is a lame excuse. This is a matter of putting up file efficiently within time before the Hon'ble Ministers.

- 8. Secondly in these 3 matters the children of the applicants are in 10<sup>th</sup> and 12<sup>th</sup> standard. On this point I rely on the judgment of the Hon'ble Supreme Court in *O. Karuppa Thevan & Anr.* (supra), which reads as under:
  - "1. Leave granted. Heard both counsel.
  - 2. The tribunal has erred in law in holding that the respondent employee ought to have been heard before transfer. No law requires an employee to be heard before his transfer when the authorities make the transfer for the exigencies of administration. However, the learned counsel for the respondent, contended that in view of the fact that respondent's children are studying in school, the transfer should not have been effected during mid-academic term. Although there is no such rule, we are of the view that in effecting transfer, the fact that the children of an employee are studying should be given due weight, if the exigencies of the service are not urgent. The learned counsel appearing for the appellant was unable to point out that there was such urgency in the present case that the employee could not have been accommodated till the end of the current academic year. We, therefore, while setting aside the impugned order of the Tribunal, direct that the appellant should not effect the transfer till the end of the current academic year. The appeal is allowed accordingly with no order as to costs."



- 9. Thus, though transfer is an incident of service and it is the duty of the government servant to go to the place of transfer and render service, however, it is also mandatory on the part of the administration to follow the rules and especially when there is special enactment in State of Maharashtra i.e. Transfer Act, 2005 which is outcome of the judgment of the Hon'ble Supreme Court in T.S.R. Subramanian & Ors. Vs. Union of India & Ors. Writ Petition (Civil) No.82 of 2011 decided on 31.10.2013.
- 10. In view of the above, the transfer order dated 13.7.2023 in respect of the applicants are hereby stayed till further orders. The respondents are directed to allow the applicants to continue to work in their respective posts till then.
- 11. The office objections, if any, are to be removed and court fees to be paid, if not already paid.
- 12. Issue notice before admission returnable on 18.8.2023. The respondents are directed to file reply.
- 13. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is allowed. Respondents are put to notice that the case may be taken up for final disposal at the stage of admission hearing.
- 14. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- 15. By Hand delivery, speed post, courier notice to be served and acknowledgement be obtained and produced along with affidavit of



compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.

16. In case notice is not collected within **seven days** or service report on affidavit is not filed **three days** before returnable date, the OA shall be placed on board before the concerned Bench under the caption "For **Dismissal**" and thereafter on the subsequent date the OA shall stand dismissed.

#### ORDER

- 1. The applicant working as Education Officer (Secondary), Zilla Parishad, Nasik, challenges his transfer order dated 28.7.2023 transferring him from Nasik to Zilla Parishad, Ahmednagar as an Education Officer (Scheme).
- 2. The matter today is for interim relief. Earlier, ad-interim relief was granted on 19.7.2023 directing the applicant to continue to work on the said post till today, as the learned P.O for the Respondents wanted time to take instructions to argue on interim relief in the matter so the applicant was protected for two days.
- 3. It is the mid-term transfer. The applicant has taken charge of the post at Nasik by order dated 2.11.2022 and only after 9 months the applicant is transferred. Learned counsel for the applicant has submitted that the applicant is transferred out of

political pressure and mainly on the ground that he is facing a criminal case under the Prevention of Corruption Act and there are certain complaints against him. Learned counsel for the applicant has further submitted that the applicant was never informed about the complaints against him. No explanation is sought from the applicant in respect of the complaints. The departmental enquiry is initiated against him on 18.7.2019 and it is concluded and the report is submitted to the Disciplinary Authority in the year 2022. Learned counsel has relied on the G.R dated 11.2.2015 on following the procedure at the time of transferring the officer and has submitted that the Applicant has been transferred to nonexecutive post on account of the pending complaint against him. Learned counsel for the applicant has further submitted that the reasons given for his transfer arc malafide, bad in law. Further, the applicant has been promoted after 2017 and he has been holding always executive post along with the additional charge of the higher post. The Applicant has never been informed or asked for any such compliant. No D.E. was initiated against the Applicant. Learned counsel for the applicant has submitted that nobody is posted in his place. Therefore, learned counsel for the applicant prays for interim relief.

4. Learned P.O for the Respondents while defending the order passed by the competent authority submits that the Respondents have followed the due procedure and the Civil Services Board has taken a conscious decision of transferring the applicant on account of the complaints against him. Learned P.O has further submitted that the case of the applicant was placed before the Civil Services Board and in the meeting held on 28.6.2023, the Civil Services Board has taken decision to transfer the applicant. Learned P.O has further submitted that on the file noting the Hon'ble Education Minister has signed and the approval of the Hon'ble Chief Minister



is taken. Thus, the Respondents have followed the appropriate procedure under Section 4(4)(ii) and 4(5) of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005.

- 5. Perused the notings and the minutes of the Civil Services Board. It discloses that the applicant is transferred on the basis of the complaint letter written by the Guardian Minister. There is a note from the Hon'ble Minister of Ports and Minerals dated 28.6.2023. It shows that the Hon'ble Minister has proposed the transfer of the applicant on account of complaints received by him from the Teachers and the Teachers Association. In the minutes of the meeting of the Civil Services Board, the reason for his transfer is mentioned in para 3 which states that applicant is transferred on account of complaints received from the Teachers and the Teachers Association, also on account of the case filed against the applicant under the Prevention of Corruption Act and so also for not obeying the administrative orders and also on account of the letter dated 14.6.2022 sent by the Commissioner, Education to the Director, A.C.B to conduct enquiry against the applicant, and therefore, he is transferred.
- 6. In clause No.8 of the G.R dated 11.2.2015, it is stated that in the event of receiving the complaint against the civil servant, who has not completed three years at a particular post, it is necessary for the competent authority to find out the factual position and also to consider the seriousness and then departmental enquiry should be initiated against the civil servant for those complaints by keeping him on the same post. However, if at all the competent authority comes to the conclusion that it is not proper to keep the said civil servant on the same post, then after recording reasons the said civil servant can be transferred. In the present case, the



noting discloses that the complaints were received from the Teachers and the Teachers Association against the applicant. There is one case pending against the applicant under the Prevention of Corruption Act. However, the case was registered on Further, he was promoted and he was also given 21.3.2017. executive posting with additional charge. Thus, pendency of case against him since 2017 cannot be considered as a ground for mid term transfer in the year 2023 as it is a very remote cause. A strong ground argued by the learned P.O that the complaints were received about his behaviour, conduct and administration by the Teachers and Teachers Association and the Hon'ble Guardian Minister, Nasik after taking a serious note of the complaints have written letter to the Hon'ble Chief Minister and therefore, he was transferred. Thus, there was some information collected by the Respondent to justify his transfer. It is true that owing to reasons of political expediency and the administration, the Hon'ble Minister being representative of the people have to take note of the complaints of the people against the working of a particular civil servant. However, it is necessary for the administration to follow the procedure and in clause 8 of the G.R dated 11.2.2015, it is stated as under:-

"८. एखाद्या प्रकरणात ३ वर्षापेक्षा कमी कालावधी असलेल्या अधिकारी/कर्मचा-याच्या विरोधात गैरवर्तणूकीच्या तक्रारी प्राप्त झाल्यास केवळ तक्रारीच्या आधारे संबंधीत अधिकारी/ कर्मचा-याची बदली करण्यात येऊ नये. अशा प्रकरणात संबंधीत अधिकारी/ कर्मचा-यांच्या तक्रारीसंबंधातील वस्तुरिश्ती जाणून घेऊन (आवश्यक तेथे अहवाल मागवून) तक्रारीमधील गांभीर्य विचारात घेऊन, संबंधीत अधिकारी / कर्मचारी त्याच पदावर ठेवणे आवश्यक आहे किंवा करो यांबाबात बदली प्राधिका-यांने ठोस निर्णय घ्यावा."

Thus, if at all the complaints are received about the Applicant, then it is necessary for the authority to collect the information and verity it and understand real factual situation as expeditiously as possible against the said officer and also that officer is to be informed about such complaints so the independent

verification, seriousness and truthfulness in the complaints can be ascertained by the higher authority. Apart from the G.R dated 11.2.2015, I would like to place reliance on the judgment of the Hon'ble Supreme Court dated 31.10.2013, in the case of T.S.R Subramanian & Ors Vs. Union of India & Ors, Writ Petition (C) No 82/2011, in which the Hon'ble Supreme Court has extensively considered the report of 2004 of Hotha Committee and also 2<sup>nd</sup> Administrative Reforms Commission (10<sup>th</sup> report of 2008), wherein it is specifically mentioned that:-

"It would be expedient before an officer is sought to be transferred in the public interest when he has not completed his tenure, that an administrative enquiry of a summary nature is held to ascertain if the transfer is justified as a matter of public policy. The administrative inquiry will be conducted as expeditiously as possible by a designated officer nominated by the Civil Services Board. In appropriate cases, the Civil Services Board may also direct the officer to proceed on leave on full pay and allowances till the administrative inquiry over and a decision is taken regarding the transfer."

7. It is to be noted that there are complaints against the applicant. There may be complaints. However, the administration is required to look into the said complaints by following the correct procedure. Transferring the officer by way of punishment is not the answer. Moreover, in the file the written complaints made by one or two complainants are placed and it appears that nowhere in the said complaint the name of the applicant is appearing. Thus, when the complaints are made in general, it is all the more expected on the part of the Respondents or the higher administrative authority to probe into the seriousness,d correctness and find out prima facie truth in such enquiry. The record does not disclose so.



- 8. In view of the above, interim relief is granted in terms of prayer clause 11, till final disposal of the Original Application.

### ORDER

- 1. The applicant, working as Assistant Professor, Group-B, at Grant Medical College, Sir J.J Group of Hospitals Mumbai, challenges the order dated 13.7.2023 transferring him to Dr V.M Medical College, Solapur.
- 2. Learned counsel for the applicant submits that private Respondent no. 2 is not served and the Respondent no. 2 is not relieved from Nagpur. Learned counsel for the applicant challenges the transfer order on the ground that as per the G.R dated 9.4.2018 preference of giving choice posting is not called from the applicant before he is transferred. Learned counsel for the applicant relies on the order of the M.A.T, Aurangabad Bench dated 4.7.2023 in O.A 537/2023 & Ors, Dr. Snehalata T.

Yellambkar Vs. State of Maharashtra & Ors. He submits that the applicant is similarly situated like Dr. Yellambkar and Aurangabad Bench has granted interim relief there. Learned counsel prays for interim order that the applicant be allowed to continue to work at Grant Medical College, Mumbai.

- 3. Learned P.O defended the order passed by the competent authority and further submitted that today nobody is present to give instructions to him.
- 4. pursuant to the G.R dated 9.4.2018, it is necessary on the part of the Respondents to call the preference of the postings when the Government servant is due for a transfer. The case of the applicant is covered under order gated 4.7.2023 in O.A 537/2023 & Ors, Dr. Snehalata T. Yellambkar Vs. State of Maharashtra & Ors. passed by M.A.T, Aurangabad Bench, wherein this Tribunal has dealt with specifically section 4 of the Maharashtra Government Servants Regulation Transfer and Prevention of Delay in Discharge of Official Duties Act, 2005. No material is placed before me disclosing the compliance of G.R dated 9.4.2018. Therefore, considering the submissions of the learned counsel and as the Respondent no. 2 is not relieved and not taken charge of the post at Grant Medical College and Hospital, Mumbai, I am of the view, that prima facie case is made out to grant interim relief, which was granted in similar matters by M.A.T, Aurangabad Bench in O.A 537/2023 & Ors.
- 5. In view of the above, the transfer order dated 13.7.2023 is stayed and the Respondents are directed to allow the applicant to work and perform his duties as Assistant Professor in Grant Medical College and Hospital Mumbai till filing of the reply.

#### URDER

- 1. The applicant working as Associate Professor, in B.J Medical College, Pune is transferred by order dated 13.7.2023 as Associate Professor, Government Medical College, Baramati.
- 2. Learned counsel for the applicant has submitted that the applicant is transferred mid-term and mid-tenure and the applicant is going to retire on 30.4.2024. Learned counsel for the applicant has further submitted that the applicant is not due for transfer as he was posted at the present place of posting at B.J Medical College, Pune on 30.9.2022. Learned counsel for the applicant further submitted that nobody is posted in place of the applicant and the post is lying vacant.
- 3. Learned P.O, while defending the order of transfer, relies on the minutes of the meeting of the Civil Services Board dated

17.5.2023 and has submitted that provisions of Section 4(4)(ii) & 4(5) of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005. (hereinafter referred to as the said Act) are complied with. White considering the transfer of the present applicant from Pune to Baramati, the reason given by the Civil Services Board is that a post at Government Medical College, Baramati is vacant and the said post is to be filled in as per the parameters laid down by the National Medical Council and hence the applicant is transferred. Learned P.O on inscructions submits that nobody is posted in place of the applicant.

- It is true that the parameters laid down by the National Medical Committance to be followed and are to be fulfilled by each and every Government Medical College. However, while fulfilling these parameters, it is equally recessary to follow the law laid down by the State. The applicant was transferred 10 months before to B.4 Medical College, Pune, and going to retire within 8 months. This fact is not recorded while considering the special reasons or exceptional circumstances as per Rule 4(4)(ii) and 4(5) ROT Act, 2005, qualific applicant. Thus, prima facie case is made out to grant the interior relief.
- 5. In view of the face that nobody is posted in the place of the applicant, the transfer order dated 13.7.2023, qua the applicant is stayed until further orders and the applicant is allowed to continue on the said post.
- 5. Issue notice before admission returnable on 4.8.2023.
- 7. Applied it is authorized and directed to serve on Respondent intimation motice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is

allowed. Respondents are put to notice that the case may be taken up for final disposal at the stage of admission hearing.

#### ORDER

- 1. The applicant working as Associate Professor, challenges the transfer order dated 13.7.2023 transferring him from Grant Medical College, Sir J.J Group of Hospitals, Mumbai to Government Medical College, Miraj.
- 2. Learned counsel for the applicant has submitted that the applicant was not due for transfer. The applicant was working in Grant Medical College, Mumbai as Associate Professor from 23.12.2005 to 17.5.2021. By order dated 17.5.2021, he was sent on deputation to Alibaug. On 2.9.2022, he was relieved from Alibaug and posted at Grant Medical College, Mumbai afresh, and therefore, he is not due for transfer. This is a mid-term transfer also and therefore, the provisions under Section 4(4)(ii) and 4(5) of

the of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter called ROT Act) are required to be followed. The case of the applicant was placed before the Civil Service Board. Learned counsel for the applicant has submitted that the competent authority is the Minister of Medical Education Department in consultation with the Principal Secretary, Medical Education Department and the approval of the Hon'ble Chief Minister is required as the highest authority and it is not done in the present case. Learned counsel for the applicant relied on the order of the Tribunal, Aurangabad Bench dated 6.7.2023 in O.A 550/2023 & Ors, Dr Surajkumar S. Kuril & Ors. Learned counsel further submitted that the applicant's daughter is pursuing M. Sc, final year and her examination is in the month of March, 2024.

- 3. Learned P.O while opposing the application has submitted that the reason is specifically mentioned in the minutes of the Civil Services Board meeting that two posts in Government Medical College, Miraj are vacant and as per the criteria laid down by the National Medical Council, the posts are required to be filled up and therefore the applicant is transferred to Miraj. Learned P.O has further submitted that even if it is considered as mid-term transfer, still the reasons given in the minutes of the Civil Services Board meeting fulfills the requirement under Section 4(4)(ii) and 4(5) of the Act, as the approval and signature of the Medical Education Minister and the Hon'ble Chief Minister is there on the file.
- 4. Considered the submissions. After going through the minutes of the Civil Service Board meeting, it is found that the signatures of the Hon'ble Medical Education Minister and the Hon'ble The Chief Minister are found in the noting of the file. In

the minutes of the meeting of the Civil Services Board, it is specifically mentioned that officers who have completed thee years they are due for transfer. The Civil Services Board has not considered that the applicant was transferred on deputation to Alibaug for a period of one year and six months. The posting at Mumbai is shown from 12.7.2006 instead of 2.9.2022. Prima facie, it shows that the applicant as he was sent on deputation which is also a transfer as and when he joined at Mumbai on his present post the period from that is to be counted for 3 years.

- 5. In view of the above, interim relief is granted in terms of prayer clause 10(b). It is made clear that this order will not come in the way of the Respondents to pass a fresh order by following proper procedure.
- 6. Learned P.O is granted time to file reply.
- 7. S.O to 3.8.2023. Hamdast.

- 2. The applicant is seeking appointment to the post of Junior Engineer pursuant to advertisement dated 22.7.2019 from NT-C category. Ld. Advocate submits that recommendation list was published on 20.6.2023. Applicant passed the examination and secured 154 marks which is also the cutoff marks. Ld. Advocate submits that applicant is eligible for recommendation. However, his name is not recommended because one candidate from NT-C category having lesser marks than the cutoff is recommended.
- In the advertisement the respondents have declared one post Orphan in Open category and there are two posts for Orphan. Ld. Advocate points out GR dated 2.4.2018 wherein Govt. has declared its policy of giving 1% reservation to the Orphans from Open Category. Pursuant to the said GR dated 2.4.2018 the GAD has issued letter dated 28.12.2018 addressed to all the departments. It was specifically mentioned in the said letter in clause 8 of the Table reiterating the policy of keeping 1% post for Orphan in Open category. Therefore on this basis Ld. Advocate challenges shifting of reservation from Orphan in NT-C category. Thereafter the Govt. has issued different GR dated 23.8.2021 by which the Govt. has changed its reservation policy for Orphan wherein it is mentioned in sub clause 5 of clause 2 of the said GR certain conditions and procedure is laid down of giving reservation to Orphans. Sub clause 5 and 9 of clause 2 of the said GR are relevant.
- 4. Ld. Advocate for the applicants submits that result in the present matter was declared on 24.3.2023. As per sub clause 9 of clause 2 of the said GR dated 23.8.2021 it is made applicable prospectively and so also for the results which were declared till 2.4.2018.
- 5. Ld. CPO pointed out sub clause 6 of clause 2 and submits that sub clause 5 & 6 are to be read together as reservation for
