It is for the applicant to convince the authorities to consider his representation and pass the appropriate order, however, no direction can be given to the respondents in this regard. Moreover, even today also, the applicant has not possessed the E.W.S. certificate and in view of same, it may not be appropriate to give direction to the authorities to decide the representation of the applicant. However, it is open for the applicant to

Learned counsel for the applicant submits that the applicant came to be retired on superannuation on 30.06.2019 and as such he is entitled for getting increment which commences from 1st day of July 2019. His next increment was due on 01.07.2019 but he came to be retired one day earlier i.e. 30.06.2019 and therefore he is not given benefit of annual increment which was due on 01.07.2019. The applicant was appointed on the post of Junior Clerk with the office of Civil Hospital Thane, Dist. Thane on 13.03.1984. He was promoted in due course and further transferred at various places and finally retired on aforesaid date.

3. Learned counsel for the applicant submits that in terms of the order dated 16.02.2023 passed by the Hon'ble High Court of Bombay, Bench at Aurangabad in Writ Petition No. 1881 of 2023, the Government has issued Circular dated 28.06.2023

and stated therein that such employees are entitled for notional inclusion of the annual increment for recalculating their pension, gratuity, earned leave, commutation of pension benefits etc.

4. Learned counsel for the applicant submits that the department has never informed to the applicant though directed by the Hon'ble High court in the aforesaid Writ Petition. He came to know about it from the other Government employees and as such, the delay has occurred in filing the accompanying Original Application. Learned counsel for the applicant submits that the delay is not intentional one and there is no inaction on the part of the applicant.

5. Learned P.O. submits that there is an inordinate delay in filing the accompanying Original Application and the delay has not been satisfactorily explained by the applicant. Hence, the Misc. Application seeking condonation of delay is liable to be dismissed.

6. It appears that the Hon'ble High Court of Bombay, Bench at Aurangabad by order dated 16.02.2023 in Writ Petition No. 1881/2023 has

directed Chief Secretary of the State of Maharashtra and Principal Secretary (Finance Department), State of Maharashtra, to issue appropriate directions to all the concerned departments to appeal to such candidates, who fall in such category having retired on 30th June of the particular years and who have earned the annual increment on account of performing work for 12 months ending on 30th June, to tender their applications to the concerned Authorities.

7. It appears that in spite of the said directions, the respondents have not bothered to inform the applicant who came to be retired on superannuation on 31.06.2019 and entitled to pay increment which was due as on 01.07.2019. In view of same, there is no negligence on the part of the applicant and so also no inaction. In view of same, I am inclined to condone the delay. Hence, the following order:-

<u>O R D E R</u>

(i) M.A. No. 507/2022 is allowed.

- (ii) The delay of 662 days caused in filing the accompanying O.A. is hereby condoned.
- (iii) Accompanying O.A. be registered and numbered in accordance with law.
- (iv) No order as to costs.

> "[a] We direct the Chief Secretary of the State of Maharashtra and (Finance Principal Secretary Department), State of Maharashtra, to issue appropriate directions to all the concerned departments to appeal to such candidates, who fall in such category having retired on 30th June of the particular years and who have earned the annual increment on account of performing work for 12 months ending on 30th June, to tender their applications to the concerned Authorities.

> [b] After such applications are received, the concerned authorities would grant the reliefs as are being granted by the various High Courts by

restricting the arrears of payments to 3 years preceding the dates of the applications or preceding the date of actual retirement as per actuals, whichever is less. With these guidelines, the concerned authorities shall not reject a single application if it fits into the parameters of the judgments delivered by this Court.

[c] In the alternative, let the concerned authorities suo-moto dig out such cases and after scrutinizing the same as regards their entitlment, proceed to grant the benefits as per the judgments of this court, within 120 days.

[d] While undertaking the above exercise, the gratuity/pay fixation/ pension will be re-calculated, so as to be paid to the candidates with arrears as directed above."

4. In terms of the aforesaid directions given by the Hon'ble High Court, the Finance Department has issued Circular dated 28.06.2023 with the specific direction to the concerned departments to decide all such matters as per information available with the department. However, though specifically directed by the Hon'ble High court in the aforesaid W.P., applicant has not been communicated to submit application for seeking notional increment along with the arrears which fell due on 1st July of his date of retirement.

5. It appears from the direction issued by the Hon'ble High court in the aforesaid W.P. and in the light of the Circular issued by the Finance Department on 28.06.2023 and considering the date of retirement of the applicant, the applicant is entitled for the aforesaid benefits. The applicant is seeking direction to respondent Nos. 1 to 3 to grant the last annual increment of the applicant along with all the consequential benefits. In view of same, the Original Application deserves to be allowed. Hence, the following order:-

- (A) The Original Application is hereby allowed.
- (B) The respondent Nos.1 to 3 are directed to grant annual increment along with the arrears to the applicant which fell due on 1st July of his date of retirement.

Deshmukh, learned counsel for the applicants in O.A, Shri Ganesh Darandale, learned counsel for respondent Nos. 7, 12, 32 & 24 in O.A., Shri J.B. Choudhary, learned counsel for respondent Nos. 8, 28 & 36 in O.A. and Shri M.S. Mahajan, learned Chief Presenting Officer for the respondent authorities.

2. Learned counsel appearing for the applicants in O.A. has sought permission to add intervenors as respondents in the present O.A.

3. Leave granted. The necessary amendment be carried out within a week.

4. Some of the candidates have sought their impleadment as applicants and those applications are

6. On 21.9.2023 the present matter was heard by the Single Judge for non-availability of the Division Bench. The matter then reserved for orders; however, when the Division Bench is available it is deemed appropriate that the matter shall be heard by the Division Bench in brief, so the matter was kept on today's board. Today, the MPSC as well as the Government both have filed affidavit in reply to the O.A. It is informed that insofar as the candidates in respect of whom there are no interim orders the process is going on for their appointment and the document verification has been done and police verification is in progress. It is informed that the appointments are likely to be issued from first week of January to the said candidates.

7. Considering the facts as aforesaid it appears to us that matter can be finally heard in the second week of January, 2024, which may be in the interest of all the
