The applicant is seeking relief of revocation of suspension order. Learned counsel on instructions submits that the applicant has acquiesce right to challenge the order of suspension.
- 4. Learned counsel for the applicant further submits that the applicant though suspended by order dated 29.08.2015, he remained in jail till the year 2018 and finally he came to be released on bail

under the orders of the Hon'ble Supreme Court on 13.11.2018. The charge-sheet has been served on the applicant even in the year 2022. The Departmental Enquiry is completed and the report has been submitted by the enquiry officer. The disciplinary authority has neither served the copy of the enquiry report on the applicant nor taken any action. Learned counsel submits that it is learnt that the enquiry officer exonerated the applicant in the D.E. Learned counsel submits that the applicant is seeking revocation of suspension order, since the applicant is under suspension for more than 09 years.

- 5. In view of above, I do not think that the office objection is sustainable. Hence, issue notices to the respondents, returnable on 03.04.2024.
- 6. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- 7. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with

complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

- 2. The office has raised an objection that the applicant Nos. 9, 11, 15, 17, 19 to 21, 24, 26 to 37, 41 to 43 do not come within the territorial jurisdiction of this Tribunal.
- 3. Learned counsel for the applicants submits all the applicants were from the department and they are seeking directions against the respondents to revise the pay matrix of Tutors in Public Health Department and Education Department at par with other employees as resolved by G.R. dated 13.02.2023 along with appropriate deem date and arrears of salary. Learned counsel submits that the applicant Nos. 1 to 8, 10, 12 to 14, 16, 18, 22, 23, 25, 38 to 40, 44 & 45 are presently working under the jurisdiction of this Tribunal, whereas the applicant Nos. 11, 15, 26 to 29, 33 to 37 & 41 to 43 are presently working at

Nagpur, amenable to the Nagpur Bench of this Tribunal and the applicant Nos. 9, 17, 19 to 21 & 24 are presently working at Nashik and applicant Nos. 30 to 32 are presently working in Mumbai and hence amenable to the Principal Seat of this Tribunal at Mumbai. The applicants have preferred the common Original Application praying for same relief under the same cause of action.

4. Learned counsel for the applicants submits that in terms of Rule 4 sub-rule (5)(a) of the Maharashtra Civil Services (Procedure) Rules, 1988, the Tribunal may permit more than one person to join together and file a single application if it is satisfied, having regard to the cause of action and the nature of relief prayed for, that they have a common interest in the matter. Learned counsel further submits that in terms of Rule 6 of the said Rules, 1988, the application shall ordinarily be filed by the applicants with the Registrar of the Bench within whose jurisdiction (i) the applicant is posted for the time being, or (ii) the cause of action has arisen, or (iii) the respondent or any of the respondents against whom relief is sought,

ordinarily resides. Learned counsel submits that though the applicants are working in different cities amenable to the different Benches of this Tribunal, however they have got common cause of action as against the common relief. In view of the same, in terms of the aforesaid provisions, the applicants are seeking permission to sue jointly in view of Rule 4 sub-rule (5)(a) of the Maharashtra Civil Services (Procedure) Rules, 1988.

5. Learned counsel for the applicants has placed reliance in a case of Nilesh Raosaheb Tagad and Ors. Vs. State of Maharashtra and Ors. in W.P. No. 3228/2020, decided on 21.09.2020, wherein in respect of the similarly situated employees the Division Bench of the Hon'ble High Court of Bombay, Bench at Aurangabad after referring Rule 4 sub-rule (5)(a) of the Maharashtra Civil Services (Procedure) Rules, 1988 has quashed and set aside the order passed by the Tribunal holding that the Tribunal has no jurisdiction in such type of cases and further held that the Tribunal shall consider the Original Application filed by the petitioners on its own merits.

6. In view of above submissions, it is necessary to reproduce herein below the provisions of Rule 4 subrule (5)(a) of the Maharashtra Civil Services (Procedure) Rules, 1988, which is relevant for the present discussions, as the sub-clause (b) may not be relevant of the said Rules, 1988:-

"4. Procedure for filing application.-

- "(5)(a) more than one person to join together and file a single application if it is satisfied, having regard to the cause of action and the nature of relief prayed for, that they have a common interest in the matter"
- 7. In the aforesaid W.P. No. 3228/2020, decided on 21.09.2020, in para Nos. 8, 9 & 10, the Division Bench of the Hon'ble High Court of Bombay, Bench at Aurangabad has made the following observations:-
 - "8. A tribunal may get the jurisdiction to entertain an application in any one of the contingencies referred to in Rule 6 of the Maharashtra Administrative Tribunal Rules. An applicant may file the application before the tribunal within whose

jurisdiction he is posted or the cause of action has arisen or the respondent or any of the respondents against whom relief is sought, ordinarily resides.

- 9. Petitioner no. 1 is resident within the jurisdiction of the tribunal at Aurangabad, petitioner no. 2 is resident within the jurisdiction of the tribunal at Mumbai and petitioner no. 3 is resident within the jurisdiction of the tribunal at Nagpur.
- If the place of residence would have been the only consideration, then the order of the tribunal would have been justified. It appears that the tribunal has failed to consider the other two contingencies i.e. where the cause of action has arisen or the respondent or any of the respondents against whom relief is sought, ordinarily resides. The advertisement of which Clauses 6.4.3 and 6.4.4 were under challenge is for filling in the posts throughout the State of Maharashtra. advertisement is not restricted to filling in the posts at a particular place. The concept of cause of action has not been considered by the tribunal. The posts are to be filled in by the State Government and the said posts could be filled in by the Government at any place in the State Maharashtra. The advertisement is not limited to fill in the posts at a particular place. In that view, it cannot be said that the cause of action has not arisen within the jurisdiction of the tribunal at Aurangabad."
- 8. In the instant case, the applicant Nos. 1 to 8, 10, 12 to 14, 16, 18, 22, 23, 25, 38 to 40, 44 & 45 are presently working under the jurisdiction of this Tribunal, the applicant Nos. 11, 15, 26 to 29, 33 to

37 & 41 to 43 are presently working at Nagpur, which amenable to the Nagpur Bench of this Tribunal and the applicant Nos. 9, 17, 19 to 21 & 24 are presently working at Nashik and applicant Nos. 30 to 32 are presently working in Mumbai and hence amenable to the Principal Seat of this Tribunal at Mumbai. Thus the place of working would not have been the only consideration. There are other two contingencies i.e. the common cause of action has arisen and the applicants serving in the same department are seeking common relief. Thus the view expressed by the Division Bench of the Hon'ble High Court of Bombay, Bench at Aurangabad is squarely applicable to the facts and circumstances of the present case. Thus considering the entire aspect of the case and in terms of the above discussions, I hold that this Tribunal gets the jurisdiction to entertain this Original Application, as they are seeking the same relief.

- 9. The office objection is hereby overruled.
- 10. In view of above, the present Misc. Application is allowed in terms of prayer clause 7(A), subject to

payment of court fee stamps, if not paid. The accompanying O.A. be registered and numbered by taking in to account other office objection/s, if any.

11. Accordingly, M.A. stands disposed of. No order as to costs.
