A simple interpretation that the applicant has not relied on any letter dated 30.07.2018 issued by respondent no. 2 and therefore, he had verbally proposed above amendment, does not justify his act of harping on initial cause of action and not covering subsequent developments which constitute main cause of action as explained in following para No. 6 of this order.
- 6. It is notice worthy that by the time of filing the present O.A. i.e. by 01.08.2019, departmental inquiries against the applicant had been completed and the Department of Revenue and Forest (Forest),

- Dated 09.04.2018 informing the applicant proposed punishment about the and opportunity to the applicant to submit his say in one of the departmental inquiries. Copy of this communication is appended as EXHIBIT-'L', page No. 106-107 of the paper-book of the O.A. Similarly, the applicant was communicated about proposed punishment in three other departmental proceedings against the applicant which have been appended as EXHIBIT - 'K', at page no. 94 to 105 of paper-book of the O.A. However, the applicant has neither challenged these proposed punishments nor given updated position in respect of passing of final punishment orders by the respondent authorities.
- 7. Learned Presenting Officer had filed affidavit in reply to the miscellaneous application, on behalf of respondent Nos. 1 to 4 on 19.03.2020, which was taken on record and a copy thereof, has been served on the other party. As per applicant's request, further hearing of this matter was adjourned to

dates of 25.01.2022; 01.03.2022; 07.04.2022 and 08.06.2022 for enabling the applicant to file rejoinder affidavit to affidavit in reply filed by respondent no. 1 to 4. Thereafter, the learned Advocate for the applicant submitted that he is not willing to file rejoinder affidavit. With consent of the two sides to the dispute the matter was fixed for final hearing on 14.07.2022 which finally took place on 23.03.2023 and the matter was reserved for order.

8. It is admittedly that the applicant, who was working as a Range Forest Officer, retired on 31.05.2014 and was fully aware of departmental inquiries going on against him from prior to his retirement. He was also informed by respondent No. 2 by a letter dated 30.07.2015 about the departmental inquiries had been continued even after his retirement by superannuation. However, the applicant did not act promptly and failed to approach this Tribunal within limitation. The applicant has not only failed to explain by advancing convincing reasons for delay in filing the O.A. with un-amended prayer clause 'B', but has also not given cogent reason for not incorporating

comprehensive cause of action in O.A. as elaborated in para No. 6 of this order.

- 9. On the other hand the respondents have opposed delay condonation on ground that the applicant has not given any justification for delay in filing this O.A.
- 10. Upon perusal of rival submissions, we do not find justification of delay of over 2 years in filing the present O.A. with respect to impugned letter dated 30.07.2015. Moreover, as the present O.A. has been filed by the applicant without giving updated facts in respect of departmental inquiries initiated against him and without enclosing copy of enquiry report along with proposed punishment communicated to him, if any, it may not be possible to adjudicate the matter in a proper manner. Taking serious view of all these shortcomings and dismissing the present Misc. Application may deprive the applicant of opportunity to seek relief even if he is aggrieved by findings in Departmental Enquiry report and/or, punishment order, if any, passed against him. Therefore, in our considered opinion, the delay may be condoned in the interest of justice.

 - C) The respondent Nos. 1 to 4 may kindly be directed to decide the various representations made by the applicant in respect of granting the family pension dated 29/5/2012, 1/3/2016, 16/2/2016 and 20/9/2019 within a stipulated period.
 - D) Any other appropriate orders may kindly be passed in favour of applicant."

- 3. When the present Original Application is taken up for consideration, learned counsel for the applicant, on instructions, submitted that the applicant is not pressing for the relief prayed in clause 'B' of the prayer clause and is pressing only clause 'C' in the prayer clause. It is the contention of the learned counsel for the applicant that though the applicant submitted various representations with the respondents on 29.5.2012, 1.3.2016, 16.2.2016 & 20.9.2019, they are not considered by the respondents.
- 4. In the affidavit in reply the respondents have contended that the representations made by the applicant were not considered for want of requisite documents submitted by the applicant. The respondents have contended that time and again the applicant was communicated to submit the proper documents within a specified period, however, the applicant failed in producing such documents and that was the reason that the representations are not considered.
- 5. Learned counsel for the applicant submits that the applicant is ready to furnish all required

documents to the respondents and has prayed for directions that the respondents shall consider the representations of the applicant on the basis of the documents which may be submitted by her.

Applicant is claiming family pension. It is not 6. in dispute that the applicant's husband, who was in Government employment, remained continuously absent after 2001 unauthorizedly. Had he been in employment of the Government, he would have retired on attaining the age of superannuation in the year 2016. He however, died in the year 2012. Till his death he did not report on duty. According to the applicant, past services of her husband i.e. from 1983 to 2000 can be considered for granting her for family pension and that purpose representations were filed.

In view of the submissions now made, it appears to me that without going into the merits of the contention raised by the applicant, the present Original Application can be disposed of by giving liberty to the applicant to file a fresh representation by annexing there with all required documents and

if such representation is made, the respondents shall consider the said representation on its own merit and pass necessary orders thereon.
