5. Learned Presenting Officer on instructions submits that the respondent No. 6 has not been relieved.

6. Considering the submissions made on behalf of the applicant, it is evident the applicant is challenging the transfer order of the respondent No. 6 and further praying for direction of his transfer from Aurangabad Circle to Pune Circle. In the circumstances, in my considered opinion, at this stage, the purpose would be suitably served by making impugned order of transfer of the respondent No. 6 subject to outcome of the present Original Application and by expediting reply to be filed on behalf of the respondents. It is ordered accordingly.
