2. Learned Advocate for the applicant has submitted that the applicant is serving as Additional Civil Surgeon, Civil Hospital, Ahmednagar from 31.05.2016. It is his contention that without transferring the applicant, the respondents had issued the transfer order of respondent No. 3 and posted him at the place of the applicant by the impugned order dated 31.05.2019. He has submitted that the respondent No. 3 took the charge ex-parte without any relieving order. Therefore, he prayed to grant interim relief to the applicant.

3. Learned Chief Presenting Officer has submitted that transfer of the respondent No. 3 has been made as per the rules and the respondent No. 3 has joined his new posting at Ahmednagar and therefore, he prayed to reject the interim relief as prayed by the applicant.

4. On perusal of the record, it reveals that the applicant has been transferred and posted as Additional Civil Surgeon, Civil Hospital, Ahmednagar by the order dated 31.05.2016 and he is working there since then. He has not been transferred by the respondents in the General Transfers of the year 2019 and without transferring the applicant, the respondents had issued the impugned transfer order of respondent No. 3 and posted on the place of the applicant. Not only this, but record would show that the respondent No. 3 has not been relieved by the higher authority and without relieving order, he took the charge of the post of Additional Civil Surgeon, Civil Hospital, Ahmednagar hurriedly on 03.06.2019. The applicant has also not been relieved from that post i.e. from the post of Additional Civil Surgeon, Civil Hospital, Ahmednagar. In the absence of any transfer order of the applicant, the transfer of respondent No. 3 on the same post prima-facie seems to be illegal.

5. In view of this, it is just and proper to give protection to the applicant. Hence, the respondents are directed not to relieve the applicant and allow him to work on the same post till the next date.

6. Issue notices to the respondents, returnable on 30.07.2019.
