2. This Original Application is filed challenging the impugned posting order of the respondent No.4 dated 20.09.2022 (Annex. 'A-5') issued by the respondent No.1 i.e. the State of Maharashtra through its Additional Chief Secretary (Water Resources), Water Resources Department, Mumbai in place of applicant as Executive Engineer, Krushna Marathwade Construction Division No.4, Osmanabad .

3. The applicant is working on his present post of Executive Engineer, Krushna Marathwada Construction Division No.4 immediately after issuance of order dated 06.04.2018 (Annex. 'A-1'), issued by the respondent No.1 by way of promotion and posting amongst others. The applicant has already completed usual tenure of

2. The applicant has submitted that he is working on the post of Assistant Professor in Obstetrics & Gynecology Department in Vilasrao Deshmukh Government Medical College, Latur on temporary basis. He has completed his Post Graduation Degree in M.S.(Obstetrics & Gynecology) during the period 2015 to 2018. The applicant has enclosed his experience certificates for working as Assistant Professor on temporary basis in various medical colleges covering the period from 2018 to till date.

3. As per clause 3.3.1 of the advertisement No. 041/2021, requirement of experience for minimum qualification for the post of Assistant Professor (Obstetrics & Gynecology), includes three years' Junior Resident in a recognized permitted medical college in the concerned subject and one year as Senior Resident in the concerned subject in a recognized permitted

medical college, in case in which minimum educational qualification prescribed is M.D. Obstetrics & Gynecology or M.S. Obstetrics & Gynecology. The aforesaid minimum experience required is in accordance with the notification issued by Indian Medical Council dated 12.02.2020 as per "Teachers in Medical Institution (Amendment) Regulations, 2019." The Tribunal has already granted interim relief in the following two types of cases: -

(a) Where, Indian Medical Council has given a letter that facility for gaining experience as Senior Resident, is not available in a particular course and, therefore, it is not possible for the candidate to acquire that experience in that course; and

(b) Where facility for gaining experience is available however, total period of experience gained is falling short by small margin say, 2 to 7 days or so.

The present case is altogether different. In the instant matter, facility for gaining experience as Senior Resident is available. However, the applicant has experience of few months only as Senior Resident. In this matter the applicant has claimed relief mainly on the ground of submissions made in paragraph 12 in the present O.A. (page-9 of paper book), which reads as follows: -

"12. Applicant says that, MCI and MUHS regularly carry out inspection of all Medical Colleges including Govt. Medical Colleges. The inspection by MCI is for purpose of granting sanction to strength of students in the college which depends upon the strength

of teaching faculty. MUHS carries out inspection being the Affiliating University of the Medical Colleges in State of Maharashtra. During the course of inspection, academic qualification and eligibility of each teaching faculty both permanent and adhoc is verified by inspection committee. Inspection committees of MCI & MUHS have treated appointments of all bonded and D.S.B. adhoc Assistant Professors as legal and valid appointments. Thus, even according to MCI & MUHS, a candidate who is appointed on the post of Assistant Professor without having worked on the post of Senior Resident, is duly qualified to hold the post of Assistant Professor. MCI & MUHS have always treated them duly qualified and eligible candidates to hold the post of Assistant Professor.”

4. Though the applicant has referred to inspection and communication by NMC and MUHS, he has not added these institutions as respondents, which otherwise appear to be proper and necessary parties. While making oral submission, the learned counsel for the applicant has sought permission to add MCI & MUHS as party respondents, which was granted. Amendment in this regard should be carried out within 7 days from today.

5. In case the facility for gaining experience of Senior Resident is not available anywhere, there is *prima facie* no reason for causing prejudice to any candidate, as Maharashtra Public Service Commission would not have got any valid application. Similarly it is a normal rule that if a candidate does not fulfill minimum eligibility requirement as advertised for the process of recruitment undertaken then relaxation

should not be ordinarily given in individual cases rather the same relaxation should be made available to all the potential candidates who may be prejudiced by limiting the relief only to a few who may be before the Tribunal as applicants.

6. However, considering balance of convenience, relief prayed for by the applicants in those two types of cases has already been granted. In order to provide equal opportunity to all the potential candidates, it is necessary to notify relaxation in clauses relating to minimum experience in relation to educational qualification, so that all the potential candidates can have opportunity to avail the benefits of such relaxation. Therefore, respondent Nos. 1 to 3 are being directed to consider the case of the applicant in the present O.A., if merit is found in the cause of action, and necessary amendment in the corresponding advertisement may be made and opportunity for appearing for the interview may be provided to all the similarly situated candidates.
