Learned Advocate for the Applicant, further states that the Order of 'D.G.P. of Maharashtra State' dated 24.02.2023 which refers to the G.A.D. G.R. date 15.05.2019 is about the 'Inter Establishment Transfer' of 'Government Servants'. He further states that 'Cadre Controlling Authority' of 'Senior Clerks and Junior Clerks' is 'D.G.P. of Maharashtra State' even though these 'Senior Clerks and Junior Clerks' actually work on establishment of 'Commissioner of Police, Mumbai' as well as other (i) 'Commissioners of Police' and (ii) 'Superintendents of Police'.</p> <p>4. Learned Advocate for the Applicant states the fact that it is 'D.G.P. Maharashtra State' who is the 'Cadre Controlling Authority' as is itself evident from Order dated 24.02.2023 of 'D.G.P. Maharashtra State'. Hence, there should be no requirement of 'N.O.C.' from respective (i) 'Commissioners of Police' and (ii) 'Superintendent of Polices' as there is no incidence of 'Inter Establishment Transfer' of 'Government Servants'.</p>

5. Learned P.O. is accordingly informed to seek further instructions ^{Tribunal's orders} as to why G.A.D. G.R. dated 15.05.2019 has been relied upon by 'D.G.P. Maharashtra State,' which is applicable only in cases of 'Inter Establishment Transfers' and not in cases where it is possible to transfer 'Government Servants' such as 'Senior Clerks and Junior Clerks' who are in Group 'C' working under 'D.G.P. Maharashtra State'. The 'D.G.P. Maharashtra State' as the 'Cadre Controlling Authority' can exercise 'Statutory Powers' under 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' read with policy guidelines in G.A.D. G.R. dated 09.04.2018 to transfer such 'Senior Clerks and Junior Clerks' to work on establishment of any (i) 'Commissioners of Police' and (ii) 'Superintendents of Police'.
