- 2. This MA is brought seeking stay to the recovery of the alleged excess amount paid to the applicant.
- I have perused the record and proceedings. The facts to the extent necessary to be set out are that the applicant is a retired medical officer. The respondents alleged that on account of his own misdemeanour excess payment was made to him which is now being recovered from pension. According to the applicant he is getting a pension of Rs.10,212/- while according to the respondents he is getting a take home of Rs.16,974/-. It is not necessary for me to enter any finding about quantum in this MA but if the deductions were not there the applicant would have been getting Rs.42,212/-. The issue of the validity of the deduction is a pivot which the controversy revolves around and in the MA it may not be possible to give any final verdict there about. In any case the applicant has retired and therefore other factors remaining constant there is every necessity to finally dispose off the OA itself. It appears that the affidavit in reply to the amended portion of the OA has not been filed. The respondents are directed to file the same positively without fail within two weeks from today i.e. by 5.4.2016 and rejoinder thereto, if any, should be filed by 12.4.2016. Irrespective of whether the same was file or not filed the OA shall be posted for hearing.
- 4. Thus, the MA is disposed off with a direction that the hearing of the OA is expedited and as an expedited OA it be placed before the appropriate bench for final hearing on 12.4.2016.
