- 3. Learned Advocate for Applicant submits that the impugned order has proceeded on a wrong premise that a period of deputation of Applicant had exceeded 5 years. In support of this submission, reliance is placed on order dated 16.03.2023 (Exb. 'G'). Para 2 of this order states as under:

It was contended that order dated 16.03.2023 was a fresh order of deputation and to this order, the earlier period of service on deputation could not have been tagged. In Reply, the Respondent Nos.1 & 2 have relied on order dated 12.09.2024. This order reads as under:-

- 4. The conjoint consideration of impugned order dated 16.03.2023 and order dated 12.09.2024 primafacie shows that the period of deputation of Applicant had exceeded 5 years.
- 5. Rival submissions will have to be heard at length. In the facts and circumstances of the case, reasonable opportunity is required to be given to Respondents to file Reply. Hence, at this stage, 'interim Order' which would be in the nature of 'Status Quo' cannot be passed, since impugned order has already taken effect.
- 6. Issue notice returnable on 12.11.2024.
- 7. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

- 2. Learned Advocate for Applicant has submitted that in Para No.7 of Judgment in R.A.10/2024, some clarification is necessary by adding word 'not' so as to suggest that the judgments relied upon by the Applicant are not referred in Para No.3 of the Judgment in O.A.101/2024.
- 3. It is further submitted by learned Advocate for Applicant that there is no reference in judgment in R.A. 10/2024 about judgements relied upon by the Applicant while arguing O.A.No.101/2024. It has to be noted that the contention of Applicant about his reliance of judgements of Tribunal and Judgment of the Hon'ble High Court at the time of argument in O.A.No.101/2024 is already mentioned in Para No.3 of R.A.10/2024.
- 4. While passing judgment in O.A.No.101/2024, the Tribunal has specifically mentioned in Para No.3 of the judgment on which Applicant has placed reliance and same fact is mentioned in Para No.7 of the judgment in R.A.10/2024.
- 5. In view of above, there is no need of any clarification. The application for 'Speaking to Minutes' is therefore disposed off accordingly.

There is merit in this submission.
- 4. Learned Advocate for Applicant submitted that it would be appropriate if CSB is directed to reconsider the cases of Applicant as well as Respondent No.5 for transfer afresh. Respondent Nos.1 to 4 have no objection to do so. This statement is made by learned PO on instructions from Mr. Rohidas Khokale, Desk Officer.
- 5. On instructions from Mr. Rohidas Khokale, Desk Officer, learned PO makes a statement that the post of Taluka Agriculture Officer at Ulhasnagar shall be kept vacant till CSB decides question of transfer of Applicant and Respondent No.5 afresh. CSB shall decide this question afresh within two months from today.
- 6. With these directions, OA stands disposed of. No order as to costs.

Today, learned PO has placed on record communication from Department dated 22.10.2024. It states as under:-

- 6. Aforesaid communication dated 22.10.2024 refers to deletion of an e-mail. It is submitted that this Tribunal should take cognizance of such conduct, so that there is no recurrence.
- 7. Presently, the Tribunal is considering the case for grant of 'Interim Order' in the nature of stay to the effect and implementation of the impugned order (Annexure 'A-1').
- 8. It is submitted by learned Advocate for Respondent No.5 that Respondent No.5 has joined on the transferred post on 15.10.2024. I have referred to the fact that on the same post, the Applicant has joined on 14.10.2024.
- 9. In view of aforesaid facts, case is made out to pass 'Interim Order'. The effect and implementation of the impugned order of transfer of Respondent No.5 dated 11.10.2024 (Annexure 'A-1') shall stand stayed till the next date.

### ORDER

- 1. Heard Shri C.T. Chandratre, learned Advocate for Applicant, Smt. K.S. Gaikwad, learned PO for Respondent Nos.1 to 3 and Smt. Punam Mahajan, learned Advocate for Respondent No.4.
- 2. Yesterday, this OA was finally heard by consent at length and closed for orders.
- 3. It is the submission of learned Advocate for Applicant that yesterday, after going through Minutes of Meeting of CSB, certain aspects came to his notice which are required to be argued at length. These points are as under:-
  - (i) Constitution of CSB itself was defective, as only 2 out of 4 persons in the Board put their signature on what is stated to be recommendation of the Board;
  - (ii) In the Column of recommendation with regard to transfer of Respondent No.4, there is only vague mention of approval accorded



- by the Competent Authority, but it is not specified as to who was the Competent Authority to accord such approval;
- (iii) Letter dated 07.08.2024 issued by Hon'ble Minister cannot be treated to be a fresh proposal for reconsidering the order of transfer of Applicant dated 06.08.2024;
- (iv) In the Minutes of Meeting of CSB, there is absolutely nothing in respect of deliberations about need to modify the order of transfer of Applicant dated 06.08.2024.
- 4. Learned PO seeks time to file Reply. Time Granted.
- 5. It is submitted by learned Advocate for Respondent No.4 that when order dated 15.10.2024 was passed, the Respondent-Department and Respondent No.4 were not in a position to resist the prayer of Applicant for passing 'Interim Order', and therefore, question of continuation or otherwise of 'Interim Order' be heard today.
- 6. Accordingly, submissions are heard.
- 7. In order dated 15.10.2024, it was observed as under :-
  - "3. Learned Counsel Mr. Chandratre has submitted that by impugned order dated 11.10.2024, the Applicant who is Deputy Collector and who posted as Regional Officer, Maharashtra Industrial Development Corporation (MIDC), Nashik on 06.08.2024 came to be transferred and posted as Deputy Chief Officer, Shree Sai Baba Sansthan, Shirdi, District Ahmednagar. Learned Counsel has submitted that by order dated 06.08.2024 applicant was transferred from Parner, District Nagar to Regional Officers, MIDC, Applicant could not join as Regional Officer, MIDC, Nashik pursuant to order dated 06.08.2024 because the movement has not been issued by the Secretary, Industry Department, MIDC. On 07.08.2024 (Exhibit A-5) the applicant has made written request to the Principal Secretary, Industry, Mantralaya to let him join his new posting. On 07.08.2024 (Exhibit A-7) Mr. Uday Samant, Hon'ble Cabinet Minister of Industry has given order to Principal Secretary and Additional Chief Secretary (Revenue) that Respondent No.4, Mr. Deepak Santosh Patil is to be posted as Regional Officer, MIDC on deputation. Pursuant to this letter, transfer order dated 11.10.2024 (Exhibit A-1) was issued."
- 8. I have already set out the grounds on which re-hearing of OA was sought and today, matter was heard again.
- 9. As submitted by learned Advocate for Applicant, in Minutes of Meeting of CSB held on 11.10.2024, there is no reference to deliberations held on the point of need to re-consider the transfer order of Applicant dated 06.08.2024. It is further pointed out that though the Board consisted of 4 Members, the meeting appears to have been attended only by 2



Members because below the Minutes, there are signatures of only 2 out of 4 Members. It was submitted that it can be gathered that the issue of need to re-consider the transfer order of Applicant dated 06.08.2024 was not deliberated by CSB in its Meeting dated 11.10.2024. Prima-facie, there appears to be substance in the contentions raised by Applicant that when the matter was placed before the higher authority i.e. Hon'ble Chief Minister, the name of Applicant was inserted in the list and pursuant to such insertion, the Applicant was transferred on deputation by order dated 11.10.2024.

- 10. It is further submitted by learned Advocate for Applicant that letter of Hon'ble Minister dated 07.08.2024 cannot be construed to be a fresh proposal for reconsidering transfer order of Applicant dated 06.08.2024. In Reply, it is submitted by learned PO that in the facts and circumstances of the case, it was not necessary to submit fresh proposal in respect of transfer of Applicant.
- 11. Learned Advocate for Respondent No.4 submitted that after order of his transfer dated 06.08.2024 was passed, the Applicant kept mum for more than 2 months. It is further submitted that Applicant did not join on the post and he is kept in a hanging position. It is further submitted that by virtue of order of 'Status Quo' passed by this Tribunal on 15.10.2024, Respondent No.4 is also kept in a hanging position.
- 12. It is submitted that on 11.10.2024, pursuant to his order of transfer, the Respondent No.4 was relieved on the same day and he remained present before Secretary, Industry, Energy and Labour Department for the purpose of joining on the post to which he is transferred on deputation.
- 13. Arguable points are raised in this OA which are required to be heard at length. Today, prayer of PO seeking time to file Reply is also granted and time is given till 12.11.2024.
- 14. Under the circumstances, I have come to the conclusion that no case is made out to vacate order of 'Status Quo'. 'Status Quo' shall continue fill next date i.e. 12.11.2024.
