Learned C.P.O., as well as, learned Advocate for respondent No. 4 sought to vacate that order. In that

regard, learned C.P.O. submitted that the Government is in process to issue the transfer order of the applicant. Learned Advocate for respondent No. 4 submitted that the respondent No. 4 was without any posting since about a year.

5. Learned Advocate for the applicant submitted that the interim relief granted earlier by this Tribunal be continued contending that even if the order of transfer of the applicant is issued, it will be mid-term transfer order. He further submitted that the applicant is not running away from the fact that his normal tenure of posting is completed.

6. The learned Advocate for respondent No. 4 submitted that the applicant has no right to challenge the order of posting of respondent No. 4 dated 20.09.2022 (Annexure A-5) and therefore, interim order would not be continued.

7. After having considered the rival submissions of all the parties, in my considered opinion, interim order was passed only in the background of the letter dated 21.09.2022 (Annexure A-6) addressed by the respondent No. 4 to the Executive Engineer, Krushna Marathwada Construction Division No. 1, Osmanabad, which post is held by the applicant. Learned Advocate for the respondent No. 4 points out that in the impugned order of posting dated 20.09.2022 (Annexure A-5) it is observed in para No. 5 as follows :-

8. It is however, pertinent to note here that unless the post is vacant, there is no question of relieving and subsequent giving and taking of the charge of the post. In the case in hand, the applicant's transfer order is not yet issued. In view of the same, by the act of insisting for taking charge by the respondent No. 4 may create complications and may result into multiplicity of proceedings. In view of the same, in my considered opinion, it would be just and proper to continue the interim order till next date. It is ordered accordingly.
