5. It shows that the State has not decided the matter before filing of O.A. on 13-09-2019 and till 21-03-2022 and the communication referred to above dated 21-03-2022 does not explain the reason behind not extending the relief to the applicant and respondent nos.4 and 5 if the matter had merit as claimed by the applicant and now as it is being apparently considered by the respondents. Said correspondence does not make such clarification. It is in the interest of justice to call for original record relating to this matter for perusal of the Tribunal to
