2. Since identical issues are raised, both these matters are heard together. It is the contention that both the applicants were duly selected after having undergone the selection process for the post of Forest Guard. The appointment order was issued in favour of the applicant in O.A. No. 386/2024, whereas the applicant in O.A. no. 385/2024 was allowed to resume the duties, though there seems to be no written appointment order in her favour. After their appointments, within few davs appointment orders of these applicants have been

cancelled on the ground that some errors have occurred in interpreting the provisions as about the reserved seats. As is submitted by the learned counsel for the applicants, before cancelling their appointments, the respondents did not issue any show cause notice nor any hearing was given to the In the circumstances, the learned applicants. counsel prayed for an interim relief, thereby staying order the dated 22.3.2024, whereby the appointments of both these applicants have been cancelled.

3. Learned Chief Presenting Officer sought time to file affidavit in reply. He, however, opposed for granting any interim relief stating that it was well within the power of the State Government to rectify the mistake if had occurred while giving the appointments. Learned C.P.O. submitted that a special Committee was constituted after the complaints were received in regard the appointments issued in the matters and the said committee has taken a decision and recommended for cancellation of the appointments of the present applicants. He, therefore, prayed for rejecting the prayer for interim relief.

- 4. We have carefully considered the submissions made on behalf of the applicants, as well as, the State authorities. We have perused the documents filed on record. The applicants were appointed after having successfully undergone the selection process. Undisputedly, the appointments of both these applicants have been cancelled without giving them any opportunity of hearing and even without issuing any show-cause-notice. It is thus evident that the minimum requirement in regard to the principles of natural justice has also not been followed. The applicants have therefore, certainly made out a *prima facie* case.
- 5. As submitted by learned C.P.O. though the special committee was appointed and the said committee has recommended cancellation of the appointments of the applicants, the fact remains that the applicants were not given any opportunity of hearing. In query made by us to the learned C.P.O. whether the revised list of recommended candidates has been prepared and whether the appointments have been issued to the said candidates, the learned C.P.O. submitted that he

has no instructions in that regard. After having considered the facts as aforesaid, we deem it appropriate to pass the following order:-
