2. The learned P.O. has tendered across the bar the affidavit in reply of respondent no. 2. It is taken on record and copy thereof has been supplied to other side.

3. The applicant was dismissed from the service in the year 2014. The applicant thereafter preferred the departmental appeal, which came to be decided in the year 2018. Vide order dated 24.8.2018 the respondent no. 2 rejected the departmental appeal preferred by the applicant. As contended in the application some assurance was given to the applicant for considering the case of the applicant for grant of compassionate pension. The applicant has filed on record some documents in support of his said contention. It is the

contention of the applicant that the respondents however have not considered the case of the applicant as was assured. Hence the applicant is constrained to approach the Tribunal. The learned counsel submitted that in the meanwhile the COVID-19 pandemic started and the applicant was prevented from approaching the Tribunal. The delay occurred in filing the O.A. is of 585 days. The learned counsel submitted that the delay occurred in filing the O.A. is for bona-fide reasons and unintentional. The learned counsel, therefore, prayed for condoning the said delay.

4. The respondents opposed for condoning the delay stating that the reasons as are assigned by the applicant for condoning the said delay are unsatisfactory. It is pointed out that even otherwise also there is no case for the applicant on merit.

5. Though the learned P.O. has opposed the present application and though the delay caused in filing the O.A. is of a bit long period i.e. 585 days, the applicant has sufficiently explained the said delay. It further appears to us that the matters are to be decided on merits and not to be thrown on technicalities at the threshold. We do not see any mala-fide on the part of the applicant in approaching late to this Tribunal. It further appears to us that the applicant needs to be given an opportunity of prosecuting his O.A. on merits. In the circumstances, the following order is passed.

2. It is the grievance of the applicant that with the only object of protecting the interest of and in order to show favour to respondent No. 3 in the present O.A., the applicant has been transferred from the post of Superintending Engineer, Public Works Aurangabad Circle to the post of Superintending Engineer Pradhan Mantri Gram Sadak Yojna, Aurangabad. It is contended that the applicant has hardly completed the period of 9 months on the present post and in the circumstances there is no reason for directing his transfer. Learned counsel has brought to my notice the order, whereby the applicant has been transferred. To buttress his contention that in

order to facilitate the transfer of the respondent No. 3 the applicant has been transferred from the present post, the transfer order of respondent No. 3 is also brought to my notice. According to the learned counsel the grounds mentioned in the order of present applicant's transfer are too vague and the real reason behind his transfer is the intention of respondents to favour respondent No.3.

3. Learned counsel in the circumstances has prayed for staying the effect and operation of the impugned order till decision of the present O.A.

4. Learned C.P.O. submits that today only the impugned order has been passed and unless the instructions are received it may not be possible for him to make any statement as about the reasons for transfer of the present applicant. Learned C.P.O. submitted that time may be granted at least till Tuesday i.e. 26.7.2022 to make a statement after taking instructions from the concerned authorities, as about the reasons for transferring the applicant from the present post.

5. Learned counsel appearing for the applicant has submitted that the applicant has not yet handed over the charge of his post and has requested for passing ad-interim order, thereby staying the effect of the transfer orders, impugned in the present O.A. till then.

6. After having heard the learned counsel appearing for the parties and after having gone through the documents filed on record there appears *prima facie* case in favour of the applicant for protecting his interest temporarily till the next date. Hence, the following order: -

2. The grievance made by the applicant in the present Original Application is that the respondent was under obligation to review the case of the applicant for promotion in view of the Government Resolution dated 15.12.2017. The applicant entered into the service as Assistant Regional Transport Officer and as contended in the O.A., was eligible to be promoted to the post of Deputy Regional Transport Officer. Learned counsel for the applicant submitted that since the applicant was in the zone of consideration for promotion to the said post, in the meeting of Departmental Promotion Committee his case was also considered, however,

since a criminal case has been filed against the applicant and the departmental enquiry has also been initiated against the applicant in the meeting of DPC held on 22.6.2021, a decision was taken to keep the decision in regard to the promotion of the present applicant in sealed cover.

3. The Government Resolution dated 15.12.2017 lays down certain guidelines if the sealed cover procedure has been followed. In the guidelines it has been specifically mentioned that the DPC shall review the decision of keeping the case of the concerned employee in a sealed cover after every six months and ultimately if it is noticed by the DPC that even after completion of two years neither the departmental enquiry has been completed nor the criminal case has been tried by the concerned Court, a conscious decision on the basis of the performance as has been noticed in the sealed cover, further action has to be taken by the DPC.

4. It is the grievance of the applicant that in the DPC meeting held on 22.6.2021 the decision in regard to the applicant was kept in sealed cover, the review was liable to be taken after six months thereafter i.e.

in the month of December, 2021. Till today no such review has been taken.

5. In the affidavit in reply filed by the respondents though they have denied the contention of the applicant in that regard, nothing has been stated in positive terms, whether decision was reviewed by the DPC as provided or prescribed in the G.R. dated 15.12.2017. No such document has also been placed on record by the respondent.

6. In the circumstances, according to us the present O.A. can be disposed of by directing the sole respondent to convey DPC meeting within 15 days from the date of this order and to consider the case of the applicant in light of the G.R. dated 15.12.2017.

7. In view of the above, the present O.A. stands disposed of however, without any order as to costs.
