2. The present Original Application is filed seeking to challenge the impugned order dated 01.09.2021 (Annexure A-8) issued by the respondent No. 2 i.e. the Senior Administrative Officer (Establishment), Agriculture Commissioner, Maharashtra State, Pune-1, thereby directing the applicant to deposit an amount of Rs. 4,78,000/- by exercising the power under rule 8 of the Maharashtra Civil Services (Discipline and Appeal) Rules, 1979. The applicant has retired on superannuation w.e.f. 30.06.2017. The alleged recovery is for the period of 2012-2013. In view of the same, according to the applicant the recovery is impermissible.

3. Pleadings are complete in the present O.A. and the same is fixed for final hearing.

4. During the course of arguments, it transpires that from the pleadings in the O.A. itself it is evident that the impugned order is punitive in nature. In view

of the same, the said order is appealable order before the appellate authority i.e. specified in Rule 18 of the Maharashtra Civil Services (Discipline and Appeal) Rules, 1979.

5. Admittedly, the applicant has filed the present Original Application without exhausting remedy of filing Departmental Appeal. Perusal of the O.A. would nowhere show as to how the O.A. is maintainable under Section 19 of the Administrative Tribunals Act, 1985 without exhausting remedies. In view of the same, prima-facie, it is evident that the present O.A. would not be maintainable, which is filed under Section 19 of the Administrative Tribunals Act, 1985.

6. Learned Advocate for the applicant submitted that the applicant seeks liberty to file the Departmental Appeal and the necessary directions may be issued in that regard. He further submitted that the impugned order is stayed by this Tribunal as per the order dated 14.09.2021 and he sought further extension of the said interim order.

7. Learned Presenting Officer submitted that the appropriate order may be passed for disposal of the present O.A.

8. In the circumstances as above, in my considered opinion, the present Original Application can be disposed of by issuing necessary directions. Hence, the following order :-

ORDER

The Original Application is disposed of in following terms :-

- (A) The applicant is granted liberty to file Departmental Appeal against the impugned order dated 01.09.2021 (Annexure A-8) before the appellate authority in accordance with law within the period of two weeks from today and more particularly according to Rule 21 of the Maharashtra Civil Services (Discipline and Appeal) Rules, 1979 deals with submission of appeal and the competent appellate authority to decide such Departmental Appeal in accordance with law considering the period of pendency of the present O.A. and to decide the same within a period of three months thereafter and to communicate the decision thereof to the applicant in writing within a period of two weeks thereafter.
- (B) If the applicant is aggrieved by such order, he is at liberty to prosecute the remedy in accordance with law.
- (C) Interim relief granted earlier by this Tribunal by order dated 14.09.2021 is extended for two weeks from today.
- (D) There shall be no order as to costs.
