In the present O.A., the Applicant has challenged the impugned transfer order dated 22.07.2019 whereby he has been transferred from Satana to Yeola District, Nashik and in his place Respondent No.2 who is serving at Yeola is posted at Satana. The Applicant has assailed the impugned transfer order contending that he had joined at Satana by order dated 17.06.2019 but again Respondent No.1 by order dated 22.07.2019 abruptly transferred him only to oblige Respondent No.2.
- 3. Learned Counsel for the Applicant contends that the impugned transfer order is in total defiance of Section 4(4)(ii) and 4(5) of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 200S (hereinafter referred to as 'Act 2005) and prayed for interim stay.
- 4. Learned P.O. nas produced a file for the perusal. Perusal of file reveals that in fact Civil Services Board (CSB) has not recommended for the transfer of the Applicant. The matter was placed before CSB for Respondent No.2 and significantly the CSB did not recommend his transfer being not due for transfer. However, the Hon'ble Minister accepted the request of Respondent No.2 and in his place posted the Applicant. As such, ex-facie, the impugned transfer order is passed only to accommodate the Respondent No.2. Absolutely no case is made out as a special case for transfer on 'administrative exigency'. Besides, admittedly there is no approval of next preceding Competent Authority for the transfer as required under Section 6 of the 'Act 2005'.
