- 1. Heard Shri C.T. Chandratre, learned Advocate for the Applicant and Smt. Archana B.K., learned Presenting Officer for the Respondents.
- 2. This O.A. is filed only for direction to the Respondents to complete D.E. within stipulated period so that the Applicant could get his retiral benefits.
- 3. Perusal of record reveals that the Applicant stands retired as Deputy Commissioner (Social Welfare) on 31.01.2020. Before retirement he was subjected to D.E. by issuance of charge-sheet dated 29.09.2015. The Applicant has submitted his Reply and Enquiry Officer who was appointed.
- 4. Shri C.T. Chandratre, learned Advocate for the Applicant submits that in D.E. after appointment of Enquiry Officer no further steps were taken and it is simply pending without any progress.
- 5. Whereas, learned P.O. sought time to take instructions and know status of D.E.
- 6. It is really appalling to note that though D.E. was initiated in 2015 and the Applicant retired on 31.01.2020, till date D.E. is not completed and the Applicant is deprived of getting retiral benefits. Indeed in terms of various Circulars, Departmental Proceeding Manual and decisions rendered by the Tribunal from time to time, D.E. ought to have been completed within six months.

#### Tribunal's orders

- 7. In this behalf by Circular dated 07.04.2018 Government had issued instructions to complete D.E. maximum within six months and where it is not completed in six months extension is required to be obtained from competent authority. It further provides where Departmental Enquiry is pending for more than five years the Government is required to inquire as who is responsible for the delay and should take necessary disciplinary action against the concerned person. Despite all these things it is common phenomenon that Departmental Enquires are kept pending for years together. Needless to mention that pension is not bounty and it is right of retired person which is also recognized as right to property.
- 8. In view above, this O.A. needs to be disposed of by giving suitable directions.
- 9. Learned P.O. is therefore directed to take instructions from the Respondents and appraise the Tribunal on 27.07.2021.
- 10. Hamdast granted.
