1. Heard Shri C.T. Chandratre, learned Advocate for Applicants and Smt. Archana B.K., learned Presenting Officer for Respondents.

2. The 'Group of O.A's' are at the stage of 'Final Hearing' (P.H.).

3. The learned Advocate for Applicants during course of arguments pointed out to certain anomalies in assessment of evidence from documents placed on record by 'Affidavit-in-Reply' filed on 10.10.2023 on behalf of 'Additional DG Prisons and Correctional Services, Maharashtra State, Pune' and specifically drew attention to contents of 'Statements of Convicted & Undertrial Prisoners' of 'Yerwada Central Jail' recorded on 26.06.2023 and 05.07.2023 as only these came to be considered by 'Additional DG, Maharashtra State' Correctional Services, Pune' to issue initial 'Order' dated 30.06.2023. The reports submitted to 'Jail Superintendent' of 'Yerwada Central Jail' by two 'Prison Officers - Grade - II' on 26.06.2024 were also based entirely on 'Statements of Convicted & Undertrial & Prisoners'.

4. The learned Advocate for Applicant mentioned that initial Order dated 30.06.2023 of 'Additional DG Prisons and Correctional Services, Maharashtra State, Pune' was challenged by filing this 'Group of O.A's' and 'Interim Relief' was also granted on 12.07.2023 but with liberty to transfer the Applicants by availing legal course in consonance with law afresh if so desired.

5. The learned Advocate for Applicants contended that Applicants were thereafter transferred by Home Department letter on 21.07.2023 but it was based on report of 'Additional DG Prisons and Correctional Services, Maharashtra State, Pune' which had relied only upon non-credible evidence from 'Statements of Convicted & Undertrial Prisoners'.

6. The learned Advocate for Applicant emphasized that it was pertinent to note that 'Home Department' had transferred Applicants on 21.07.2023 without any 'Application of Mind' as its decision was communicated by routine letter addressed to 'Additional Director General Prison & Correctional Services, Maharashtra State, Pune'. Also the letter issued by Home Department on 21.07.2023 was only an expression of '*ex post facto*' approval to initial Order dated 30.06.2023 of 'Additional Director General Prison Correctional Services, Pune' which had been stayed by 'Interim Relief' granted on 12.07.2023.

7. The learned Advocate for Applicant further contended that Home Department letter dated 21.07.2023 was issued upon exercise in 'Statutory Powers' under 'Rule 4(4)(II)' and 'Rule 4(5)' of the 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005', so formal 'Transfer Orders' of Applicant were required to be issued by 'Home Department'.

8. The learned Advocate for Applicant emphasized that although initial Order dated 30.06.2023 of 'Additional Director General Prison & Correctional Services, Maharashtra State, Pune' mentions about indiscipline on the part of Applicants as principal reason for their 'ad-hoc' shifting which was later confirmed '*ex post facto*' by Home Department letter dated 21.07.2023; yet no action has still been initiated for conduct of 'Disciplinary Proceedings' against Applicants under 'MCS (D & A) Rules 1979'.

9. The detection of 'Unauthorized Objects' inside the 'Yerwada Central Jail' such as (i) Mobile Phones, (ii) Mobile Batteries, & (iii) Mobile Sim Card are undoubtedly serious incidents for which offences were registered under 'Section 42', & 'Section 45' of 'Prisons Act: 1894' and 'Section 120 (b)' and 'Section 188' of 'Indian Penal Code 1860'. Hence; the Additional

'Additional DG, Maharashtra State' 'Correctional Service, Pune' before deciding to act only against Applicants should have undertaken 'Fact Finding Enquiry' at 'Senior Level' preferably by 'DIG West Division Prisons & Correctional Services, Pune'; so as to ascertain as how such 'Unauthorized Objects' could have flagrantly passed through stringent 'Security Protocols' put in place at 'Yerwada Central Jail' which are to be strictly enforced by 'Supervisory Officers' such as (a) Jail Superintendent; (b) Deputy Jail Superintendent and (e) Senior Prison Officers acting under provisions of 'Prisons Act 1894' and 'Maharashtra Prison Manual 1969'.

10. The 'Additional Director General Prison Correctional Services, Pune' by 'Affidavit-in-Sur Rejoinder' filed on 14.02.2024 even admits that some (i) 'Mobile Phones', (ii) 'Mobile Batteries', & (iii) 'Mobile Sim Card' were probably thrown from outside areas just adjacent to 'External Wall' of 'Yerwada Central Jail'. The 'Additional Director General Prison Correctional Services, Pune' also has referred to unsubstantiated suspicious behavior on part of few Applicants as another reason behind issue of initial Order dated 30.06.2024.

11. The 'Fact Finding Enquiry' as has been observed above was required to be instituted under 'DIG West Division Prisons & Correctional Services, Pune' and only upon submission of its report further appropriate action as necessary should have been taken against all found culpable beginning with the 'Jail Superintendent' down hierarchical ladder upto 'Prison Constables' as all were serving together at 'Yerwada Central Jail'. Hence; transfer of Applicants '*prima facie*' appears to have been done in undue haste just to find some scapegoats at level of 'Prison Constables'.

12. The 'Additional DG, Maharashtra State' 'Correctional Service, Pune' has thus acted selectively only against Applicants who are just 'Prison Constables' by immediately shifting them out of 'Yerwada Central Jail'; when no definitive action as was desirable had been concurrently initiated against (a) 'Jail Superintendent, (b) Deputy Jail Superintendent Officer, (c) Sr. Prison Officers as all were posted together at 'Yerwada Central Jail'.

13. The 'Additional DG, Maharashtra State' 'Correctional Service, Pune' is thus directed to forthwith undertake 'Comprehensive Review' to re-determine individual culpability of Applicants by examining evidence such (a) 'Duty Locations' & (b) 'Nature of Duties' etc. during period of about 'Six Months' preceding detection of 'Unauthorized Objects such as (i) Mobile, (ii) Mobile Batteries, & (iii) Mobile Sim Card within premises of 'Yerwada Central Jail'. The 'Comprehensive Review' is to be conducted by referring to provisions of (a) 'Prisons Act 1894' (b) 'Maharashtra Prison Manual 1979' & (c) 'Maharashtra Prison (Staff Function) Rules 1965'. Upon completion of 'Comprehensive Review' which is expected to be done with an 'Open Mind'; the 'Additional Director General Prison Correctional Services, Maharashtra State, Pune' must arrive at unbiased conclusion whether Home Department letter dated 21.06.2023 which had only confirmed initial Order dated 30.06.2023 of 'Additional Director General Prison Correctional Services, Maharashtra State, Pune' to effect transfers of Applicants can still be held as justiciable; notwithstanding the fact that majority of Applicants have since joined at places of new Postings reportedly upon submitting representations of protest to 'Additional DG, Maharashtra State' 'Correctional Service, Pune'.

14. The 'Additional DG, Maharashtra State' 'Correctional Service, Pune' is directed to complete the exercise of 'Comprehensive Review' within about 'Four Weeks' and thereafter inform whether transfers of Applicant effected by Home Department letter dated 21.07.2023 can be proposed to be rescinded and if Applicants can then be reposted back as 'Police Constables' at 'Yerwada Central Jail'.




