Learned Advocate for Applicant thereupon clarifies that by 'Government Order' dated 04.03.2024 of Housing Department the Respondent No.4 had been laterally transferred to 'Deputation Post' of 'Competent Authority 1' only on backdrop of 'Government Order' dated 15.02.2024 of Revenue & Forest Department.
- 4. Learned Advocate for Respondent No.4 thereupon confirms that 'Government Order' dated 01.08.2024 of Housing Department was issued at the request of Respondent No.4 and accordingly upon being laterally transferred again she has now joined on 'Deputation Post' of 'Competent Authority 7' in 'S.R.A. Mumbai'.
- 5. Learned Advocate for Applicant thereupon emphasizes that Applicant has thus continued to serve on 'Deputation Post' of 'Competent Authority-1' in 'S.R.A. Mumbai' on account of 'Interim Relief' granted on 06.03.2024.

Tribunal's orders

- 6. The Applicant had been transferred to 'Deputation Post' of 'Competent Authority-1' in 'S.R.A. Mumbai' by 'Government Order' dated 07.02.2023 of Revenue & Forest Department and 'Government Order' dated 28.02.2023 of 'Housing Department' which infact were principal reasons for grant of 'Interim Relief' to Applicant on 06.03.2024 and permitting Applicant to continue serving on 'Deputation Post' of 'Competent Authority-1' in 'S.R.A. Mumbai'.
- 7. The Applicant thus continued to serve on 'Deputation Post' of 'Competent Authority-1' in 'S.R.A. Mumbai' even though 'Respondent No.4' was transferred to post of 'Competent Authority -1' by 'Government Order' dated 15.02.2024 of Revenue & Forest Department and Government Order dated 04.03.2024 of Housing Department. However Government Order dated 04.03.2024 of Housing Department now stands modified / changed by 'Government Order' dated 01.08.2024 of Housing Department issued at request of Respondent No.4 who is laterally transferred again to post of 'Competent Authority -7' in 'S.R.A. Mumbai'.
- 8. The Applicant therefore to continue serving on 'Deputation Post' of 'Competent Authority-1' in 'S.R.A., Mumbai' as per 'Government Order' dated 07.02.2023 of Revenue & Forest Department and 'Government Order' dated 28.02.2023 of Housing Department.
- 9. The grievances of both Applicant and Respondent No.4 now stand redressed upon issue of 'Government Order' dated 01.08.2024 of Housing Department. Hence nothing survives in this O.A. No. 335/2024. Thus O.A. No. 335/2024 is disposed off. No Order as to Cost.
