Mumbai' by 'Government Order' dated 07.02.2023 of Revenue & Forest Department and 'Government Order' dated 28.02.2023 of 'Housing Department' which infact were principal reasons for grant of 'Interim Relief' to Applicant on 06.03.2024 and permitting Applicant to continue serving on 'Deputation Post' of 'Competent Authority-1' in 'S.R.A. Mumbai'.

7. The Applicant thus continued to serve on 'Deputation Post' of 'Competent Authority-1' in 'S.R.A. Mumbai' even though 'Respondent No.4' was transferred to post of 'Competent Authority -1' by 'Government Order' dated 15.02.2024 of Revenue & Forest Department and Government Order dated 04.03.2024 of Housing Department. Mumbai'.

8. The Applicant therefore to continue serving on 'Deputation Post' of 'Competent Authority-1' in 'S.R.A., Mumbai' as per 'Government Order' dated 07.02.2023 of Revenue & Forest Department and 'Government Order' dated 28.02.2023 of Housing Department.

9. The grievances of both Applicant and Respondent No.4 now stand redressed upon issue of 'Government Order' dated 01.08.2024 of Housing Department. Hence nothing survives in this O.A. No. 335/2024. Thus O.A. No. 335/2024 is disposed off. No Order as to Cost.
