6. Learned Advocate for the Applicant states that Applicant has been transferred from post of 'Executive Engineer, P.W.D., Panvel Division, District Raigad' without any recommendation of 'C.S.B'. Further, its 'Mid-Term' and 'Mid-Tenure' transfer in contravention of the provisions of Section 4(4)(ii) and Section 4(5) of the 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005'.

7. Learned P.O. stated on the basis of 'File Noting' that no 'Interim Relief' be given to Applicant as 'Transfer Order' dated 22.11.2023 has been issued after the recommendation of 'Competent Transferring Authority' and with prior approval of next 'Superior Transferring Authority' and thus was in accordance with the provisions of Section 4(4)(ii) and Section 4 (5) of the 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005'

8. The 'File Notings' of P.W.D. reveal the Respondent No.2 who was on 'Compulsory Waiting Period' was initially proposed to be transferred to the 'Vacant Post' of 'Executive Engineer, P.W.D., Jawhar Division, District Palghar' based on recommendations

Therefore it is established that the Transfer Orders of Applicant were issued on 22.11.2023 is in contravention of the Judgment of Hon'ble Supreme Court of India in (2013) 15 SCC 732 T.S.R. Subramanian and Ors. Vs. Union of India & Ors.. The 'Additional Chief Secretary, P.W.D.' and 'Secretary (Roads), P.W.D.' had more than one occasions re-submitted file with all facts for reconsideration of the 'Hon'ble Minister-in-Charge of P.W.D.' and 'Competent Transferring Authority'. '1' which discloses that 13 Police Constables who were similarly placed like Applicant and were sent for training with Direct Recruits Batch of 2018. In such circumstances, we direct the Home Department to send the Applicant for training in Batch 124 of Direct Recruits which will commence tomorrow and Applicant shall Execute Bond of undergoing 12 Months training, if otherwise eligible.
