We may further note that in the judgment delivered by this Tribunal, the direct appointments of the nominees of the Freedom Fighters are held in violation of the provision under Article 16(1) of the Constitution of India.

5. In the aforesaid circumstances, we direct the respondent no.1 to file affidavit clarifying the stand of the Government in regard to the Circular dated 04-03-1991. We may further wish to refer to Clause-4 in the Government Circular dated 25-10-2005 which reads thus:

4. We have carefully perused the documents filed on record. In the departmental enquiry conducted against the applicant he has been held guilty for the charges leveled against him. Vide memo dated 19.3.2021 the applicant was called upon to submit the say on the point of punishment imposed upon him by the disciplinary authority i.e. the State Government.
