#### COMMONORDER

- 1. All these Misc. Applications are made seeking condonation of delay in filing the accompanying O.As. under Section 19 of the Administrative Tribunals Act, 1985 seeking similar relief of absorption / permanency in the Government service in view of the Government Resolution dated 31.01.1996 and in terms of proposal dated 28.12.2017 forwarded by the respondent No. 4 to the respondent No. 3.
- 2. The cause of action and relief sough for in all these proceedings are similar in nature and therefore, it would be just and convenient to dispose of all these M.As. by a common order.
- 3. The applicants in all the matters are working with the respondent authorities since 1989 on wards till today. In view of the same, they are entitled to get the benefits of permanency in view of the G.R. dated 31.01.1996. Initially they were appointed on the post of Van Majoor on daily wages i.e. Class-IV post. They are discharging duties as Van Majoor since 1989 onwards. However, orders of permanency were not

issued to the applicants. In that respect, the proposal dated 28.12.2017 was submitted by the respondent No. 4 to the respondent No. 3. However, no decision is taken by the respondent No. 3. After waiting for considerable period for the decision on the proposal dated 28.12.2017 as stated above, the applicants through their Advocate sent legal notice dated 10.01.2019 the respondent authorities requested to prepare seniority list of the applicants for giving benefits of permanency in view of the G.R. dated 31.01.1996. The respondents however, neither complied with nor replied the said legal notice. applicants have good case on merits, more particularly in view of the decision of the Hon'ble Apex Court reported in AIR 2008 Supreme Court 2723 in the matter of Ashok Kumar Vs. State of Bihar and Ors., wherein it is held that if there is delay due to pendency of review representation before the State Government, this is sufficient ground for condonation of delay.

4. In the cases in hand, there is delay ranging from 3 months to 34 months in filing the accompanying O.As. The information in this regard is tabulated as under:-

It is stated that there is no deliberate or intentional delay in filing the accompanying O.As. Hence, the present Misc. Applications.

- 5. In all these M.As. the respondents have filed affidavits in reply, thereby they have denied all the adverse contentions raised by the applicants on merit and contended that no sufficient ground has been shown by the applicants for condonation of inordinate delay. Hence, all these M.As. are liable to be dismissed.
- 6. The applicants have filed affidavit in rejoinder, thereby denying the adverse contentions raised in the affidavit in reply filed on behalf of respondents.
- 7. I have heard the arguments advanced by Shri V.G. Pingle, Shri P.M. Shinde with Shri P.B. Jadhav, learned Advocates for the applicants in the respective cases on one hand and Shri N.U. Yadav, learned Presenting Officer for the respondents in all these cases on the other hand.
- 8. After having considered the facts of the cases, it is evident that the applicants are working as Van Majoor since 1989 and are claiming benefits of

permanency / absorption in the Government service as per the G.R. dated 31.01.1996. In this regard, the respondent No. 4 also submitted a proposal dated 28.12.2017 to the respondent No. 3 seeking favourable consideration. However, no decision has been taken by the respondent No. 3 for years together. It appears that the legal notice was sent by the applicants through their Advocate in the year 2019, but in vain.

9. Learned Advocates for the applicants have relied upon the citation of the Hon'ble Apex Court reported in AIR 2008 Supreme Court 2723 in the matter of Ashok Kumar Vs. State of Bihar and Ors. In the said citation case, it is held that the delay of four years caused due to pendency of Review / representation before the State Government was condoned being sufficient cause. In the present cases also it appears that the applicants were hoping for appropriate decision from the respondent No. 3 after being favourable proposal was submitted by the respondent No. 4 on 28.12.2017. On 10.01.2019, the applicants have also sent legal notice through their Advocate to the respondent authorities seeking decision on the pending issue. However, there was no response. In the circumstances as above, it cannot be said that the

delay caused in seeking relief in the O.As. under Section 19 of the Administrative Tribunals Act, 1985 is deliberate or intentional one. Some negligence in not approaching this Tribunal in time can be attributed to the applicants. However, the same cannot be said to gross one, thereby the applicants had nothing to gain. It is a settled principle of law that the expression "sufficient cause" is to be construed liberally. Refusing to condone the delay is likely to defeat the cause of justice at the threshold. In view of the same, in my considered opinion, these are the fit cases to condone the delay. Hence, I proceed to pass following order:-

#### ORDER

- 1. All these M.As. are allowed.
- 2. The delay caused in filing the accompanying Original Applications is hereby condoned.
- 3. Accordingly, the M.As. are disposed of. The Registry is directed to register and number the accompanying O.As. in accordance with law by taking into account other office objection/s, if any.
- 4. No order as to costs.

Learned counsel submitted that interviews are

already held and the Maharashtra Public Service Commission may declare the final list of the candidates to be recommended for their appointments at any time. Learned counsel in the circumstances, has prayed for a direction against the MPSC not to make the final recommendation insofar as the seats reserved for the persons having disability are concerned.

- 3. Learned Presenting Officer submitted that within two weeks the affidavit in reply will be filed by the respondents. He has in the circumstances, opposed for granting any interim relief.

In the circumstances, according to the learned counsel, it cannot be said that there is any delay and in the alternative he submitted that since the applicant was agitating on the administrative side he could not file the O.A. within the stipulated period of limitation.

- 4. Learned Chief Presenting Officer has opposed the application stating that when the O.A. was filed it was admittedly beyond the period of limitation. He submits that delay has not been appropriately explained.
- 5. After having considered the submissions advanced by learned counsel for the applicant and the learned Chief Presenting Officer, it appears to me that the just and sufficient reasons are made out for condoning the delay. Ultimately the matter is required to be decided on merit. Further the delay is not of a longer period, and no mala fides can be attributed on the part of the applicant. Hence, the following order: -

#### ORDER

(i) The present M.A. is allowed. The delay occurred in filing accompanying O.A. is condoned.
