3. It is admitted fact that the Water Conservation Department of Government of Maharashtra had issued G.R. dated 31.5.2017 copy of which is appended at page No. 18 of the paper book. According to para 7(अ) thereof the employees and the Officers of Minor Irrigation (Water Conservation) Department already working in the Department of Water Conservation shall be absorbed in the Department of Water Conservation. The relevant provision being in Marathi is quoted below for accuracy :-

“७. मृद व जलसंधारण विभागाच्या क्षेत्रीय यंत्रणेचा एकूण १६४७९ पदांचा सुधारीत व फेररचित आकृतिबंध मंजूर करण्याच्या प्रस्तावास व त्या अंतर्गत समाविष्ट असलेली जलसंपदा व कृषी विभागाकडील विवरणपत्र - अ मधील तपशीलात दर्शविण्यात आलेली पदे कार्यरत अधिकारी व कर्मचा-यांसह मृद व जलसंधारण विभागाकडे कायमस्वरूपी समोयोजित करण्याच्या खालील प्रस्तावास राज्यमंत्रीमंडळाने मान्यता दिली आहे.

(आ) जिल्हा परिषद यंत्रणेकडील एकूण २९५९ मंजूर पदे समाविष्ट करणे व या पदांमधील जलसंपदा विभागाकडील कार्यकारी अभियंत्यांची ३१ पदे व उप अभियंत्यांची १८९ पदे, जी पदे १९९२ पासून तात्पुरत्या प्रतिनियुक्तीवर आहेत

अशी सर्व पदे कार्यरत अधिकारी व कर्मचा-यासह मृद व जलसंधारण विभागाकडे कायमस्वरूपी समायोजित करण्यात यावीत.”

4. It is submitted that formal order has not been issued by the concerned respondent in compliance of this provision.

5. The learned counsel for the applicant has placed on record copy of another G.R. of the Department of Water Conservation dated 30.7.2021. It is taken on record and the same be appended at page no. 78 onwards in the paper book of the present O.A. It appears that the applicant has been given posting as Sub-Divisional Water Conservation Officer, Soil & Water Conservation Department at Parbhani. The apprehension expressed by the learned counsel is that applicant's posting as Sub Divisional Water Conservation Officer in the Department of Soil & Water Conservation is by way of a stopgap arrangement and not by way of absorption and therefore the grievance of the applicant persists. He also submits that the action has been initiated by the Department of Water Conservation to promote the officers from parent cadre of Soil & Water Conservation Department to fill up the post of Sub-Divisional Water Conservation Officer, which may amount to taking away of right of the applicant about his absorption on the said post.

6. At this juncture, it is necessary to examine the Recruitment Rules for the post of Sub-Divisional Water Conservation Officer and the eligibility of the applicant with the qualification and experience as Sub-Divisional Engineer in Minor Irrigation Department to get absorption on the post of Sub-Divisional Water Conservation Officer. It is also necessary to examine the vires of provisions of para 20 and para 19 of the G.R. dated 31.5.2017 on which the detailed

consultation made and concurrence given by various Departments to various provisions of the said G.R. can be appreciated and legality of administrative decision to delegate the powers of initiating disciplinary actions against Officers absorbed from other Departments under M.C.S. (Discipline & Appeal) Rules, 1979 to the Department of Soil & Water Conservation can be established.

7. The learned CPO has assured to submit affidavit in reply on the points raised in the present OA, as well as, to submit the documents viz. the Recruitment Rules for the post of Sub-Divisional Water Conservation Officer, office record related to consultation and concurrence of various administrative Departments as mentioned in para 20 of the G.R. dated 31.5.2017 and legality of provisions enunciated in para 19 of the said GR applicable thereby granting Department of Soil & Water Conservation power to take disciplinary actions against the officers brought on the establishment of Soil & Water Conservation Department under provisions of M.C.S. (Discipline & Appeal) Rules, 1979. The learned CPO seeks time for above compliance.

8. In the above circumstances, I pass the following order:-

ORDER

1. Issue notice to respondents, returnable on 14-10-2022.
2. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
3. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

4. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

5. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

6. If notice is not collected within 7 days or proof of service is not produced before 3 days of the next date, case shall automatically stand dismissed without further reference to the Tribunal.

7. The interim relief as prayed for by the applicant in para 8(A) of the present O.A. is being granted and it is ordered that the applicant may not be repatriated back to his parent Department till filing of the affidavit in reply by the respondents.

8. S.O. to 14-10-2022.

9. Steno copy and Hamdast is allowed to both parties.

3. It is admitted fact that the Water Conservation Department of Government of Maharashtra had issued G.R. dated 31.5.2017 copy of which is appended at page No. 18 of the paper book. According to para 7(अ) thereof the employees and the Officers of Minor Irrigation (Water Conservation) Department already working in the Department of Water Conservation shall be absorbed in the Department of Water Conservation. The relevant provision being in Marathi is quoted below for accuracy :-

“७. मृद व जलसंधारण विभागाच्या क्षेत्रीय यंत्रणेचा एकूण १६४७९ पदांचा सुधारीत व फेररचित आकृतिबंध मंजूर करण्याच्या प्रस्तावास व त्या अंतर्गत समाविष्ट असलेली जलसंपदा व कृषी विभागाकडील विवरणपत्र - अ मधील तपशीलात दर्शविण्यात आलेली पदे कार्यरत अधिकारी व कर्मचा-यांसह मृद व जलसंधारण विभागाकडे कायमस्वरूपी समोयोजित करण्याच्या खालील प्रस्तावास राज्यमंत्रीमंडळाने मान्यता दिली आहे.

(आ) जिल्हा परिषद यंत्रणेकडील एकूण २९५९ मंजूर पदे समाविष्ट करणे व या पदांमधील जलसंपदा विभागाकडील कार्यकारी अभियंत्यांची ३१ पदे व उप अभियंत्यांची १८९ पदे, जी पदे १९९२ पासून तात्पुरत्या प्रतिनियुक्तीवर आहेत

अशी सर्व पदे कार्यरत अधिकारी व कर्मचा-यासह मृद व जलसंधारण विभागाकडे कायमस्वरूपी समायोजित करण्यात यावीत.”

4. It is submitted that formal order has not been issued by the concerned respondent in compliance of this provision.

5. The learned counsel for the applicant has placed on record copy of another G.R. of the Department of Water Conservation dated 30.7.2021. It is taken on record and the same be appended at page no. 78 onwards in the paper book of the present O.A. It appears that the applicant has been given posting as Sub-Divisional Conservation Officer, Water Conservation Department at Parbhani. The apprehension expressed by the learned counsel is that applicant's posting as Sub Divisional Water Conservation Officer in the Department of Soil & Water Conservation is by way of a stopgap arrangement and not by way of absorption and therefore the grievance of the applicant persists. He also submits that the action has been initiated by the Department of Water Conservation to promote the officers from parent cadre in Soil & Water Conservation Department to fill up the post of Sub-Divisional Water Conservation Officer, which may amount to taking away of right of the applicant about his absorption on the said post.

6. At this juncture, it is necessary to examine the Recruitment Rules for the post of Sub-Divisional Soil Conservation Officer and the eligibility of the applicant with the qualification and experience as Sub-Divisional Engineer in Minor Irrigation Department to get absorption on the post of Sub-Divisional Water Conservation Officer. It is also necessary to examine the vires of provisions of para 20 and para 19 of the G.R. dated 31.5.2017 on which the detailed

consultation made and concurrence given by various Departments to various provisions of the said G.R. can be appreciated and legality of administrative decision to delegate the powers of initiating disciplinary actions against Officers absorbed from other Departments under M.C.S. (Discipline & Appeal) Rules, 1979 to the Department of Soil & Water Conservation can be established.

7. The learned CPO has assured to submit affidavit in reply on the points raised in the present OA, as well as, to submit the documents viz. the Recruitment Rules for the post of Sub-Divisional Water Conservation Officer, office record related to consultation and concurrence of various administrative Departments as mentioned in para 20 of the G.R. dated 31.5.2017 and legality of provisions enunciated in para 19 of the said GR applicable thereby granting Department of Soil & Water Conservation power to take disciplinary actions against the officers brought on the establishment of Soil & Water Conservation Department under provisions of M.C.S. (Discipline & Appeal) Rules, 1979. The learned CPO seeks time for above compliance.

8. In the above circumstances, I pass the following order:-

ORDER

1. Issue notice to respondents, returnable on 14-10-2022.
2. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
3. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

2. Present O.A. is in respect of the advertisement
no.01/2022 issued by Directorate of Vocational
Education and Training, Maharashtra State, Mumbai
for total of 1457 posts to be filled in the recruitment
rules for the respective posts. The post for which the
contention has been raised is Craft Instructor (Turner)
and the applicant belongs to OBC and has applied
from the category of OBC Female. The applicant has
pointed out that as per proviso to clause 8 (paper book
page 60) preference may be given to candidates who
have successfully completed training in the Central
Training Institute for the post of Instructor. Clause 8-
III) along with proviso reads as follows:

“८. शैक्षणिक अर्हता व अनुभव (Educational Qualification & Experience).

III) have practical experience in appropriate trade for a period of not less than four years including the minimum period prescribed for training by the persons possessing the qualification mentioned in sub-clause (a) and (b) (i), (ii) and (iii) of clause (B) of this rule; and for persons possessing the qualification mentioned in sub-clause (b) (iv) of clause (B) (II) of this rule, two years practical experience in appropriate trade after acquiring the qualification in a respective trade in an industry of Government Department or Industrial Undertaking or Commercial concern or Corporation or Board established by Government;

Provided that, preference may be given to candidates who have successfully completed training in the Central Training Institute for the post of Instructor;

Provided further that, the requirement of experience may not be insisted upon in case of persons possessing Diploma in Second Class.”

3. The applicant claims that she meets the requirement of educational qualification and experience as prescribed under clause 8.(b)(iii) of the said advertisement i.e. Trade Certificate in respective Trade awarded by the State Council for Training in Vocational Trades of Maharashtra and has experience in the Trade of Craft Instructor (Turner) for more than 4 years after getting appointed on contractual basis in the year 2011 followed by interim relief granted by this Tribunal in O.A.No.542/2015 (O.A.St.No.1213/2015) dated 21-08-2015, according to which the services of the present applicant were protected until further orders. However, the said O.A. is yet to be finally decided, and therefore, the interim relief continues. The main grievance of the applicant in O.A.No.542/2015 is about regularization of her services in the cadre of Crafts Instructor (Turner) which is yet to be adjudicated.

4. Cause of action in the present O.A. is with respect to proviso 8.(b)(iii) of advertisement no.01/2022 which provides for preference to be given to the candidates who have successfully completed the

course of training of Central Training Institute for the post of Instructor. The applicant has placed a copy of internal communication before office of Joint Director, Vocational Education to Principal, ITI, Dhule dated 28-07-2022 on record at paper book 68 of the paper book by way of evidence that the applicant had applied for certificate for possessing requisite experience for being sponsored for registration for examination of CITS (RPL); however, the same was declined giving grounds which are quoted for ready reference as below (quoted from p.b.p. 68 of O.A.):

“या बाबत पडताळणी केली असता असे दिसून येते की, यापुर्वी संगणता व पुर्नसंलग्नतासाठी निदेशकानी CITS प्रशिक्षण घेतलेले असावे. तथापी प्रशिक्षण पुर्ण नसल्यास सदर निदेशकांचा पदोन्नती साठी विचार करण्यांत येवू नये अशा सूचना असल्यामूळे त्यांना प्रशिक्षणासाठी पुरूसकृत करण्यांत येते. तथापी श्रीमती.शिदि यांची नेमणूक ही ठोक वेतनावर कंत्राटी पध्दतीने असल्याने त्यांना CTS (RPL) Main Exam Sept-2022 च्या Registration साठी Sponsor व अनुभव असणे बाबतचे शिफारस पत्र अदा करता येत नाही.”

5. This aspect has been examined and it is noticed that the applicant had applied in the month of July, 2022 for sponsorship for main examination of

September, 2022 of CTS (RPL) and the advertisement was issued inviting applications for the post of Craft Instructor (Turner) during the period extending from 17-08-2022 to 07-09-2022. Prima facie, it appears that even if the candidates would have been sponsored for registration of Main Examination of September, 2022 CTS (RPL), she would have not been eligible for benefit under proviso 1 of Clause 8(b)(iii) of the advertisement no.01/2022, therefore, this ground does not pass the scrutiny on merit. The applicant may like to submit the details for eligibility for sponsorship and duration of examination of CTS (RPL) during the hearing of the main O.A.

6. In the interest of justice, O.A.No.542/2015 being connected to this matter, be tagged together with this O.A. and may be heard together.

7. Issue notice to the respondents, returnable on 18.11.2022.

8. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
