5. We are informed by learned Advocate for Applicant that Sambhaji A. Patil though he is retired Police Officer had taken 'Sanad' in 2018 and registered as Advocate with 'Bar Council of Maharashtra'.

#### Tribunal's orders

- 6. The learned Advocate for Applicant submits that he has not appeared in other matter except two matters i.e. one in 2020 and other in December, 2023, and therefore, he be allowed to defend the delinquent officer.
