(B) *By allowing this Original Application, kindly quash and set aside the impugned order dated 31.05.2022 issued by the respondent No.2 wherein the present applicant has been reverted on the post of Head Clerk from post of Office Superintendent and sent on deputation from Jalgaon to Osmanabad.*

(C) Pending hearing and final disposal of this original application, kindly grant stay to the impugned order dated 31.05.2022 issued by the respondent No.2 wherein the present applicant has been reverted on the post of Head Clerk from post of Office Superintendent and sent on deputation from Jalgaon to Osmanabad.

(D) Ad-interim relief in terms of prayer clause "C" may kindly be granted in favour of the applicant.

(E) Any other just and equitable relief may kindly be granted in favour of the present applicant."

3. Learned Counsel appearing for the applicant submitted that the order passed by the respondent no.2 on 31-05-2022 is apparently illegal and unsustainable. The request is, therefore, made for setting aside the said order.

4. When the present matter was initially heard, G.R. dated 15-12-2017 was not filed on record. Today, the said G.R. has been filed on record by the learned Counsel for the applicant. Same has been taken on record. I have

carefully gone through the said G.R. In view of the specific provisions made vide the said G.R., it does not appear to me that the prayer made in the present O.A. can be considered by this Tribunal.

5. After having argued the matter for some time, learned Counsel for the applicant also realized that it may not be possible to pursue prayers made in the O.A. In the circumstances, learned Counsel prayed for directing the respondents to complete the enquiry initiated against the applicant expeditiously within stipulated period. Another request was made by the learned Counsel that the applicant be continued at Jalgaon, may be on the demoted post, since he has not yet shifted to the transferred place i.e. at Osmanabad.

6. Since, there were no pleadings in the O.A. in relation to the submissions later on made by the learned Counsel referred to hereinabove, the learned Counsel was directed to file an affidavit in that regard. The affidavit has been accordingly filed and the same is also taken on record.

In the affidavit, request is made for disposing of this O.A. by giving direction to the respondents to complete the enquiry within stipulated period and to retain the applicant at Jalgaon till the said enquiry is completed.

7. Shri M.P.Gude, learned Presenting Officer for the respondents opposed the request so made. Learned P.O. has also placed on record certain documents. Same are also taken on record.

8. On perusal of the documents filed by the learned P.O., it is revealed that similar request was made by the applicant to the Director of AYUSH Sanchalanalay that he shall be retained at Jalgaon, may be on the demoted post till enquiry is completed. However, said request has been rejected by the Director, AYUSH Sanchalanalay and accordingly the applicant has been communicated the said rejection. The aforesaid fact has not been disclosed by the applicant in the O.A. as well as in the affidavit later on filed by him. The applicant must have mentioned these facts in the affidavit which has been today sworn in by him

when similar prayer is made before the Tribunal. This amounts to suppression of material facts, which disentitles the applicant from getting the relief claimed by him. In so far as another request made by him for expediting the enquiry and for completing the same in stipulate period is concerned, I am inclined to accept the said prayer.

9. As has been contended in the O.A., chargesheet has been issued on 08-04-2021 which was received to the applicant on 16-04-2021, period of more than one year has already lapsed. In fact, as per rules framed for conducting the departmental enquiry, the enquiry must have been completed by this time. Thus, there is substance in the request made by the applicant for giving directions to the respondents to complete the enquiry within shortest possible time. As such, without going into the merits of other contentions raised in the O.A. and keeping it open to be agitated by the applicant at the appropriate stage if so required, present O.A. can be disposed of by passing following order:

- (ii) Applicant shall co-operate to complete the enquiry and shall ensure that enquiry proceedings are not delayed at his instance.
