

Applicant prays that Respondents be directed to quash and set aside impugned transfer dated 20.09.2024 qua the Applicant thereby transferring the Applicant from the post of Administrative Officer Pimpri Chinchwad Municipal Council to the post of Assistant Commissioner Panvel Municipal Corporation.

3. Learned Counsel seeks permission to amend the nomenclature of Respondent No.3.

4. Permission granted. Amendment be carried out forthwith and amended copy be served upon the concern.

5. Learned Counsel has submitted that he has served all the Respondents and has filed affidavit of service.

6. Learned Counsel Mr. Dere challenges the impugned transfer order dated 20.09.2024 on the following grounds :

(a) The Applicant had completed three years in Thane District but not on the same post, as Applicant was holding that post since 24.07.2024. Learned Counsel has submitted that on the point of counting the period for due for transfer he relies on the orders dated 26.0.2024 and 28.03.2024 passed by this Tribunal in O.A.No.427/2024, Chetana Kerure Vs. The State of Maharashtra & Ors. and also order dated 04.04.2024 passed by this Tribunal in O.A.No.462/2024, A.S. Raut V/s. The State of Maharashtra & Ors.

(b) Learned Counsel has also placed reliance on the guidelines of Election Commission of India dated 21.12.2023 which were issued for General Elections (Lok Sabha), 2024. He has pointed out to Clause 5.2 of the letter dated 21.12.2023, which states about the officers other than District Officers. He has submitted that the same interpretation is considered by this Tribunal in O.A.No.427/2024 and O.A.No.462/2024. However, by letter dated 18.03.2024 the said guidelines were amended. In the amended guidelines dated 18.03.2024 the interpretation of tenure applicable to the Municipal Corporations i.e., Municipal Commissioners/ Additional and Deputy Commissioners are also covered under the transfer/ posting policy.

(c) Learned Counsel has also placed reliance on the new guidelines dated 31.07.2024 (Exhibit-F) which are now issued for the ensuing General Elections to Legislative Assembly in Maharashtra. He has further submitted that as per the orders in the case of O.A.No.427/2024 and O.A.No.462/2024 the State of Maharashtra has accepted the said interpretation of opting three years at a particular post and not in a particular District. He has submitted that the same issue was involved in O.A.No.427/2024 and O.A.No.462/2024 and therefore the Applicants were excluded for transfer in view of this Assembly Elections. Learned Counsel prays that Applicant should not



be relieved in view of this modified guidelines dated 18.03.2024 as the said guidelines are applicable to the present Applicant as well.

7. Learned P.O. seeks time to file affidavit-in-reply.

8. Learned P.O. is directed to take instructions with regard to Clause 6 (ii) of letter dated 18.03.2024 and make specific statement on this point. Clause 6(ii) reads as under :

*“6. Now, therefore, the Commission conveys displeasure to the Chief Secretary, Government of Maharashtra and directs him to immediately :*

*(i) .....*

*(ii) To transfer all the Municipal Commissioners/ Additional Municipal Commissioners/ Deputy Municipal Commissioners who have served more than 3 years in the present posting and are posted in their home district in the state of Maharashtra.”*

The applicant has applied for the post of Police Constable and challenges the select list dated 18.9.2024 for excluding the name of the applicant in the select list despite being meritorious candidate. She submits that from today medical is going to commence. The applicant belongs to Rajput and he has applied in EWS under Rajput i.e. Open. Ld. Advocate submits that applicant belongs to Rajput however in the SLC which was issued on 25.6.2022 his case is erroneously written Rajput Bhamta instead of Rajput. The name of the sister of the applicant is Kiran Ishwar Patil and her caste is shown as Hindu – Rajput in the SLC issued on 16.6.2016 and similarly the SLC certificate of the father of the applicant Ishwar Omkar Patil was issued on 4.9.1993 and his case was written as Hindu Rajput Bina Magas. She further submits that death certificate of the grandfather Omkar Shahsingh Patil who expired on 13.2.2013 the caste is mentioned as Hindu Rajput. Ld.
