- 3. I find no substance in the submissions made on behalf of the applicants. The applicants are not required to file any documents along with the online application in terms of clause H and Z i.e. the procedure prescribed for online application. The candidate is required to file all the documents, if he succeeds in the written examination. The candidate is thereafter called for verification of documents and as per the time scheduled in the advertisement, the date for verification of documents was 14.01.2024, which would have been the sufficient time for any candidate to obtain the requisite documents.
- 4. So G.R. far said dated 04.08.2010 as (Annexure A-5) is concerned, learned Presenting Officer has rightly pointed out clause No. 6 of terms and conditions of selection process of advertisement dated 01.01.2024 (Annexure A-2), which prescribes that the preference is given to the legal heirs of the Police Patil, if he files an application. In view of the same, there is a sufficient compliance of G.R. dated 04.08.2010. Except these two grounds, no other

grounds are raised by the applicants in the present Original Applications.
