On query about the period from which 'Assistant Town Planner in the office of Assistant Director, Town Planning, Mumbai City Survey

and Land Records Mumbai and Land Acquisition Special Officer No.1, Mumbai City and Mumbai Suburb' has been lying based vacant, on information received from officer present on behalf of 'Urban Development Department' learned P.O. states that it has been lying vacant since 23.06.2022, and 'Additional Charge' had been given to another 'Assistant Town Planner' from office of 'Deputy Director of Town Planning and Valuation, Mumbai'.

- 4. The post of 'Assistant Town Planner in the office of Assistant Director, Town Planning, Mumbai City Survey and Land Records Mumbai and Land Acquisition Special Officer No.1, Mumbai City and Mumbai Suburb' has thus been lying vacant since 23.06.2022. Therefore, for Urban Development Department to mention that it was only for 'Administrative Reasons' that they have now filled-up this post is not borne out by the facts; as evidently no action was initiated to fill it up earlier during 'General Transfer 2023' from amongst those 'Assistant Town Planners' who had completed 'Normal Tenure' of 3 Years as per Section 3 (1) of the 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005'. The ground of 'Administrative Reasons' seems to be propounded selectively by Urban Development Department in the case of Applicant as admittedly there are 16 Vacant Posts of 'Assistant Town Planner' in jurisdiction of 'Deputy Director of Town Planning and Valuation, Mumbai'; but no action whatsoever has been taken to fill them up during 'General Transfers 2023' on similar ground of 'Administrative Reasons' cited in the case of Applicant.
- 5. The Applicant in any case has not completed his 'Normal Tenure' of 3 Years and is also due to retire on 29.02.2024. The provisions of Section 5(1)(a) of 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' provides that in cases of Government Servants who are due for transfers after completion of Normal Tenure of 3 Years, their tenures can be extended if there is less than 1 years for retirement of such Government Servants. Thus, in the case of the Applicant even if he was to retire sometime after 28.02.2024 he would have been eligible to be given One Year extension under Section 5(1)(a).

However, instead Section 4(4)(ii) and Section 4(5) came to be invoked by 'Urban Development Department' to effect the transfer of the Applicant the ground that there were indeed some 'Special Reasons and Exceptional Circumstances' which remain in the realm unknown; as these were not recorded by C.S.B. in its meeting held on 07.11.2023 under the 'Principal Secretary, Urban Development Department'. Further recommendations made by C.S.B. in its meeting held on 07.11.2023 was immediately approved by the 'Principal Secretary, Urban Development Department' in the capacity of 'Competent Transferring Authority' which is in contravention of the provisions of law under the 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' and against the spirit of the order of Hon'ble Supreme Court in (2013) 15 SCC 732 (T.S.R. - 3. Learned Counsel for the Applicants informs that second set in all these matters were filed.
- 4. Learned C.P.O. for the Respondents pointed out that Deputy Director, Directorate of Sports & Youth Services, Pune who cancelled the validation is not made party in the present O.A. She further states that Deputy Director, Sports and Youth Services, Pune is the one who is necessary and proper party.
- 5. We accept the submission made by learned C.P.O. and direct the learned Counsel for the Applicants to make Deputy Director, Directorate of Sports & Youth Services, Pune as party Respondent No.5 in all these Original Applications.
- 6. Learned Counsel for the Applicants seeks permission to amend the O.A.
- 7. Amendment be carried out and amended copy be served on all the Respondents.
- 8. The matter is fixed on 01.12.2023. All Applicants are directed to remain present on 01.12.2023 with their original sports certificates and with all correspondence in respect of their representations.
