Kanakratnam, Additional Director of General of Police (Estt), Shri Atulkumar Kulkarni, Special Inspector of General (Estt), Shri More, Additional Commissioner of Police and A.C.B. Mumbai and Shri Vijay Chavan, Additional Commissioner of Armed Force, Mumbai and except Shri Atulkumar Kulkarni all are retired.
- 8. In view of above, the O.A. needs to be decided on its own merit without Minutes.

The applicant, Medical Superintendent is challenging the order of transfer dated 18.12.2020 transferring him from his present posting as Medical Superintendent, Women's Hospital, Parbhani to Rural Hospital, Pishore, Tal-Kannad, Dist-Aurangabad. The learned counsel for the applicant states that applicant was transferred to Parbhani on 5.8.2017 and hence he was due for transfer.
- 3. The learned counsel for the applicant challenges the order on following grounds:-
- (i) The Respondents have not considered the case of the applicant under Section 7 of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter referred as 'ROT Act 2005' for brevity) ROT Act, as the applicant is going to retire in June, 2021.
- (ii) The Respondents have not followed the provisions section 4(4)(ii) & 4(5) of the ROT Act, 2005.
- (iii) The meeting of the Civil Services Board was not held and his name was not placed before the Civil Services Board.
- (vi) In the present case, the Hon'ble Chief Minister is the competent transferring authority. However, his approval is not obtained.
- (vii) Learned counsel further submits that till today nobody is posted in place of the applicant.
- 4. Learned P.O while opposing the application submits that the case of the applicant was placed before

the Civil Services Board and all necessary procedure was followed. The reason for transferring the applicant recorded in the minutes of the meeting of C.S.B is the complaint against him. Learned P.O submitted that the applicant is already relieved and the charge of his post is given to Dr Puri, Superintendent, Parbhani.

As the matter is heard by Video Conference, the file of the transfer of the applicant is produced by the officers from the Public Health Department, Mantralaya, Mumbai and Ms Archana B.K, learned P.O has attended the matter, who pointed out that there was a complaint by Ex. M.L.A that he has received complaints against the applicant from the people and patients.

On query made to learned P.O, about consideration of Section 5 of ROT Act, 2005, it is informed that nothing is mentioned about it in the minutes of the meeting of the Civil Services Board. The complaints made by the people or the patients were also not placed before the competent transferring authority. Civil Services Board and nor before the supervising authority, i.e. Dy. Director, Public Health.

In view of the judgment of Hon. Bombay High Court, dated 16.12.2020, in Dr. Saudamini Chaudhari Vs. State of Maharashtra, W.P 2585/2019, where the issue of transfer of a Medical Officer was considered by the Frist Court and especially in para 22 of the said judgment, the affidavit in reply of the Respondent is invited along with the papers of C.S.B and noting of the transfer of the applicant with a view to find out whether proper consideration of the complaints of the people or patient was taken into account at the time of transfer of the applicant.

8. The post of the applicant at Parbhani is still now vacant. Therefore, though applicant is relieved, he is directed to continue to work at Parbhani. Hence the said order of transfer is stayed till filing of the reply. The matter can be decided at the interim stage after receiving the affidavit in reply.

- 2. Learned counsel submits that he has served notice on all the Respondents, i.e. Contemnors. The order in issue was passed on 9.1.2020, thereby directing the Respondents to release the retiral benefits to the applicant within a week from the date of the order, i.e. on or before approximately 17.1.2020. Till today, the amount is not paid and hence this is contempt. As per the said order, the Respondents were saddled cost of Rs. 10,000/-.
- Learned P.O submits that cost of Rs. 10,000/- is deposited and receipt is placed on record. Learned further submits that the file was sent to Law & Judiciary in the month of January, 2020 for the opinion as the applicant was dismissed from service on account of corruption charges. He was dismissed on the ground of charges of corruption and prosecuted under Prevention of Corruption Act. Learned Sessions judge had convicted However, his appeal was allowed and he was acquitted. Learned P.O submits that the opinion of Law & Judiciary so also opinion of MPSC is required before disbursing the retiral benefits to the applicant. Learned P.O further submits that on 15.12.2020, the department has received the opinion from Law & Judiciary wherein permission is given for cancellation of dismissal order of the applicant. Now this file will be sent to MPSC for their

opinion and thereafter the order can be complied with. Learned P.O submits that there is no deliberate disobedience on the part of the Respondents and therefore the delay caused to be condoned. She further submits that within one month MSPC will give their opinion.

- 4. In view of the submissions of learned P.O, the time for compliance of the order of this Tribunal is extended till 20 2.2021. In the meanwhile, MPSC shall give opinion on or before 20.1.2021.
