- 2. Father of the applicant No. 2 i.e. applicant No. 1 was working as Sweeper on the establishment of respondent No. 4. He took voluntary retirement on 31st May, 2021. Thereafter applicant No. 2 made an application seeking appointment in place of her father on the basis of the recommendations of the Lad Page Committee. The request of applicant No. 2 has been rejected by respondent No. 2 vide its communication dated 5.10.2021 on the ground that since she is not belonging to any of the Scheduled Castes, the recommendations made by the Lad Page Committee would not apply in her case.
- 3. Learned counsel for the applicants submitted that in O.A. No. 334/2019 (Goroba Ram Aaradwad & Anr.

Vs. State of Maharashtra and Ors.) decided by this Tribunal on 3.9.2021 on the similar ground the request of the applicants therein was rejected by the respondents therein. Learned counsel brought to my notice that the applicants in the said mater were not belonging to or falling in any of the reserved class and that was the reason that their request was rejected by respondents therein. Learned counsel further brought to my notice that while allowing the said application this Tribunal has held that the appointment to the applicants on the basis of the recommendations of Lad Page Committee could not have been refused on the ground that the applicants were not belonging to any of the reserved class and directed the respondents therein to appoint the applicants therein on the post of Sweeper, in view of the recommendations of Lad Page Committee.

4. Learned counsel submitted that applicant No. 2 stands at par with the applicants in the aforesaid OA. Learned counsel further submitted that the aforesaid decision rendered by this Tribunal has been implemented by the respondents concerned and the appointment has been accordingly issued in favour of the said applicants.

- 5. Learned Presenting Officer reiterated the contentions raised in the affidavit in reply filed on behalf of the respondents. In the affidavit in reply the respondents have taken the same stand that since applicant No. 2 does not belong to any of the Scheduled Castes she was not qualified to be considered for appointment under the recommendations of Lad Page Committee.
- 6. I have carefully gone through the judgment delivered by this Tribunal in O.A. No. 334/2019. I deem it appropriate to reproduce paragraph Nos. 10 & 11 of the said judgment, which read thus: -
  - "10. Considering the rival facts on record, I have to analyse the facts of the present case in the background of original Lad-Page scheme, which deals with appointment on compassionate ground and continuation of said scheme by the Government by issuing Notifications dated 21.10.2011 (Exhibit-page 14 of paper book), 26.2.2014 (Exhibit - B page 18 of paper book) and G.R. dated 11.3.2016 (Exhibit - C page 22 of paper book). Above said Notifications and G.R. were issued by the respondent no. 1. Perusal of first two notifications would show that the scope of beneficiaries for appointment on compassionate ground is, in fact, extended and broadened and hurdles faced in appointing such persons are sought to be removed. In the background of above said Notifications, if G.R. dated 11.3.2016 (Exhibit - C page 22 of paper book) is considered, the benefits are summarized in clause (03) of the said G.R. dated

11.3.2016 (Exhibit – C page 22 of paper book), which reads as under:-

- "३. लाड सिमतीच्या शिफारशी नुसार सफाई कामगारांच्या वारसाांना शासकीय / निमशासकीय सेवेत देण्यात येणा-या नियुक्ती संदर्भात पुनर्विचार करून संदर्भीय दिनांक १०.११.२०१५ रोजीचा शासनिर्णय रद्द करून सुधारीत निर्णय खालीलप्रमाणे घेण्यात येत आहे :-
- 9) वाल्मिकी, मेहंतर समाजाला सामाजिक, आर्थिक संरक्षण देण्यासाठी सफाई कामगारांच्या नियुक्तीबाबत लाड समितीने शिफारस केलेली वारसा पध्दत पुढे चालू ठेवण्यात यावी.
- २) लाड समितीच्या शिफारशी जरी ४० वर्षापूर्वी लागू केल्या असल्या तरी सद्यःस्थितीत सदर शिफारशी चालू ठेवणे आवश्यक आहे. त्यानुसार शासन परिपत्रक, सामाजिक न्याय व विशेष सहाय्य विभाग कं. सफाई २०१४/प्र.कं.०७/महामंडळे दि. २६ फेब्रुवारी २०१४ अन्वये घेण्यात आलेली भूमिका कायम ठेवण्यात यावी.
- ३) सफाई कर्मचारी म्हणून सेवानिवृत्त झालेल्या किंवा होणा-या अथवा खेळानिवृत्ती घेणा-या किंवा सेवेत असतांना निधन पावलेल्या अनुसूचित जातीमधील इतर सफाई कर्मचा-यांच्या वारस किंवा नातेवाईक यांस सदर योजनेचा लाभ देण्यात यावा."
- 11. In my considered opinion, in order to understand the real purport of the G.R. dated 11.3.2016, the clauses thereof are to be read conjointly and harmoniously. Clauses (01) and (02) thereof lay down that the scheme for compassionate appointment propagated by the Lad-Page Committee is to be extended further confirming the earlier Notification dated 26.2.2014 (Exhibit - B page 18 of paper book). The Notification dated 26.2.2014 speaks appointment on compassionate ground to the legal representatives or closed relative irrespective of the Caste / Religion. Clauses (01) and (03) which speak about extending of said benefits to the persons belonging to Walmiki or Mehetar community and S.C. category do not take away the rights of persons belonging to other Religion or caste, whose rights are

recognized by earlier Notifications dated 21.10.2011 (Exhibit – A page 14 of paper book) and 26.2.2014 (Exhibit – B page 18 of 10 O.A. NO. 334/2019 paper book). As per the clause (04) of the G.R. dated 11.3.2016 (Exhibit – C page 22 of paper book) the said benefits or said scheme is made applicable to the legal representatives of Sweeper working in all the Departments."

7. In view of the findings recorded by this Tribunal as above, the decision communicated by respondent No. 2 thereby rejecting request of applicant No. 2 to appoint her giving the benefit of the recommendations of Lad Page Committee on the ground that she does not belong to any of the Scheduled Castes, cannot be sustained and deserves to be set aside. In the result, the following order is passed: -

#### ORDER

(i) The respondents are directed to consider the case of applicant No. 2 for her appointment in place of applicant No. 1 by giving the benefits of recommendations of Lad Page Committee on the post of Sweeper, if there is no other legal impediment, within the period of 12 weeks from the date of this order.

- 5. The record reveals that the applicant in O.A. No. 679/2022 has been placed under suspension vide order dated 20.7.2022 passed by the District Collector, Dhule, respondent No. 1 in the said O.A., whereas the applicant in O.A. No. 680/2022 has been suspended by the Sub-Divisional Officer, Shirpur, who is respondent No. 2 in the said O.A. on 22.7.2022. Learned P.O. has not controverted the fact asserted by the learned counsel for the applicants that till date no review has been taken of the aforesaid orders by the competent authority.
- 6. Admittedly, the period of more than 90 days has lapsed after the suspension has been ordered of both these applicants. In the circumstances, in view of law laid down in the case of Ajay Kumar Choudhary Vs. Union of India through its Secretary and Anr., Civil Appeal No. 1912/2015, arising out of SLP(C) No. 31761/2013 by the Hon'ble Apex Court, it was incumbent on the part of the respondents to review the orders of suspension within a period of 90 days.
- 7. In the circumstances as noted hereinabove I deem it appropriate to dispose of both these OAs with the following order: -

## ORDER

- (i) The competent Review Committee shall review the order of suspension passed on 20.7.2022 in O.A. No. 679/2022 and the order of suspension passed on 22.7.2022 in O.A. No. 680/2022 within 4 weeks from the date of this order.
- (ii) Both these OAs stand disposed of with the directions as aforesaid. There shall be no order as to costs.
