3. Learned P.O. seeks time to submit response and also points out that private parties have been named in M.A. Learned P.O. has further submitted that as per his information meeting of DPC has not been scheduled as yet.

4. It is being considered in view of the fact that meeting of the DPC and recommendations made by same do not attain finality unless the same is accepted by the appointing authority, therefore, there appears merit in the submissions made by the learned P.O. that he may be granted some more time for filing reply. However, at the same time it is necessary to protect the interest of the applicant. Therefore, considering the balance of convenience of both sides and public interest at large, the process of finalizing list of employees in the zone of consideration, holding meeting of DPC, getting its recommendations, internal scrutiny etc. may be continued. However, final order of promotion shall not be issued without filing affidavit in reply in the matter and until the Tribunal has taken cognizance of the affidavit in reply that may be filed by the respondents.

5. With these observations, M.A.No.396/2021 stands disposed of with no order as to costs.
