#### ORDER

1. Heard Shri A. V. Bandiwadekar, the learned Advocate for the Applicant and Ms S. P. Manchekar, the learned Chief Presenting Officer for the Respondents 1 & 3. Shri D. B. Khaire, learned Advocate for Respondent No.2.

## Admitted facts of the case are us under :-

2. Shri K. V. Patil was working as Assistant Commissioner of Police, Turbhe Division. The impugned order (Exb.-'A', page 33) states that he was transferred because of the improper supervision as well as harassment caused to one private person named as Suresh Jain.

3. The impugned order transferred him as ACP, Control Room, Navi Mumbai and the private respondent no.2, Shri Amol Zende, ACP was posted in his place.

4. The Petitioner vide Exb. D', page 40 of the O.A. was posted by the Commissioner of Police, Navi Mumbai to Turbhe Division on temporary basis as Dhanaraj Dayma, A.C.P. Turbhe was on medical leave.

5. Meanwhile, the petitioner numely Kiran Patil, A.C.P. has been transferred by the Government by Home Department on 20.06.2018 as ACP, Mumbai. In persuit of the same, the D.G.P. Maharashtra has issued an orders to relieve him on 22.06.2018. The same is marked as 'X' and 'X1" for the purpose of identification.

6. Accordingly, the Commissioner of Police, Navi Mumbai has relieved him on 22.06.2018. the impugned order of his transfer from Turbhe has been challenged by the Advocate of the Petitioner on the following grounds:-

- a) The Advocate for the Petitioner pertains that the Commissioner of Police has no authority to transfer the Applicant from Turbhe Division to Control Room. (Para 4(1) of the written argument)
- b) Internal transfer is also governed by the provision of Police Act particularly Section 22 (D) of the said Act. (Para 4(2) of the written argument)
- c) The PEB at Commissionarate level, which proposed the transfer which was constituted and proposed transfer was defective as it was not in compliance of Section 22(I). (Para 4(3) of the written argument)
- d) The transfer order is punitive order as it is issued without holding any inquiry for the misconduct mentioned in the impugned order. (Para No.6.17 and 6.18, page 11 & 12 of the OA).

7. According to the learned Advocate for the Petitioner, Section 22(D) of the Maharashtra Police Act, the power of transfer pertains to DYSP and ACP are with PEB No.1.

8. Learned Advocate for the Applicant draws attention to Section 22(I) of the said Act and states that this provision pertains to transfer and posting of Police Officer of the rank of PSI to PI within Commissionarate. He, therefore, says that the Commissioner of Police has no authority to issue the impugned order.

9. Learned Advocate for the Applicant points out that the word 'transfer' or posting has not been defined under Section 2 of the said Act. According to him, therefore, only PEB -1 has authority to recommend the transfer of DYSP.

10. Learned Advocate for the Letitioner contents that tenure of the ACP at one place should be of two years. In case, he is transferred, the same should be transferred from the PEB-I. Learned Advocate states that the Maharashtra Police Act has amended on 16.02 2015 and it has a provision of posting at one place under Section 22(N)(1) and Section 22(D). He mentions that earlier this did not exist in the R.O.T. Act, 2005.

11. Learned Advocate for the Applicant, therefore, contends that the earlier judgment given by the Bombay High Court as well as by this Tribunal regarding the same are no longer applicable. He further contends that the judgment given by the Hon'ble High Court in W.P.No.202 of 2018 dated 07.03.2018 (page 271) has set aside the decision of the Tribunal in O.A. No.404 of 2017 decided on 20.12.2017.
