2. When the present matter is taken up for consideration, learned CPO has tendered across the bar following two documents, which are taken on record, (i) appointment order dated 13-09-2019 issued in favour of 3 officers, and (ii) another order of the same date ordering promotion of 10 officers. Vide these two orders all 3 applicants are stated to have been promoted to the post of Tahsildar. Learned CPO submits that by these orders promotions are effected by following due procedure of law and taking into consideration the merits of the candidates. It is further submitted by the learned CPO that after the promotion orders were passed in 2019 till date these orders have not been objected to by any other candidate/employee. In the circumstances, learned CPO has submitted for disposing of the present O.A.,

purpose being satisfied of the applicants in filing the present O.A.

3. Shri A.S.Deshmukh, learned Counsel appearing for the applicants submits that the promotion orders are issued subject to the decision of the present O.A.

4. In view of the submissions made by the learned CPO, it is quite evident that without there being any interim order, the respondents at their own have granted promotions to the present applicants. More importantly, as submitted by the learned CPO the promotions are granted to the applicants on merits and having regard to their seniority. Significantly, the promotions granted in favour of the applicants in the year 2019 have not been challenged till this date, as has been further submitted by the learned CPO.

5. In the above circumstances, holding that the grievance raised by the applicants in the present O.A. has been redressed by the respondents on their own, we deem it appropriate to dispose of the present O.A. It does not appear to us that the disposal of the present O.A. will have any adverse effect on the promotions granted in favour of the applicants. Hence, the following order:
