2. All these matters are taken up for consideration. Learned C.P.O. tendered G.R. dated 16-09-2024 issued by the General Administration Department of the State. Vide the said G.R. the Government has cancelled the G.R. dated

28.08.2024. We deem it appropriate to reproduce the text of the said G.R. which reads thus:

“प्रस्तावना:-

स्वातंत्र्य सैनिकांना/त्यांचे नामनिर्देशित यांना शासकीय सेवेत महाराष्ट्र लोकसेवा आयोगाच्या कक्षबाहेरील वर्ग-३ व वर्ग-४ च्या पदावर नियुक्ती देण्याच्या अनुषंगाने शासनाने काही सवलती दिल्या आहेत. स्वातंत्र्य सैनिकांना/त्यांचे नामनिर्देशित यांना शासकीय सेवेत नियुक्ती देण्याच्या अनुषंगाने शासन स्तरावरून वेळोवेळी शासन निर्णय/शासन परिपत्रक/ निर्देश निर्गमित करण्यात आले आहेत. स्वातंत्र्य सैनिकांना/त्यांचे नामनिर्देशित यांना शासकीय सेवेत नियुक्ती देण्याच्या अनुषंगाने सदर शासन निर्णय / शासन परिपत्रक/ निर्देशांचे पालन होत नसल्याची बाब शासनाच्या निदर्शनास आली आहे. सदरची वस्तुस्थिती विचारात घेवून, सामान्य प्रशासन विभाग, शासन परिपत्रक क्रमांक: सीएनएस- १०८७/४९९/के.नं. १२/१६-अ, दिनांक ०४ मार्च, १९९१ मधील तरतुदी रद्द करण्याचा व ज्या स्वातंत्र्य सैनिकांच्या पाल्यांची विहित कार्यपद्धती अनुसरून व विहित मार्गाने नियुक्ती झालेली नाही (थेट नियुक्ती झालेली आहे) अशा कर्मचा-यांच्या सेवा समाप्त करण्याच्या अनुषंगाने नियुक्ती प्राधिकारी यांनी कार्यवाही करावी, अशा प्रकारचा निर्णय संदर्भाधीन दिनांक २८ ऑगस्ट, २०२४ च्या शासन निर्णयान्वये घेण्यात आला आहे.

२. संदर्भाधीन दिनांक २८ ऑगस्ट, २०२४ च्या शासन निर्णयाविरोधात संबंधित कर्मचारी/अधिकारी यांनी मा. महाराष्ट्र प्रशासकीय न्यायाधिकरण मुंबई तसेच खंडपीठ नागपूर/औरंगाबाद

येथे मोठ्या प्रमाणात याचिका दाखल केल्या आहेत. सदर याचिका अॅडमीट करून घेताना मा. महाराष्ट्र प्रशासकीय न्यायाधिकरणाने संबधित कर्मचारी/अधिकारी यांच्याविरुद्ध जबरदस्तीने कारवाई करण्यात येवू नये, असे शासनास निर्देश देवून पुढील सुनावणीची तारीख निश्चित केली आहे. तसेच, मा. लोकप्रतिनिधी यांनी देखील दिनांक २८ ऑगस्ट, २०२४ रद्द करण्याच्या अनुषंगाने शासनाकडे निवेदने सादर केली आहेत. उपरोक्त वस्तुस्थिती विचारात घेता, संदर्भाधीन दिनांक २८ ऑगस्ट, २०२४ च्या शासन निर्णयाच्या अनुषंगाने संबधित नियुक्ती प्राधिकारी यांच्याकडून वस्तुस्थितीदर्शक माहिती प्राप्त करून घेवून, स्वातंत्र्य सैनिकांना/त्यांचे नामनिर्देशित यांना शासकीय सेवेत महाराष्ट्र लोकसेवा आयोगाच्या कक्षेबाहेरील वर्ग-३ व वर्ग-४ च्या पदावर नियुक्ती देण्याच्या अनुषंगाने सर्व समावेशक मार्गदर्शक सूचना देण्याकरिता काही कालावधी लागणार असल्याने, तोपर्यंत संदर्भाधीन दिनांक २८ ऑगस्ट, २०२४ चा शासन निर्णय रद्द करण्याची बाब शासनाच्या विचाराधीन होती.

3. In all these O.As. the applicants have prayed for quashment of the G.R. dated 28-08-2024 and the consequential actions taken on the strength of the said G.R. In view of the fact that the said G.R. dated 28-08-2024 has now been cancelled by the State Government vide subsequent G.R. issued on 16-09-2024 which we have reproduced hereinabove, all these O.As. and T.As. have become infructuous and hence stand disposed of without any order as to costs.

4. Needless to state that, in the event any fresh order is passed by the respondents as indicated in the G.R. dated 16-09-2024 and if the applicants find it detrimental to their interest they are not precluded from approaching this Tribunal in that contingency. M.As., if any, also stand disposed of. No costs.
