The information as is revealing from the said list reveals that the applicant, as well as, respondent no. 3 both belong to NT-D category. The date of birth of the applicant is 9.5.1989, whereas the date of birth of respondent no. 3 is 23.4.1990. The applicant has passed LLM examination, whereas respondent no. 3 is not having any extra qualification. Both have secured total marks as '117'. Learned counsel then invited our attention to the general instructions issued and more particularly clause 6.5.1 thereof, which provides the methodology to be adopted in case of the candidates securing similar marks. Clause 6.5.1.1 pertains to educational qualification, whereas sub-clause 6 thereof pertains to age. Considering both these criterias apparently the applicant appears having a better claim, however, MPSC has recommended the name of respondent no. 3.

4. Learned CPO has sought time to take instructions to file affidavit in reply. We have noted that record apparently reveals that the applicant may have better claim. In the circumstances, we deem it appropriate to pass the following order :- ::-3-::

4. After having considered the submissions as aforesaid and after having gone through the documents placed on record, we are convinced that the applicant has filed the present Original Application well within the period of limitation. The office objection, therefore, stands overruled.

5. Learned counsel for the applicant has sought leave to place on record certain documents pertaining to the marks received by the applicant. Leave granted. The documents be accepted.

6. The applicant has applied for the promotional post of Deputy Education Officer, which is to be filled in by

The contents of the communication dated 23.10.2023 reveal that the candidates, who have secured 150 marks only, were called for interview on 26th & 27th July, 2023 and since the applicants have received less than 150 marks they have not been called for interview. However, as we noted above the provisional general merit list demonstrates that the candidates having received less than 150 marks were also called for interview.

5. Having considered the fact as aforesaid, there appears *prima facie* case in favour of the applicants. The Principal Seat of this Tribunal at Mumbai, as well as, this Tribunal had in some previous matters directed the MPSC to hold the interview of the candidates concerned. Accordingly interviews were taken on the subsequent dates, however, the present applicants have approached late. Though delay has been condoned, by that time the dates of interview have already gone. In the circumstances, presently we are not inclined to give any direction for calling the present applicants for the However, it is clarified that we have not interview. turned down the request made by the applicants seeking interim relief thereby directing the respondents to interview the present applicants. After filing of the affidavit in reply by the respondents, the facts and circumstances can be finally reviewed and if required the necessary orders will be passed. In the circumstances, it is further clarified that in the meanwhile if list of selected candidates is published and accordingly appointment orders are issued, all the said processes will be subject to outcome of the present O.A.

6. Issue notice to respondents, returnable on 1.11.2023.

7. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

8. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

9. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

10. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

11. S.O. to 1.11.2023.

2. Learned counsel for the applicant submits that in the present matter initially applicant Nos. 2 to 9 were given appointment on supernumerary posts by G.R. dated 31.01.2023. In the circumstances, vide order passed on 30.03.2023, the present O.A. was held to have been disposed of as infructuous insofar as applicant Nos. 2 to 9 are concerned. Thereafter only applicant No. 1 continued with the present matter. Learned counsel submitted that now the applicant No. 1 has also been given appointment order on the basis of the same G.R. dated 31.01.2023. Learned counsel in the circumstances prayed for disposing of the present Original Application being infructuous.

3. In view of the submissions made as above, the present Original Application stands disposed of being infructuous. No order as to costs.

2. The applicant has filed the present Original Application with a request for finalizing Departmental Enquires pending against him.

3. Learned counsel appearing for the applicant submitted that though the applicant retired in the year 2019 on attaining the age of superannuation, even thereafter the D.Es. against him are not concluded and are still going on. Learned counsel further submitted that because of the D.Es. pending against the applicant, he is being deprived of the pension and the pensionary benefits. Learned counsel in the circumstances has prayed for disposing of present Original Application by giving direction to the respondents to complete enquiries pending against the applicant within time bound manner.

4. Learned Presenting Officer submits that total 5 enquires were pending against the applicant, out of which one has been completed.

5. Learned counsel for the applicant submitted that according to his information two enquires are completed. Whatever may be the case, it cannot be disputed that enquires are to be completed as expeditiously as possible. In the present matter, admittedly 4 years have passed after retirement of the applicant. We therefore, see justification in the request made by the applicant for giving direction to the respondents to complete the Departmental Enquiries pending against him by stipulating the time therefor.

6. Learned P.O. does not have objection for passing such order.

7. In view of above, without going into the merits of contentions raised in the O.A., we deem it appropriate to dispose of this Original Application with the following order :-

- Respondents are directed to complete the Departmental Enquires pending against the applicant in all respect within 4 months from the date of this order.

2. Learned Counsel for applicants in M.A.No.216/2023 and M.A.No.217/2023 are heard on the point of intervention.

3. In the O.A. the applicants being aggrieved by the new Rules brought into effect for promotion to the post of Deputy Education Officer have obtained the ex-parte stay to the implementation of the new rules.

4. Interveners are working on the post of Extension Officer (Education), Administrative Officer, Assistant Deputy Education Inspector, =2= M.A.NO.216/2023 & Ors. which are made eligible for promotion to the post of Education Officer and the post on which the applicants in O.A.No.227/2023 are working though have been excluded in the new rules, it is the contention of the interveners that because of the interim stay granted in the O.A. their promotions are withheld. It is their further contention that they are having every right to oppose the contentions raised in the O.A. and to contest the petition.

5. Having regard to the contentions in the intervention applications, we are satisfied that the interveners fall in the category of aggrieved persons and hence we are inclined to allow their intervention applications. Hence, the following order:

[i] M.A.No.216/2023 & M.A.No.217/2023 for intervention are allowed.

[ii] Applicants to add interveners as party respondents in the O.A.

[iii] It would be open for the added respondents to file their affidavit in reply till next date.

6. S.O. to 02-11-2023 in other M.As. & O.A.

2. Applicant has preferred the present O.A. seeking following reliefs:

"B) To direct the respondents to consider the period of service rendered by the applicant since 17/10/1979 to 16/04/1997 as mustering assistant as qualifying period of fixation of pension and re-fix the pension to applicant and release the benefits of the revised pension since date of retirement, within stipulated time.

C) Pending hearing final disposal of the original application the respondents be directed to calculate the pension of the applicant by considering his qualifying service from 18/06/1984 to 30/04/2009 and release the benefits of the pension since date of retirement, within stipulated time."

3. The applicant has preferred the present M.A. seeking condonation of delay which has occasioned in filing the O.A. The delay as has been contended in the application is of the period more than 9 years. We deem it appropriate to reproduce the reasons as are stated in paragraphs 3, 4 and 5 of the said application as it is, which read thus:

"3. That, applicant came to be joined as mustering assistant on 17.10.1979 and thereafter as per policy of the state absorbed in the state services on 31.3.1997 and as such after absorption in state service his service is considered and earlier service as mustering assistant has not been considered by the respondents.

4. That though cause of the in correct consideration of qualifying service of the applicant for the purposes of pension arose after his retirement i.e. 30.4.2011 and the said cause is continuing one and accruing in every month as net result of the considering past service of the applicant will be that he will receive more pension in every month as such cause is recurring and continuing one and as such as per settled potion of law there is no any type of delay in the matter, still as per office objection applicant is filing this application.

5. That, after retirement and earlier also applicant owes so many family responsibilities and as there are large of

persons/ employees like applicant in Nanded district, they have collectively made some efforts for consideration of their past service however respondents have not considered their request as such time is lapsed for approaching before this Hon'ble Tribunal, which is not intentional and deliberate."

4. Admittedly, the present applicant retired in the year 2011. Now, so far as the contention of the applicant that only for the purpose of enhancement in the amount of pension the applicant has approached the Tribunal by filing the present application is concerned, it has to be explained by the applicant why he took 10 years to approach the Tribunal for the aforesaid reason. In the M.A. nothing is explained as to why in the intervening 10 years' period he did not approach this Tribunal. It is also not stated whether before any forum he was agitating his cause or ventilating his grievance. It is evident that the applicant has been totally negligent in asserting his right.

5. It is the contention of the applicant that he entered into Government service as Muster Assistant on 17-10-1979, and thereafter, in view of policy

of the Government he was absorbed in regular service on 31-03-1997. The applicant is now praying for considering the said intervening period as his regular service period and to reckon his service period from 1979 with consequential benefits.

6. It is, thus, evident that the cause of action, in fact, has arisen in the year 1997. The applicant admittedly did not take any step in securing his right at that time. Thereafter, the applicant was in service till the year 2011. In the entire said period he did not claim the aforesaid right and/or benefit. After retirement in the year 2011 till the year 2022 i.e. for the period of 11 years, applicant did not take any step and remained silent in asserting his right. The claim of the applicant has become too stale.

7. The applicant has not assigned any reason for not approaching the Tribunal or not asserting his right for quite a long period. In absence of any cogent and sufficient reason given by the applicant, it is difficult to condone the inordinate delay occasioned in filing the present O.A.

It is well settled that if no sufficient cause is made out, the delay of a smaller period also cannot be condoned. In the instant matter, applicant has failed in explaining the huge delay caused for filing the present O.A. by him. Hence, the following order:

- [i] M.A. for condonation of delay is rejected.
- [ii] Consequently, O.A. also stands rejected.
- (iii) There shall be no order as to costs.
