2. The applicant has sought direction to the respondent no.2 to consider his claim for issuing order of appointment on the post of Health Worker (Male) and he was called for producing his documents but the applicant is not holding certificate regarding seasonal work done by him for 90 days as required in the advertisement. Therefore, he sought direction in that regard.

3. Learned P.O. has submitted that the applicant has to produce the required certificate and only on production of experience certificate, appointment letter can be issued.

4. On perusal of record, it reveals that the applicant has been selected on the post of Health Worker and his name has been mentioned at Sr. No.6. As per advertisement, a candidate must work for 90 days as Seasonal Worker and to produce the certificate in that regard. On the

basis of the merit list, the applicant was called for producing original documents by letter dated 14-06-2018 but the applicant has not produced the required documents, more particularly, experience certificate showing that he worked as Seasonal Worker for 90 days.

5. Since the applicant has been considered on the basis of Seasonal Worker in the recruitment process and he has been selected and called for production of original documents, no question of issuing direction to respondents to appoint him on the post of Health Worker (Male) without production of the required certificate of experience arises.

6. In these circumstances, in my opinion, there is no merit in the O.A. Consequently, it deserves to be dismissed. Accordingly, O.A. stands dismissed in limine. There shall be no order as to costs.
