The applicant prays that the Respondent No. 2 2. be directed to consider the case of the applicant as per D.P.C meeting dated 4.1.2024 and open the seal cover and further the applicant be permitted to submit his option pursuant to Cadre Allotment Rules before taking option from the juniors to the applicant pursuant to the office order dated 10.7.2024. Further the Respondent No. 2 be directed to promote the applicant to the post of Superintendent, District Prison, Group-2/Deputy Superintendent, Central Prison, Group-B. Learned P.O submits that the meeting of the 3 D.P.C was conducted on 3.1.2024 and at that time departmental enquiry was pending against the applicant and so on that day the case of the applicant was kept under sealed cover. 4 Learned counsel for the applicant submitted that the case of the applicant was considered and kept in a sealed cover in view of pendency of the departmental enquiry against him. Learned counsel further submitted that the applicant was acquired on 10.7.2024 and on the same day options were called by the Respondents before issuing the promotion order. Learned counsel further submitted that the case of the persons who are considered in the D.P.C meeting are junior to the applicant. Learned P.O seeks time to file reply and on 5. instruction from Shri Sandeep Dase, Administrative Officer, submits that there are 13 vacant posts and for that meeting of the D.P.C was held on 3.1.2024. 6.
