- Learned Advocate for the Applicant states that the Applicant who is working as Junior Clerk in the office of Settlement Commissioner, Pune since 24.5.2021 has now filed MA No.506 of 2024 seeking to keep 'One Post' of Junior Clerk available in Haveli as per Order dated 15.6.2022 passed by the Hon'ble Minister of State for Revenue Department.
- Ld. Advocate for the Applicant draws our attention to the Order dated 15.6.2022 which was passed in Appeal by the Hon'ble Minister of State for Revenue Department in which he has condoned long absence of Applicant of 2121 days to regularize it as leave due and admissible to Applicant. However, this Order dated 15.6.2022 passed in Appeal is not referred to in Order dated 31.8.2023 issued by Revenue & Forest Department thereby informing Applicant that his leave period of more than 5 years and 10 months is to be treated as 'Extra-ordinary Leave'. However, as Special Case it cannot be considered valid for 'Pensionary Benefits

or other Service Benefits' being contrary to the Order dated 15.6.2022 passed by the Hon'ble Minister of State for Revenue Department.

- 4. We would thus like to know how Hon'ble Minister of State for Revenue Department and under what power has without recommendations of 'CSB' directly transferred Applicant under ROTA to Haveli on which this MA No.506 of 2024 is based wherein it is prayed that the post of Junior Clerk in Haveli is to be kept vacant for the Applicant. The question which arises is whether the post of Junior Clerk in Haveli has been kept vacant since 15.6.2022 and secondly why Order dated 15.6.2023 of Hon'ble Minister of State for Revenue Department was not communicated to the Applicant and Settlement Commissioner, Pune and under what power the Order passed in Appeal on 15.6.2022 by Hon'ble Minister of State for Revenue Department was subsequently cancelled by Order dated 31.8.2023 by Revenue & Forest Department.
- 5. Ld. PO seeks time to file reply on behalf of Respondents.

ORDER

- 1. Applicant prays that Respondents be directed to set aside the impugned order dated 23.09.2024 passed by Respondent No.1 under which he transferred the Applicant from the post of Police Surgeon, Police Hospital, Nagpada, Mumbai to the post of Medical Superintendent, Sub-District Hospital, Pen, District Raigad and by separate impugned order dated 23.09.2024 transferred the Respondent No.2 in place of the Applicant from the post of Medical Officer (Physician), Pt. Bhimsen Joshi Hospital, Mira Bhayandar, District Palghar and accordingly the Applicant be granted all consequential service benefits, as if the impugned order had not been passed.
- 2. Learned Counsel Mr. Bandiwadekar challenges the transfer order and seeks interim stay on the following grounds:
 - (a) Applicant's transfer order is mid-term and mid-tenure thereby violating Sections 4(4)(ii) and 4(5) of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties, Act, 2005 (hereinafter referred as 'ROTA 2005' for brevity).
 - (b) According to the Applicant no CSB meeting has been conducted.
 - (c) According to the Applicant for transfer of Police Surgeon, Class-I, the competent authority is the Hon'ble Ministry, Public Health and immediately approval of the Hon'ble Chief Minister is

- sought. He has submitted that the Department had bypassed competent authority i.e. Hon'ble Minister of Health and has directly taken the approval of Hon'ble Chief Minister therefore there is breach of Section 6(b) of the ROTA 2005.
- (d) The post of Medical Superintendent, Sub-District Hospital, Pen, District Raigad is already occupied and the person who is brought in place of the applicant i.e. Respondent No.2 Dr. Gajanan K. Sanap is not competent for holding the post of Police Surgeon as requisite qualification for the said post is M.D. (Forensic Medicine and Toxicology) as Nagpada Hospital entertains police cases whereas Respondent no.2 is M.D. Medicine.
- 3. Learned P.O. has produced for perusal the minutes of CSB meeting conducted on 23.08.2024. Learned P.O. has submitted that within two days Applicant's posting order will be issued and he will not remain without posting. Learned P.O. seeks time to file affidavit-in-reply.
- Par contra, learned Counsel has raised objection relying on G.R. dated 11.02.2015 that certain directions are required to be followed by the Government while issuing the mid-term and mid-tenure transfer orders.
- 5. Learned P.O. has submitted that the State has followed the procedure.
- 6. I have gone through the file placed before me. The reasons for the transfer are specifically mentioned and special reasons are also mentioned that there are complaints against the applicant of the colleagues about malpractices and about bad administration at the hands of the applicant. It appears that the Hon'ble Minister Health and Hon'ble Chief Minister have signed the said minutes. Hence, it is not the fit case to grant interim stay. Respondents are directed to issue posting order of the Applicant within three days. Meanwhile Applicant is directed to join the posting wherever is given.

- 7. The office objections, if any, are to be removed and court fees to be paid, if not already paid.
- 8. Issue notice before admission returnable on 03.10.2024.
- 9. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is allowed. Respondents are put to notice that the case may be taken up for final disposal at the stage of admission hearing.
- 10. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- 11. By Hand delivery, speed post, courier notice to be served and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.
- 12. In case notice is not collected within seven days or service report on affidavit is not filed three days before returnable date, the Original Application shall be placed on board before the concerned Bench under the caption "for Dismissal" and thereafter on the subsequent date the Original Application shall stand dismissed.
- 13. Adjourned to 03.10.2024.

- 3. Learned Advocate for Applicants then states that all Applicants had filled-up 'Application Forms' for these '33 Posts' of 'Auxiliary Binder'. After completion of due process of recruitment by 'Regional Selection Committee Government Central Press'; names of all Applicants were included in 'Select List' published on 06.09.2024.
- Learned Advocate for **Applicants** then emphasized that all Applicants were then issued 'Appointment Orders' on 06.09.2024 by 'Manager, Government Central Printing Press, Charni Road, Mumbai'. - 1. Mr. R.M. Kolge, learned Counsel for the Applicant, Ms. K.S. Gaikwad, learned Presenting Officer for the Respondents and Mr. M.D. Lonkar, learned Counsel for Respondent No.5, who is also Caveator in Caveat No.34/2024 are present.
- 2. On query learned Counsel Mr. Kolge has submitted that he has served copy of O.A. to learned Counsel Mr. Lonkar.
- 3. Applicant working as Assistant Registrar prays that Respondents be directed to quash and set aside the impugned order of transfer dated 20.04.2024 issued by the Respondent No.1 thereby transferring the Respondent No.3 in place of the Applicant as Assistant Registrar at Bhiwandi and further be please to direct the respondent No.1 to allow the applicant to discharge her duties as Assistant Registrar, Bhiwandi and O.A. be allowed accordingly.
- Learned Counsel Mr. Kolge has submitted that Applicant earlier was working in Junnar and by choice posting she came to be transferred from Junnar to Bhiwandi by order dated 05.08.2021. Learned Counsel has submitted that the Applicant's transfer order is passed without posting the applicant on the vacant post and Respondent No.3 has been transferred in place of applicant, the post which is not being vacant. Respondent No.3, Mr. B.K. Patil is transferred from Sangli to Bhiwadi who is added as Respondent N.3 in the present O.A. Learned Counsel Mr. Kolge has submitted that transfer order of Applicant is passed invoking Sections 4(4)(ii) and 4(5) of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties, Act, 2005 (hereinafter referred as 'ROTA 2005' for brevity). He has placed reliance on the judgment dated 04.08.2023 passed by this Tribunal in O.A.No.691/2023, A.V. Kurhade Vs. The State of Maharashtra & Ors.
- 5. Learned Counsel Mr. Lonkar has submitted that Respondent no.3 has already joined and his joining report is also given on 23.09.2024. He seeks time to file affidavit-in-reply

- Learned P.O. has submitted that copy of O.A. and notice is not served on the Respondents, but however she has received instructions. She has submitted that the CSB meeting was held on 22.02.2024 on request of Respondent No.3. Learned P.O. has submitted that in the CSB meeting the recommendation of transfer of Applicant and Respondent No.3 was rejected. She has submitted that the transfer of applicant was suggested, however no posting was given by the Department. Hon'ble Minister of Corporation has put remark that the proposal of transfer of Respondent no.3 from Sangli to Bhiwandi is to be accepted. Thereafter, Hon'ble Chief Minister has sent a note dated 20.03.2024 of transferring Respondent No.3 to Bhiwandi. Learned P.O. has further submitted that in the CSB meeting held on 24.09.2024 to transfer of applicant is proposed.
- 7. Considered submissions and documents produced by both the parties that applicant is kept without work. Parties are directed to maintain status quo as on today. Respondent to produce relevant record on the next date.
- 8. The office objections, if any, are to be removed and court fees to be paid, if not already paid.
- 9. Issue notice before admission returnable on 30.09.2024.
- 10. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is allowed. Respondents are put to notice that the case may be taken up for final disposal at the stage of admission hearing.
- 11. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- 12. By Hand delivery, speed post, courier notice to be served and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.
- 13. In case notice is not collected within seven days or service report on affidavit is not filed three days before returnable date, the Original Application shall be placed on board before the concerned Bench under the caption "for Dismissal" and thereafter on the subsequent date the Original Application shall stand dismissed.
- 14. Adjourned to 30.09.2024.

Heard Shri D.B. Khaire, learned Advocate for the Applicant and Smt. K.S. Gaikwad, learned Presenting Officer for the Respondents.

- The applicant is aggrieved by the judgment and order dated 20.3.2023 passed by this Tribunal in the above OA No.187 of 2021. The applicant has sought promotion / appointment to the post of Civil Engineering Assistant. Ld. Advocate for the applicant submits that letter dated 2.8.2022 issued by the Section Officer, Water Resources Department, Mantralaya to Superintending Engineer and Circle Officer, Vigilance Squad, Aurangabad etc. was not in the custody of the applicant to produce and therefore it was not considered at the time of deciding the matter. Now the applicant has procured this letter which is very important in respect of inclusion of the class of Clerk as a No.13 category in the GR dated 31.1.1989. He submits that the post of Clerk is added by GR dated 28.10.1994 in the Appendix-A of GR dated 31.1.1989 and the said letter was subsequently procured by the applicant and therefore it could not be referred at the time of arguments in the OA and also in the order of OA Ld. Advocate for the applicant argued on the applicability of the said letter and the bearing of the said letter on the issue of promotion of the applicant whose OA was denied mainly on the ground that he was holding the post of Chowkidar on 30.1.1989 and the said post was not mentioned in the Appendix-A of the GR dated 31.1.1989
- 3. Ld. PO while opposing this RA has submitted that the scope of review is very limited and the applicant is going beyond the scope of it. She submits that the applicant could have challenged the impugned order in OA passed by this Tribunal dismissing the same by filing writ petition. However, it is not done so. She further rightly pointed out

that letter of 2.8.2022 which is said as a main ground to file Review Application basically there is no whisper about the said document in the RA. She pointed out that the applicant filed RA on 11.4.2023 and filed additional affidavit in support of RA on 26.9.2023. She submitted that said letter has nothing to do with the post of Chowkidar or Mistry which the applicant was holding and the letter has no connection with the issue of inclusion of the applicant in the category mentioned in Appendix-A of GR dated 31.1.1989.

4. We have gone through the letter dated 2.8.2022. Reference of the said letter is not made in the entire RA. However, it is referred in the additional affidavit filed by the applicant. After perusal of the contents of the said letter, we are of the view that this document has no bearing over the issue involved in the said OA and it is irrelevant document. Moreover, as per criteria under Order XLVII (47) of the CPC, case of the applicant does not fall within the parameters and it is rejected. Hence, Review Application is rejected. No order as to costs.
