Thereafter the applicant was given posting vide order dated 17.10.2023 as Laboratory Attendant in Government Arts & Science College, Aurangabad and within few days thereafter i.e. on 20.10.2023 another order has been passed, thereby cancelling his inter-divisional transfer and directing him to join at his previous post at Kolhapur. The impugned

order shows that earlier orders have been cancelled on the ground that such provision is not applicable for the employees working in Class-IV category and is applicable only for the employees working in Class-III category. Learned counsel for the applicant pointed out that in the past several Class-IV employees have been given such benefit and such orders are placed on record. Learned counsel submitted that the applicant is likely to be relieved in pursuance of the impugned order and if it so happen, irreparable loss will be caused to the applicant, since he has completely shifted his family from Kolhaput to Aurangabad and has also taken admission in the School at Aurangabad for his children.

3. Learned Presenting Officer has sought time for taking instructions from the respondents and to file the affidavit in reply. Learned P.O. submitted that the concerned G.R. pertains to Class-III employees only and the order in regard to inter-divisional transfer of the applicant from Kolhapur Region to Aurangabad Region has been cancelled with retrospective effect and in the circumstances no
