No. 377/2020 with connected OAs decided along with said O.A. though had placed their reliance on the order passed by Nagpur Bench of the Maharashtra Administrative Tribunal in O.A. No. 545/2015 did not bring to the notice of this Tribunal that the order passed by the Tribunal in the said O.A. No. 545/2015 has been stayed by Nagpur Bench of Hon'ble Bombay High Court in W.P. No. 7683/2018. Learned counsel placed on record order dated 13.11.2018 passed in W.P. No. 7683/2018 and also referred to order dated 04.03.2021 passed in the said W.P. No. 7683/2018, which

is already filed on record in this O.A. Learned counsel further pointed out that in the matter claiming identical reliefs bearing O.A. No. 115/2019 this Tribunal has passed an order on 25.03.2019 adjourning the said matter sine die in view of pendency of W.P. No. Learned counsel submitted that the 7683/2018. applicants were quite aware of the aforesaid fact however, without disclosing the said fact the orders are obtained by them in O.A. No. 377/2020 and the connected OAs. In the circumstances, learned counsel prayed for staying the effect and operation of the common order passed by this Tribunal in the aforesaid OAs on 02.05.2024. Learned counsel pointed out that the DPC meeting is in usual course is held in the month of September or October. Learned counsel submitted that the DPC meeting if is held in coming few days, because of the order passed by this Tribunal in O.A. No. 377/2020, the applicants may lose the chance of promotion. In the circumstances, learned counsel insisted for staying the effect and operation of the order dated 02.05.2024 passed by this Tribunal in the aforesaid O.As.

3. Learned counsel for the private respondents namely Shri Bhamre sought to contend that unless the respondents are given opportunity to file their affidavits in reply, all the relevant factors may not be there before the

Tribunal and hence opposed for granting any stay as sought by the applicants. Learned Presenting Officer, however, supported the prayer made by the applicants stating that the Government has also filed Review Applications seeking review of the order passed by this Tribunal on 02.05.2024 in O.A. No. 377/2020 and other connected O.As.

4. We have duly considered the submissions made on behalf of respective parties. We have perused the order passed in O.A. No. 545/2015 by Nagpur Bench of this Tribunal, as well as, the orders passed in W.P. No. 7683/2018 on 13.11.2018 and 04.05.2021 respectively. After having gone through the orders passed as aforesaid there appears substance in the contentions raised on behalf of the applicants. It is not in dispute that in O.A. No. 377/2020 and other identical matters, which have been decided by common order passed on 02.05.2024, the applicants therein had relied on the order passed by Nagpur Bench of this Tribunal in O.A. No. 545/2015. The applicants in the said O.A., however, does not appear to have brought to the notice of this Tribunal the stay order passed by Nagpur Bench of Hon'ble Bombay High Court in W.P. No. 7683/2018 wherein the order passed by Nagpur Bench of this Tribunal in O.A. No. 545/2015 is challenged. The order passed by this Tribunal in O.A. No. 115/2019 was also not brought to the notice of this

Tribunal. It cannot be denied that while passing the common order by this Tribunal in O.A. No. 377/2020 with other connected O.As. and allowing the said applications the order passed by coordinate Bench of this Tribunal in O.A. No. 545/2018 was the main consideration.

- 5. There appears substance in the contention raised on behalf of the applicants that while placing reliance on the order passed in O.A. No. 545/2015 the applicants did not bring it to the notice of this Tribunal that the order passed in O.A. No. 545/2015 is under challenge before Nagpur Bench of Hon'ble Bombay High Court and further that the Hon'ble High Court has vide the order passed on 13.11.2018 has stayed the effect and operation of the order passed in the said O.A.
- 6. In the circumstances while giving opportunity to the learned counsel appearing for private respondents to file affidavits in reply, we deem it appropriate to stay the effect and operation of the common order passed by this Tribunal in O.A. No. 377/2020 with connected O.As. decided on 02.05.2024. Hence, the following order:-

Shri Palshikar, learned counsel appearing for the applicants in M.A. pointed out that in the O.A. the applicants have not added any person likely to be aggrieved if any order is passed in favour of applicant despite being aware of the names of the persons, who may be affected. Learned counsel submitted that for this single reason of non-joining of necessary parties the O.A. itself is liable to be dismissed.

- 4. Learned counsel further submitted that the relief sought by the applicant in para 10-A of the O.A. is already granted in favour of the applicant in O.A. No. 1002/2021 by the Nagpur Bench of this Tribunal on 04.01.2024 and, as such, no such prayer could have been again made by the applicant in the O.A.
- 5. Learned counsel further submitted that the applicant has sought the directions to correct/revise the promotional list dated 02.07.2024 containing the names of 50 persons in the zone of consideration for their promotion to the post of Executive Engineer (Civil), however, none of the said 50 persons has been made respondent in the O.A. Learned counsel submitted that on the aforesaid ground also the O.A. as it is cannot be entertained.
- 6. Learned counsel further submitted that apart from the discrepancies as above the applicant has obtained blanket interim relief, because of which all 50 eligible officers are unnecessarily and without any fault on their part are deprived from being promoted to the next higher post. Learned counsel in the

circumstances prayed for vacating the interim relief granted on 06.09.2024.

- 7. Learned counsel for the applicant in O.A. opposed the submissions made on behalf of the applicants. It is contended that the Tribunal has passed the interim order after having considered the pleadings and more particularly has considered the fact that the seniority of the applicant is likely to be totally ignored.
- 8. Shri Deshpande, learned special counsel appearing for the State authorities on instructions made a statement that within 08 weeks from today the order as has been passed by Nagpur Bench of this Tribunal in favour of the applicant in O.A. No. 1002/2021 will be complied with, meaning thereby that the applicant will be placed in the seniority list immediately after candidate at sr. no. 655. Learned special counsel, therefore, prayed to suitably modify the interim order passed in O.A. on 06.09.2024.
- 9. We have duly considered the submissions made by the learned counsel appearing for the respective parties. In view of the statement made by the learned

special counsel appearing for the State authorities, we may not indulge in considering the objections as are raised by the learned counsel for the applicants and counter given to the said objections by the learned counsel appearing for the applicants in O.A. We are, however, inclined to modify the interim order passed on 06.09.2024 in O.A., which would sufficiently protect the interest of the applicant and would also pave the way for promotion of the other eligible candidates. Hence, the following order:-

ORDER

The interim order passed in O.A. No. 1042/2024 on 06.09.2024 is modified as under:-

- (i) The respondents are directed to keep 01 post vacant in the cadre of Executive Engineers (Civil) till decision of the Original Application.
- (ii) It is clarified that in the process of granting promotions in the meanwhile period, if it is noticed that the promotion is granted to the officer junior to the applicant as per the placement of the applicant in view of the order

passed by the Tribunal, before the applicant is considered for the said promotion, in the event of his promotion the applicant shall be deemed to have been promoted on the date the said junior officer is promoted.

- 2. There is a delay of 06 months and 26 days caused in filing the accompanying Original Application.
- 3. Learned counsel for the applicant submits that the applicant had submitted an application for compassionate appointment on 23.03.2021 and by communication dated 28.01.2022, the respondent No. 2 has refused to give appointment to the applicant. Being aggrieved by the same, the applicant had approached to the Hon'ble High Court of Bombay, Bench at Aurangabad by filing W.P. No. 2019/2023 and by order dated 25.07.2023, the Hon'ble High Court has disposed of the said W.P. by granting liberty to the applicant to approach this Tribunal.

- 4. Learned counsel for the applicant submits that the applicant has supposed to file Original Application within one year from the date of communication dated 28.01.2022 i.e. on or before 27.01.2023. However, the Hon'ble High Court of Bombay, Bench at Aurangabad has decided W.P. No. 2019/2023 on 25.07.2023. Learned counsel thus submits that the delay, if any may be condoned.
- 5. Learned Presenting Officer has strongly resisted the application on the ground that there is an inordinate delay caused in filing the accompanying Original Application, for which no satisfactory explanation has been tendered by the applicant. Learned P.O. submits that there is no substance in the Misc. Application seeking condonation of delay and the same is liable to be dismissed.
- 6. In terms of the ratio laid down in a case of M.P. Steel Corporation Vs. Commissioner of Central Excise reported in (2015) 7 Supreme Court Cases 58, the Hon'ble Supreme Court has taken a view that bonafidely, if wrong forum is chosen though Section 14 of the Limitation Act, 1963 cannot be made applicable to the proceedings before the Tribunal,

however, principally, those provisions can be made applicable and thus, the delay can be condoned.

7. In view of above, it is apparent on the face of record that the applicant has initially approached the Hon'ble High Court of Bombay, Bench at Aurangabad and after liberty is granted to the applicant, the applicant has filed the O.A., which has been delayed. There is no inaction on the part of the applicant. There is no intentional or deliberate delay as such. Considering the entire aspect of the case, I am inclined to condone the delay caused in filing the accompanying Original Application, subject to payment of some costs by the applicant. Hence, the following order:-

ORDER

- (i) The Misc. Application No. 393/2023 is hereby allowed.
- (ii) The delay of 06 months and 26 days caused in filing the accompanying O.A. under Section 19 of the Administrative Tribunals Act, 1985 is hereby condoned, subject to payment of costs of Rs. 500/- (Five Hundred Only) to be paid by the

applicant. The amount of costs shall be paid to the M.A.T. Bar Association within a period of one month from the date of this order.
