- 2. This Original Application is filed challenging the impugned order of transfer of the applicant dated 20.04.2022 (wrongly mentioned as 21.04.2022) (Annex. 'A-1') issued by the respondent No.1 thereby transferring the applicant temporarily till further order from Kopargaon City Police Station to Shrirampur City Police Station. The applicant is working as Police Naik at Kopargaon City Police Station.
- 3. Learned Advocate for the applicant today produced on record short affidavit of the applicant explaining alleged mode of communication of impugned transfer order dated 20.04.2022 and relieving order dated 21.04.2022.
- 4. Learned Advocate for the applicant submitted that the impugned transfer order of the applicant dated 20.04.2022 (Annex. 'A-1') shows that the space of letter number and date are blank. Date on the said

letter is mentioned below the signature of the respondent No.1 as 20.04.2022. As per the contentions raised in the Original Application and short affidavit, the applicant said to have received the order of transfer and relieving on whatsapp group. But it was not duly served upon the applicant by the respondent No.2 i.e. the Police Inspector, Kopargaon City Police Station.

- 5. Similar is the case of the alleged communication of relieving order on whatsapp group. Copy of the relieving order dated 21.04.2022 is produced by the applicant at page no.43 of Paper Book. In view of same, learned Advocate for the applicant submits that this letter also does not mention the outward number.
- 6. Learned Advocate for the applicant also invited my attention to general diary details which is at page no.44 of Paper Book, wherein it is stated that the applicant was asked to take relieving memo, but he did not accept it and therefore, he was relieved by sending relieving memo on whatsapp group.
- 7. In view of above, learned Advocate for the applicant submitted that the impugned transfer order does not show that it was issued by putting the case

before the requisite Police Establishment Board as incorporated under Section 22(N) of Maharashtra Police Act. Moreover, transfer order as well as the relieving order do not show outward numbers. Therefore, according to him the whole procedure adopted by the respondents is illegal and the applicant cannot be said to have been relieved from his present post. Hence, he seeks interim stay to the said impugned transfer order till filing of reply of the respondents.

- 8. Learned P.O. for the respondents while opposing the contentions raised by the applicant submitted that the impugned transfer order and relieving order are communicated to the applicant appropriately by sending to the applicant on whatsapp group. The applicant did not come to collect relieving memo and as such station diary entry was made on 21.04.2022. In view of same, the impugned transfer order and relieving order both are legal and no case is made out for grant of interim stay.
- 9. After having considered the affidavit of the applicant together with the documents produced by him and rival submissions made on behalf of the applicant, it is apparent that in the impugned transfer

order date of 20.04.2022 is hand written. It is glaring that impugned order issued by the respondent No.1 (Annex. 'A-1') does not mention outward number. Similarly relieving order dated 21.04.2022 page No.43 of Paper Book also does not bear outward number. That apart though order mentions transfer of the applicant on temporary basis, there is no mention of compliance of requisite provision of Section 22(N) of Maharashtra Police Act or any circumstances or record showing that sanction of PEB was not necessary.

- 10. In these circumstances, prima-facie it is evident that the impugned order of transfer and relieving order of the applicant, both are the documents which cannot be said to have been duly served upon the applicant and are defective. Moreover, there is no whisper in the order of transfer about the concurrence of the PEB or any exceptional circumstances or public interest or any administrative exigency.
- 11. In view of same, in my considered opinion, this is a fit case to grant interim stay to the execution and implementation of impugned order of transfer dated 20.04.2022. (Annex. 'A-1') till filing of reply of the applicant. It is ordered accordingly.
